AN ACT relating to mental health; revising the scope of the practice of clinical professional counseling; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

This bill revises the scope of the practice of clinical professional counseling to provide that ~~the assessment or treatment of couples or families is not excluded from~~ the practice of clinical professional counseling ~~if~~ includes the assessment or treatment of couples or families if the assessment or treatment is provided by a person who has demonstrated competency in the assessment or treatment of couples or families as determined by the Board of Examiners for Marriage and Family Therapists and Clinical Professional Counselors.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 641A.065 is hereby amended to read as follows:

2 641A.065 ***1.*** “Practice of clinical professional counseling” means the provision of treatment, assessment and counseling, or equivalent activities, to a person or group of persons to achieve mental, emotional, physical and social development and adjustment.

3 ***2.*** The term includes ~~counseling~~:

4 ***(a) Counseling*** interventions to prevent, diagnose and treat mental, emotional or behavioral disorders and associated distresses which interfere with mental health
