SUMMARY—Revises provisions governing safe and respectful learning environments in public schools. (BDR 34-454)

AN ACT relating to education; revising provisions relating to the reporting of incidents of bullying, cyber-bullying, harassment and intimidation by the State Board of Education and the board of trustees of each school district in their respective annual reports of accountability; requiring each public school to disseminate information annually on bullying; revising the definition of “bullying”; revising provisions governing training in the prevention, identification and reporting of bullying and similar conduct; requiring training for administrators in preventing and responding to violence and suicide associated with bullying; requiring notice to the parent or guardian of any pupil allegedly involved in a reported incident of bullying or similar conduct; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

Existing law provides for a safe and respectful learning environment in public schools and prohibits bullying, cyber-bullying, harassment or intimidation. (NRS 388.121-388.139) Existing law also requires the board of trustees of each school district to review and compile reports for submission to the Department of Education relating to the number of reported violations of provisions relating to bullying, cyber-bullying, harassment and intimidation occurring at the public schools within the school district and any actions taken by the public schools to reduce the number of those violations. (NRS 388.1353) In addition, existing law requires the Superintendent of Public Instruction to compile each report submitted by each school district and submit the written compilation to the Attorney General. (NRS 388.1355) **Section 11.5** of this bill eliminates these reporting requirements, and **sections 1 and 2** of this bill require the contents of those reports to be included within the annual reports of

accountability prepared by the State Board of Education and the board of trustees of each school district. (NRS 385.3469, 385.347)

Section 3 of this bill requires each public school to disseminate information on bullying and the facilitation of positive relations among pupils during the annual "Week of Respect" proclaimed by the Governor.

Section 4.5 of this bill revises the definition of bullying to include: (1) only repeated acts or conduct; and (2) acts or conduct that exploit an imbalance in power.

Sections 5-7 of this bill revise various provisions governing the training of all administrators, principals, teachers and other school employees on the subject of bullying, cyber-bullying, harassment and intimidation. Existing law requires the Department of Education to prescribe a policy for such training. (NRS 388.133) **Section 5** requires the policy to encompass members of the boards of trustees of school districts and provide for training in methods to prevent, identify and report incidents of bullying and similar conduct. Existing law also requires the board of trustees of each school district to adopt the training policy prescribed by the Department and provide the appropriate training to employees of the district. (NRS 388.134) **Section 6** requires the members of the board of trustees to receive this training and requires that newly elected trustees and new employees of the school district receive the training within 180 days after the beginning of their term of office or their employment, as applicable. Existing law requires the Department to recommend certain programs of training in this area for members of the boards of trustees of school districts and school employees. (NRS 388.1342) **Section 7** requires the Department to establish these programs and a program to train administrators in the prevention of and response to violence and suicide associated with bullying and similar conduct. **Section 7** also requires each administrator to complete this training: (1) within 90 days after becoming an administrator; (2) at least once during any school year in which the training is revised or updated; and (3) at least once every 3 years otherwise.

Section 8 of this bill provides that a principal, or his or her designee, who receives a report of bullying, cyber-bullying, harassment or intimidation must give notice of the report to the parent or legal guardian of each pupil involved in the incident that is the subject of the report.

Existing law provides immunity from liability for a pupil, school employee or volunteer who reports an incident of bullying, cyber-bullying, harassment or intimidation unless he or she acts with malice, intentional misconduct, gross negligence, or intentional or knowing violation of the law. (NRS 388.137) Where such a malicious, intentional or grossly negligent report is made, **section 11** of this bill authorizes disciplinary action against the pupil or other person making the report.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. NRS 385.3469 is hereby amended to read as follows:

385.3469 1. The State Board shall prepare an annual report of accountability that includes, without limitation:

(a) Information on the achievement of all pupils based upon the results of the examinations administered pursuant to NRS 389.015 and 389.550, reported for each school district, including, without limitation, each charter school in the district, and for this State as a whole.

(b) Except as otherwise provided in subsection 2, pupil achievement, reported separately by gender and reported separately for the following groups of pupils:

(1) Pupils who are economically disadvantaged, as defined by the State Board;

(2) Pupils from major racial and ethnic groups, as defined by the State Board;

(3) Pupils with disabilities;

(4) Pupils who are limited English proficient; and

1 (5) Pupils who are migratory children, as defined by the State Board.

2 (c) A comparison of the achievement of pupils in each group identified in
3 paragraph (b) of subsection 1 of NRS 385.361 with the annual measurable
4 objectives of the State Board.

5 (d) The percentage of all pupils who were not tested, reported for each school
6 district, including, without limitation, each charter school in the district, and for this
7 State as a whole.

8 (e) Except as otherwise provided in subsection 2, the percentage of pupils who
9 were not tested, reported separately by gender and reported separately for the
10 groups identified in paragraph (b).

11 (f) The most recent 3-year trend in the achievement of pupils in each subject
12 area tested and each grade level tested pursuant to NRS 389.015 and 389.550,
13 reported for each school district, including, without limitation, each charter school
14 in the district, and for this State as a whole, which may include information
15 regarding the trend in the achievement of pupils for more than 3 years, if such
16 information is available.

17 (g) Information on whether each school district has made adequate yearly
18 progress, including, without limitation, the name of each school district, if any,
19 designated as demonstrating need for improvement pursuant to NRS 385.377 and
20 the number of consecutive years that the school district has carried that designation.

21 (h) Information on whether each public school, including, without limitation,
22 each charter school, has made:

23 (1) Adequate yearly progress, including, without limitation, the name of
24 each public school, if any, designated as demonstrating need for improvement
25 pursuant to NRS 385.3623 and the number of consecutive years that the school has
26 carried that designation.

27 (2) Progress based upon the model adopted by the Department pursuant to
28 NRS 385.3595, if applicable for the grade level of pupils enrolled at the school.

29 (i) Information on the results of pupils who participated in the examinations of
30 the National Assessment of Educational Progress required pursuant to NRS
31 389.012.

32 (j) The ratio of pupils to teachers in kindergarten and at each grade level for all
33 elementary schools, reported for each school district, including, without limitation,
34 each charter school in the district, and for this State as a whole, and the average
35 class size for each core academic subject, as set forth in NRS 389.018, for each
36 secondary school, reported for each school district and for this State as a whole.

37 (k) The total number of persons employed by each school district in this State,
38 including without limitation, each charter school in the district. Each such person
39 must be reported as either an administrator, a teacher or other staff and must not be
40 reported in more than one category. In addition to the total number of persons
41 employed by each school district in each category, the report must include the
42 number of employees in each of the three categories expressed as a percentage of
43 the total number of persons employed by the school district. As used in this
44 paragraph:

45 (1) "Administrator" means a person who spends at least 50 percent of his
46 or her work year supervising other staff or licensed personnel, or both, and who is
47 not classified by the board of trustees of a school district as a professional-technical
48 employee.

49 (2) "Other staff" means all persons who are not reported as administrators
50 or teachers, including, without limitation:

51 (I) School counselors, school nurses and other employees who spend at
52 least 50 percent of their work year providing emotional support, noninstructional
53 guidance or medical support to pupils;

1 (II) Noninstructional support staff, including, without limitation,
2 janitors, school police officers and maintenance staff; and

3 (III) Persons classified by the board of trustees of a school district as
4 professional-technical employees, including, without limitation, technical
5 employees and employees on the professional-technical pay scale.

6 (3) "Teacher" means a person licensed pursuant to chapter 391 of NRS
7 who is classified by the board of trustees of a school district:

8 (I) As a teacher and who spends at least 50 percent of his or her work
9 year providing instruction or discipline to pupils; or

10 (II) As instructional support staff, who does not hold a supervisory
11 position and who spends not more than 50 percent of his or her work year providing
12 instruction to pupils. Such instructional support staff includes, without limitation,
13 librarians and persons who provide instructional support.

14 (I) For each school district, including, without limitation, each charter school in
15 the district, and for this State as a whole, information on the professional
16 qualifications of teachers employed by the school districts and charter schools,
17 including, without limitation:

18 (1) The percentage of teachers who are:

19 (I) Providing instruction pursuant to NRS 391.125;

20 (II) Providing instruction pursuant to a waiver of the requirements for
21 licensure for the grade level or subject area in which the teachers are employed; or

22 (III) Otherwise providing instruction without an endorsement for the
23 subject area in which the teachers are employed;

24 (2) The percentage of classes in the core academic subjects, as set forth in
25 NRS 389.018, in this State that are not taught by highly qualified teachers;

26 (3) The percentage of classes in the core academic subjects, as set forth in
27 NRS 389.018, in this State that are not taught by highly qualified teachers, in the
28 aggregate and disaggregated by high-poverty compared to low-poverty schools,
29 which for the purposes of this subparagraph means schools in the top quartile of
30 poverty and the bottom quartile of poverty in this State;

31 (4) For each middle school, junior high school and high school:

32 (I) The number of persons employed as substitute teachers for 20
33 consecutive days or more in the same classroom or assignment, designated as long-
34 term substitute teachers, including the total number of days long-term substitute
35 teachers were employed at each school, identified by grade level and subject area;
36 and

37 (II) The number of persons employed as substitute teachers for less
38 than 20 consecutive days, designated as short-term substitute teachers, including the
39 total number of days short-term substitute teachers were employed at each school,
40 identified by grade level and subject area; and

41 (5) For each elementary school:

42 (I) The number of persons employed as substitute teachers for 20
43 consecutive days or more in the same classroom or assignment, designated as long-
44 term substitute teachers, including the total number of days long-term substitute
45 teachers were employed at each school, identified by grade level; and

46 (II) The number of persons employed as substitute teachers for less
47 than 20 consecutive days, designated as short-term substitute teachers, including the
48 total number of days short-term substitute teachers were employed at each school,
49 identified by grade level.

50 (m) The total expenditure per pupil for each school district in this State,
51 including, without limitation, each charter school in the district. If this State has a
52 financial analysis program that is designed to track educational expenditures and
53 revenues to individual schools, the State Board shall use that statewide program in

1 complying with this paragraph. If a statewide program is not available, the State
2 Board shall use the Department's own financial analysis program in complying
3 with this paragraph.

4 (n) The total statewide expenditure per pupil. If this State has a financial
5 analysis program that is designed to track educational expenditures and revenues to
6 individual schools, the State Board shall use that statewide program in complying
7 with this paragraph. If a statewide program is not available, the State Board shall
8 use the Department's own financial analysis program in complying with this
9 paragraph.

10 (o) For all elementary schools, junior high schools and middle schools, the rate
11 of attendance, reported for each school district, including, without limitation, each
12 charter school in the district, and for this State as a whole.

13 (p) The annual rate of pupils who drop out of school in grade 8 and a separate
14 reporting of the annual rate of pupils who drop out of school in grades 9 to 12,
15 inclusive, reported for each school district, including, without limitation, each
16 charter school in the district, and for this State as a whole. The reporting for pupils
17 in grades 9 to 12, inclusive, excludes pupils who:

18 (1) Provide proof to the school district of successful completion of the
19 examinations of general educational development.

20 (2) Are enrolled in courses that are approved by the Department as meeting
21 the requirements for an adult standard diploma.

22 (3) Withdraw from school to attend another school.

23 (q) The attendance of teachers who provide instruction, reported for each
24 school district, including, without limitation, each charter school in the district, and
25 for this State as a whole.

26 (r) Incidents involving weapons or violence, reported for each school district,
27 including, without limitation, each charter school in the district, and for this State as
28 a whole.

29 (s) Incidents involving the use or possession of alcoholic beverages or
30 controlled substances, reported for each school district, including, without
31 limitation, each charter school in the district, and for this State as a whole.

32 (t) The suspension and expulsion of pupils required or authorized pursuant to
33 NRS 392.466 and 392.467, reported for each school district, including, without
34 limitation, each charter school in the district, and for this State as a whole.

35 (u) The number of pupils who are deemed habitual disciplinary problems
36 pursuant to NRS 392.4655, reported for each school district, including, without
37 limitation, each charter school in the district, and for this State as a whole.

38 (v) The number of pupils in each grade who are retained in the same grade
39 pursuant to NRS 392.033 or 392.125, reported for each school district, including,
40 without limitation, each charter school in the district, and for this State as a whole.

41 (w) The transiency rate of pupils, reported for each school district, including,
42 without limitation, each charter school in the district, and for this State as a whole.
43 For the purposes of this paragraph, a pupil is not a transient if the pupil is
44 transferred to a different school within the school district as a result of a change in
45 the zone of attendance by the board of trustees of the school district pursuant to
46 NRS 388.040.

47 (x) Each source of funding for this State to be used for the system of public
48 education.

49 (y) A compilation of the programs of remedial study purchased in whole or in
50 part with money received from this State that are used in each school district,
51 including, without limitation, each charter school in the district. The compilation
52 must include:

(1) The amount and sources of money received for programs of remedial study.

(2) An identification of each program of remedial study, listed by subject area.

(z) The percentage of pupils who graduated from a high school or charter school in the immediately preceding year and enrolled in remedial courses in reading, writing or mathematics at a university, state college or community college within the Nevada System of Higher Education, reported for each school district, including, without limitation, each charter school in the district, and for this State as a whole.

(aa) The technological facilities and equipment available for educational purposes, reported for each school district, including, without limitation, each charter school in the district, and for this State as a whole.

(bb) For each school district, including, without limitation, each charter school in the district, and for this State as a whole, the number and percentage of pupils who received:

(1) A standard high school diploma, reported separately for pupils who received the diploma pursuant to:

(I) Paragraph (a) of subsection 1 of NRS 389.805; and

(II) Paragraph (b) of subsection 1 of NRS 389.805.

(2) An adult diploma.

(3) An adjusted diploma.

(4) A certificate of attendance.

(cc) For each school district, including, without limitation, each charter school in the district, and for this State as a whole, the number and percentage of pupils who failed to pass the high school proficiency examination.

(dd) The number of habitual truants who are reported to a school police officer or local law enforcement agency pursuant to paragraph (a) of subsection 2 of NRS 392.144 and the number of habitual truants who are referred to an advisory board to review school attendance pursuant to paragraph (b) of subsection 2 of NRS 392.144, reported for each school district, including, without limitation, each charter school in the district, and for this State as a whole.

(ee) Information on the paraprofessionals employed at public schools in this State, including, without limitation, the charter schools in this State. The information must include:

(1) The number of paraprofessionals employed, reported for each school district, including, without limitation, each charter school in the district, and for this State as a whole; and

(2) For each school district, including, without limitation, each charter school in the district, and for this State as a whole, the number and percentage of all paraprofessionals who do not satisfy the qualifications set forth in 20 U.S.C. § 6319(c). The reporting requirements of this subparagraph apply to paraprofessionals who are employed in programs supported with Title I money and to paraprofessionals who are not employed in programs supported with Title I money.

(ff) An identification of appropriations made by the Legislature to improve the academic achievement of pupils and programs approved by the Legislature to improve the academic achievement of pupils.

(gg) A compilation of the special programs available for pupils at individual schools, listed by school and by school district, including, without limitation, each charter school in the district.

(hh) For each school district, including, without limitation, each charter school in the district and for this State as a whole, information on pupils enrolled in career and technical education, including, without limitation:

(1) The number of pupils enrolled in a course of career and technical education;

(2) The number of pupils who completed a course of career and technical education;

(3) The average daily attendance of pupils who are enrolled in a program of career and technical education;

(4) The annual rate of pupils who dropped out of school and were enrolled in a program of career and technical education before dropping out;

(5) The number and percentage of pupils who completed a program of career and technical education and who received a standard high school diploma, an adjusted diploma or a certificate of attendance; and

(6) The number and percentage of pupils who completed a program of career and technical education and who did not receive a high school diploma because the pupils failed to pass the high school proficiency examination.

(ii) *For each school district, including, without limitation, each charter school in the district, and for this State as a whole:*

(1) The number of reported violations of NRS 388.135 occurring at a school or otherwise involving a pupil enrolled at a school, regardless of the outcome of the investigation conducted pursuant to NRS 388.1351;

(2) The number of incidents determined to be bullying, cyber-bullying, harassment or intimidation after an investigation is conducted pursuant to NRS 388.1351;

(3) The number of incidents resulting in suspension or expulsion for bullying, cyber-bullying, harassment or intimidation ~~reported for each school district, including, without limitation, each charter school in the district, and for the State as a whole;~~ and

~~(3)~~ (4) Any actions taken to reduce the number of incidents of bullying, cyber-bullying, harassment and intimidation, including, without limitation, training that was offered or other policies, practices and programs that were implemented.

2. A separate reporting for a group of pupils must not be made pursuant to this section if the number of pupils in that group is insufficient to yield statistically reliable information or the results would reveal personally identifiable information about an individual pupil. The State Board shall prescribe a mechanism for determining the minimum number of pupils that must be in a group for that group to yield statistically reliable information.

3. The annual report of accountability must:

(a) Comply with 20 U.S.C. § 6311(h)(1) and the regulations adopted pursuant thereto;

(b) Be prepared in a concise manner; and

(c) Be presented in an understandable and uniform format and, to the extent practicable, provided in a language that parents can understand.

4. On or before October 15 of each year, the State Board shall:

(a) Provide for public dissemination of the annual report of accountability by posting a copy of the report on the Internet website maintained by the Department; and

(b) Provide written notice that the report is available on the Internet website maintained by the Department. The written notice must be provided to the:

(1) Governor;

(2) Committee;

(3) Bureau;

(4) Board of Regents of the University of Nevada;

(5) Board of trustees of each school district; ~~and~~

(6) Governing body of each charter school ~~;~~ and

(7) The Attorney General, with a specific reference to the information that is reported pursuant to paragraph (ii) of subsection 1.

5. Upon the request of the Governor, the Attorney General, an entity described in paragraph (b) of subsection 4 or a member of the general public, the State Board shall provide a portion or portions of the annual report of accountability.

6. As used in this section:

(a) "Bullying" has the meaning ascribed to it in NRS 388.122.

(b) "Cyber-bullying" has the meaning ascribed to it in NRS 388.123.

(c) "Harassment" has the meaning ascribed to it in NRS 388.125.

(d) "Highly qualified" has the meaning ascribed to it in 20 U.S.C. § 7801(23).

(e) "Intimidation" has the meaning ascribed to it in NRS 388.129.

(f) "Paraprofessional" has the meaning ascribed to it in NRS 391.008.

Sec. 2. NRS 385.347 is hereby amended to read as follows:

385.347 1. The board of trustees of each school district in this State, in cooperation with associations recognized by the State Board as representing licensed educational personnel in the district, shall adopt a program providing for the accountability of the school district to the residents of the district and to the State Board for the quality of the schools and the educational achievement of the pupils in the district, including, without limitation, pupils enrolled in charter schools sponsored by the school district. The board of trustees of each school district shall report the information required by subsection 2 for each charter school sponsored by the school district. The information for charter schools must be reported separately.

2. The board of trustees of each school district shall, on or before September 30 of each year, prepare an annual report of accountability concerning:

(a) The educational goals and objectives of the school district.

(b) Pupil achievement for each school in the district and the district as a whole, including, without limitation, each charter school sponsored by the district. The board of trustees of the district shall base its report on the results of the examinations administered pursuant to NRS 389.015 and 389.550 and shall compare the results of those examinations for the current school year with those of previous school years. The report must include, for each school in the district, including, without limitation, each charter school sponsored by the district, and each grade in which the examinations were administered:

(1) The number of pupils who took the examinations.

(2) A record of attendance for the period in which the examinations were administered, including an explanation of any difference in the number of pupils who took the examinations and the number of pupils who are enrolled in the school.

(3) Except as otherwise provided in this paragraph, pupil achievement, reported separately by gender and reported separately for the following groups of pupils:

(I) Pupils who are economically disadvantaged, as defined by the State Board;

(II) Pupils from major racial and ethnic groups, as defined by the State Board;

(III) Pupils with disabilities;

(IV) Pupils who are limited English proficient; and

(V) Pupils who are migratory children, as defined by the State Board.

1 (4) A comparison of the achievement of pupils in each group identified in
2 paragraph (b) of subsection 1 of NRS 385.361 with the annual measurable
3 objectives of the State Board.

4 (5) The percentage of pupils who were not tested.

5 (6) Except as otherwise provided in this paragraph, the percentage of
6 pupils who were not tested, reported separately by gender and reported separately
7 for the groups identified in subparagraph (3).

8 (7) The most recent 3-year trend in pupil achievement in each subject area
9 tested and each grade level tested pursuant to NRS 389.015 and 389.550, which
10 may include information regarding the trend in the achievement of pupils for more
11 than 3 years, if such information is available.

12 (8) Information that compares the results of pupils in the school district,
13 including, without limitation, pupils enrolled in charter schools sponsored by the
14 district, with the results of pupils throughout this State. The information required by
15 this subparagraph must be provided in consultation with the Department to ensure
16 the accuracy of the comparison.

17 (9) For each school in the district, including, without limitation, each
18 charter school sponsored by the district, information that compares the results of
19 pupils in the school with the results of pupils throughout the school district and
20 throughout this State. The information required by this subparagraph must be
21 provided in consultation with the Department to ensure the accuracy of the
22 comparison.

23 (10) Information on whether each school in the district, including, without
24 limitation, each charter school sponsored by the district, has made progress based
25 upon the model adopted by the Department pursuant to NRS 385.3595.

26 ➤ A separate reporting for a group of pupils must not be made pursuant to this
27 paragraph if the number of pupils in that group is insufficient to yield statistically
28 reliable information or the results would reveal personally identifiable information
29 about an individual pupil. The State Board shall prescribe the mechanism for
30 determining the minimum number of pupils that must be in a group for that group
31 to yield statistically reliable information.

32 (c) The ratio of pupils to teachers in kindergarten and at each grade level for
33 each elementary school in the district and the district as a whole, including, without
34 limitation, each charter school sponsored by the district, and the average class size

36 school in the district and the district as a whole, including, without limitation, each

41 reported as either an administrator, a teacher or other staff and must not be reported

43 each school in each category, the report must include the number of employees in
44 each of the three categories for each school expressed as a percentage of the total
45 number of persons employed by the school. As used in this paragraph:

47 or her work year supervising other staff or licensed personnel, or both, and who is

(o) Records of the suspension and expulsion of pupils required or authorized pursuant to NRS 392.466 and 392.467.

(p) The number of pupils who are deemed habitual disciplinary problems pursuant to NRS 392.4655, for each school in the district and the district as a whole, including, without limitation, each charter school sponsored by the district.

(q) The number of pupils in each grade who are retained in the same grade pursuant to NRS 392.033 or 392.125, for each school in the district and the district as a whole, including, without limitation, each charter school sponsored by the district.

(r) The transiency rate of pupils for each school in the district and the district as a whole, including, without limitation, each charter school sponsored by the district. For the purposes of this paragraph, a pupil is not transient if the pupil is transferred to a different school within the school district as a result of a change in the zone of attendance by the board of trustees of the school district pursuant to NRS 388.040.

(s) Each source of funding for the school district.

(t) A compilation of the programs of remedial study that are purchased in whole or in part with money received from this State, for each school in the district and the district as a whole, including, without limitation, each charter school sponsored by the district. The compilation must include:

(1) The amount and sources of money received for programs of remedial study for each school in the district and the district as a whole, including, without limitation, each charter school sponsored by the district.

The State Public Charter School Authority and each college or university within the Nevada System of Higher Education that sponsors a charter school shall, on or before September 30 of each year, prepare an annual report of accountability of the charter schools sponsored by the State Public Charter School Authority or institution, as applicable, concerning the accountability information prescribed by the Department pursuant to this section. The Department, in consultation with the State Public Charter School Authority and each college or university within the Nevada System of Higher Education that sponsors a charter school, shall prescribe by regulation the information that must be prepared by the State Public Charter School Authority and institution, as applicable, which must include, without limitation, the information contained in paragraphs (a) to (hh), inclusive, of subsection 2, as applicable to charter schools. A teacher shall be deemed in attendance if the teacher is excused from being present in the classroom by the school in which the teacher is employed for one of the following reasons:

(a) Acquisition of knowledge or skills relating to the professional development of the teacher; or

(b) Assignment of the teacher to perform duties for cocurricular or extracurricular activities of pupils.

5. The annual report of accountability prepared pursuant to subsection 2 or 3, as applicable, must:

- (1) Nevada State Education Association;

- (4) Nevada Parent Teacher Association;
- (5) Budget Division of the Department of Administration;
- (6) Legislative Counsel Bureau; and
- (7) Charter School Association of Nevada,

concerning the program and consider any advice or recommendations submitted by the representatives with respect to the program.

7. The Superintendent of Public Instruction may consult with representatives of parent groups other than the Nevada Parent Teacher Association concerning the program and consider any advice or recommendations submitted by the representatives with respect to the program.

8. On or before September 30 of each year:

(6) The Attorney General, with a specific reference to the information that is reported pursuant to paragraph (gg) of subsection 2.

(b) The board of trustees of each school district, the State Public Charter School Authority and each college or university within the Nevada System of Higher Education that sponsors a charter school shall provide for public dissemination of the annual report of accountability prepared pursuant to subsection 2 or 3, as applicable, in the manner set forth in 20 U.S.C. § 6311(h)(2)(E) by

posting a copy of the report on the Internet website maintained by the school district, the State Public Charter School Authority or the institution, if any. If a school district does not maintain a website, the district shall otherwise provide for public dissemination of the annual report by providing a copy of the report to the schools in the school district, including, without limitation, each charter school sponsored by the district, the residents of the district, and the parents and guardians of pupils enrolled in schools in the district, including, without limitation, each charter school sponsored by the district. If the State Public Charter School Authority or the institution does not maintain a website, the State Public Charter School Authority or the institution, as applicable, shall otherwise provide for public dissemination of the annual report by providing a copy of the report to each charter school it sponsors and the parents and guardians of pupils enrolled in each charter school it sponsors.

Upon the request of the Governor, the Attorney General, an entity described in paragraph (a) of subsection 9 or a member of the general public, the board of trustees of a school district, the State Public Charter School Authority or a college or university within the Nevada System of Higher Education that sponsors a charter school, as applicable, shall provide a portion or portions of the report required pursuant to subsection 2 or 3, as applicable.

9 *principal or the designee shall provide written notice of a reported violation of*
10 *NRS 388.135 to the parent or legal guardian of each pupil involved in the*
11 *reported violation. The notice must include, without limitation, a statement that*
12 *the principal or the designee will be conducting an investigation into the reported*
13 *violation and that the parent or legal guardian may discuss with the principal or*
14 *the designee any counseling and intervention services that are available to the*
15 *pupil.* The investigation must be completed within 10 days after the date on which
16 the investigation is initiated and, if a violation is found to have occurred, include
17 recommendations concerning the imposition of disciplinary action or other
18 measures to be imposed as a result of the violation, in accordance with the policy
19 governing disciplinary action adopted by the board of trustees of the school district.

20 3. The parent or legal guardian of a pupil involved in the reported violation of
21 NRS 388.135 may appeal a disciplinary decision of the principal or his or her
22 designee, made against the pupil as a result of the violation, in accordance with the
23 policy governing disciplinary action adopted by the board of trustees of the school
24 district.

TEXT OF REPEALED SECTIONS

388.1353 Principal required to submit report of violations for each semester to school district; review and compilation of reports by school district; submission of compilation to Department.

1. On or before January 1 and June 30 of each year, the principal of each public school shall submit to the board of trustees of the school district a report on the violations of NRS 388.135 which are reported during the previous school semester. The report must include, without limitation:

(a) The number of violations of NRS 388.135 occurring at the school or otherwise involving a pupil enrolled at the school which are reported during that period; and

(b) Any actions taken at the school to reduce the number of incidents of bullying, cyber-bullying, harassment and intimidation, including, without limitation, training that was offered or other policies, practices and programs that were implemented.

2. The board of trustees of each school district shall review and compile the reports submitted pursuant to subsection 1 and, on or before August 1, submit a compilation of the reports to the Department.

388.1355 Compilation of reports by Superintendent of Public Instruction; submission of written compilation to Attorney General. The Superintendent of Public Instruction shall:

1. Compile the reports submitted pursuant to NRS 388.1353 and prepare a written report of the compilation.

2. On or before October 1 of each year, submit the written compilation to the Attorney General.
