---

AN ACT relating to religious freedom; prohibiting a governmental entity from substantially burdening the exercise of religion of a person under certain circumstances; authorizing a person whose exercise of religion has been so burdened to assert the violation as a claim or defense in a judicial proceeding; authorizing a court to award damages against a governmental entity that substantially burdens the exercise of religion in certain circumstances; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1       Section 4 of Article I of the Nevada Constitution and the First Amendment to the United  
2       States Constitution guarantee citizens of this State the free exercise and enjoyment of religious  
3       profession and worship. This bill enacts the Nevada Preservation of Religious Freedom Act to  
4       further protect those fundamental rights by prohibiting a governmental entity from  
5       substantially burdening the exercise of religion of a person. This prohibition applies regardless  
6       of whether the burden on religion is the result of a rule that is generally applicable and not  
7       specifically directed at religious activity.

8       However, this bill does not apply to or affect the decision of a governmental entity to  
9       grant or deny to religious organizations any appropriation or other money or benefit, or  
10       any tax exemption or other type of tax relief. This bill also does not establish or eliminate  
11       any claim or defense in a civil or criminal action brought under a federal or state civil  
12       rights law, except that this bill protects the acts of religious organizations regarding the  
13       employment, education or volunteer service of a person who performs or will be tasked  
14       with performing any religious duties for the religious organization, such as spreading or  
15       teaching faith, performing devotional services or participating in internal governance of  
16       the religious organization.

17 This bill authorizes a person whose exercise of religion has been substantially burdened  
18 to bring or defend an action in court and to obtain appropriate relief. A governmental entity is  
19 only authorized to substantially burden religious exercise if the governmental entity demonstrates  
20 that the burden furthers a compelling governmental interest and is the least restrictive means by which the governmental entity can further that interest. In addition, this  
21 bill does not restrict the Nevada Legislature from enacting laws which affect religion if the  
22 law explicitly makes the provisions of this bill inapplicable to the new law. This bill further  
23 requires a court to award costs and attorney's fees to a person who prevails ~~in an action~~  
24 ~~brought~~ pursuant to these provisions on a claim or defense against a governmental entity.

1 WHEREAS, The right to the free exercise of religion is set out in Section 4 of  
2 Article 1 of the Nevada Constitution and the First Amendment to the United States  
3 Constitution; and

4 WHEREAS, The State of Nevada has independent authority to protect the free  
5 exercise of religion based on principles that are separate from, complementary to  
6 and more expansive than the Nevada and United States Constitutions; and

7 WHEREAS, Laws that are facially neutral toward religion may burden religious  
8 exercise as significantly as laws which directly interfere with the exercise of  
9 religion; and

10 WHEREAS, The United States Supreme Court has upheld facially neutral laws  
11 which burden the exercise of religion with little justification by the governmental  
12 entity that enacted the law; and

13 WHEREAS, To balance religious freedom and competing governmental  
14 interests, governmental entities must be required to demonstrate compelling  
15 justification when it substantially burdens the exercise of religion; now, therefore,

17 THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
18 SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:  
19

20 **Section 1.** Chapter 41 of NRS is hereby amended by adding thereto the  
21 provisions set forth as sections 2 to ~~7~~ 8, inclusive, of this act.

22 **Sec. 2. *Sections 2 to ~~7~~ 8, inclusive, of this act may be cited as the Nevada***  
***Preservation of Religious Freedom Act.***

23 **Sec. 3. *1. Sections 2 to ~~7~~ 8, inclusive, of this act apply to all state and***  
***local laws and ordinances and the implementation of those laws and ordinances,***  
***whether statutory or otherwise, and whether enacted before, on or after October***  
***1, 2013.***

24 ***2. State laws that are enacted on or after October 1, 2013, are subject to the***  
***provisions of sections 2 to ~~7~~ 8, inclusive, of this act unless the law explicitly***  
***excludes such application by reference to this section.***

25 ***3. The provisions of sections 2 to ~~7~~ 8, inclusive, of this act shall not be***  
***construed as authorizing any do not:***

26 ***(a) Authorize a governmental entity to burden any religious belief of a***  
***person.***

27 ***(b) Apply to or otherwise affect the decision of a governmental entity to grant***  
***or deny to a religious organization any:***

28 ***(1) Appropriation or other money or benefit; or***

29 ***(2) Tax exemption or other type of tax relief.***

30 ***(c) Except as otherwise provided in subsection 4, establish or eliminate any***  
***claim or defense in a civil or criminal action brought under a federal or state civil***  
***rights law.***

1       4. The provisions of sections 2 to 8, inclusive, of this act apply to any claim  
2       or defense regarding the employment, education or volunteer service of a person  
3       who performs or will be tasked with performing any religious duties for a  
4       religious organization, including, without limitation:

- 5        (a) Spreading or teaching faith;  
6        (b) Performing devotional services; or  
7        (c) Participating in internal governance.

8       Sec. 4. As used in sections 2 to ~~7~~ 8, inclusive, of this act, unless the  
9       context otherwise requires, the words and terms defined in sections 5 ~~and~~ 6  
10      and 7 of this act have the meanings ascribed to them in those sections.

11      Sec. 5. "Exercise of religion" means the ability to act or to refuse to act in  
12      a manner substantially motivated by a religious belief, whether or not the  
13      exercise is compulsory or central to a larger system of religious belief.

14      Sec. 6. "Governmental entity" means the State of Nevada, a political  
15      subdivision of the State or an agency of either.

16      Sec. 7. "Religious organization" means an organization that is:

- 17        1. Incorporated, organized or established under law and:  
18           (a) Whose primary purpose and function are religious;  
19           (b) Is a religious school organized primarily for religious and educational  
20           purposes; or  
21           (c) Is a religious charity organized primarily for religious and charitable  
22           purposes; and

23        2. Recognized as exempt from taxation pursuant to section 501(c)(3) of the  
24       Internal Revenue Code of 1986, 26 U.S.C. § 501(c)(3), as amended, and does not  
25       engage in any activities that would disqualify it from such tax-exempt status.

26      ~~See. 7.~~ Sec. 8. 1. Except as otherwise provided in subsection 2 or  
27      section 3 of this act, a governmental entity shall not substantially burden the  
28      exercise of religion of a person regardless of whether the burden is the result of a  
29      rule of general applicability.

30      2. A governmental entity may substantially burden the exercise of religion  
31      of a person only if the governmental entity demonstrates that the burden as  
32      applied to the person:

- 33        (a) Further a compelling governmental interest; and  
34        (b) Is the least restrictive means of furthering that governmental interest.

35      3. Notwithstanding any provision of NRS 41.0305 to 41.039, inclusive, but  
36      subject to the limitation on damages set forth in NRS 41.035 when applicable, a  
37      person whose religious exercise has been substantially burdened in violation of  
38      this section may assert that violation as a claim or defense in a judicial  
39      proceeding and obtain appropriate relief against the governmental entity. The  
40      court shall award costs and attorney's fees to a person who prevails ~~in an action~~  
41      brought on such a claim or defense against a governmental entity pursuant to  
42      this section.

43      4. The court may find that a person is a vexatious litigant if the person  
44      makes a claim within the scope of this section which is without merit, fraudulent  
45      or otherwise intended to harass or annoy a governmental entity. If a court finds  
46      that a person is a vexatious litigant pursuant to this subsection, the court may  
47      deny standing to the person to bring further claims which allege a violation of  
48      this section.
