AN ACT relating to police officers; revising the definition of “police officer” to include court bailiffs and deputy marshals in district courts and justice courts **and chiefs and assistant alternative sentencing officers of departments of alternative sentencing** primarily for purposes of certain provisions relating to occupational diseases; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

Under existing law, court bailiffs and deputy marshals in district courts and justice courts are not included in the statutory definition of Existing law defines “police officer” to include various law enforcement officers in this State for purposes of certain provisions relating to the Nevada Occupational Diseases Act. (NRS 617.135) This bill expands the definition of “police officer” to include ~~such persons, thereby making those provisions of the Act that are applicable to police officers also applicable to:~~ (1) court bailiffs and deputy marshals in district courts and justice courts ~~; and~~ (2) **chiefs and assistant alternative sentencing officers of departments of alternative sentencing**. Furthermore, because various other provisions of NRS reference “police officer” as that term is defined in the Act, this bill makes applicable to court bailiffs and deputy marshals in district courts and justice courts **and to chiefs and alternative sentencing officers of departments of alternative sentencing** certain provisions concerning: (1) industrial insurance coverage; (2) exemption from service as grand or trial jurors; (3) compensation for police officers with temporary disabilities; and (4) certain programs of group insurance or other medical or hospital service for the surviving spouse or any child of police officers and firefighters. (NRS 6.020, 281.153, 287.021, 287.0477, chapters 616A-616D of NRS)

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. NRS 617.135 is hereby amended to read as follows:
617.135 “Police officer” includes:

1 1. A sheriff, deputy sheriff, officer of a metropolitan police department or city
2 police officer;

3 2. A chief, inspector, supervisor, commercial officer or trooper of the Nevada
4 Highway Patrol Division of the Department of Public Safety;

5 3. A chief, investigator or agent of the Investigation Division of the
6 Department of Public Safety;

7 4. A chief, supervisor, investigator or training officer of the Training Division
8 of the Department of Public Safety;

9 5. A chief or investigator of an office of the Department of Public Safety that
10 conducts internal investigations of employees of the Department of Public Safety or
11 investigates other issues relating to the professional responsibility of those
12 employees;

13 6. A chief or investigator of the Department of Public Safety whose duties
14 include, without limitation:

15 (a) The execution, administration or enforcement of the provisions of chapter
16 179A of NRS; and

17 (b) The provision of technology support services to the Director and the
18 divisions of the Department of Public Safety;

19 7. An officer or investigator of the Section for the Control of Emissions From
20 Vehicles and the Enforcement of Matters Related to the Use of Special Fuel of the
21 Department of Motor Vehicles;

22 8. An investigator of the Division of Compliance Enforcement of the
23 Department of Motor Vehicles;

24 9. A member of the police department of the Nevada System of Higher
25 Education;

26 10. A:

27 (a) Uniformed employee of; or

28 (b) Forensic specialist employed by,

29 → the Department of Corrections whose position requires regular and frequent
30 contact with the offenders imprisoned and subjects the employee to recall in
31 emergencies;

32 11. A parole and probation officer of the Division of Parole and Probation of
33 the Department of Public Safety;

34 12. A forensic specialist or correctional officer employed by the Division of
35 Mental Health and Developmental Services of the Department of Health and
36 Human Services at facilities for mentally disordered offenders;

37 13. The State Fire Marshal and his or her assistant and deputies;

38 14. A game warden of the Department of Wildlife who has the powers of a
39 peace officer pursuant to NRS 289.280; ~~H ; Hand~~

40 15. A ranger or employee of the Division of State Parks of the State
41 Department of Conservation and Natural Resources who has the powers of a peace
42 officer pursuant to NRS 289.260 ~~H ; Hand~~

43 16. *A bailiff or a deputy marshal of the district court or justice court whose
44 duties require him or her to carry a weapon and to make arrests H ; and*

45 17. *A chief or an assistant alternative sentencing officer of a department of
46 alternative sentencing created pursuant to NRS 211A.080.*
