SUMMARY—Authorizes a local law enforcement agency to establish or utilize an electronic reporting system to receive information relating to purchases of scrap metal. (BDR 54-869)

AN ACT relating to scrap metal; authorizing a local law enforcement agency to establish or utilize an electronic reporting system to receive information relating to purchases of scrap metal; requiring, under certain circumstances, a scrap metal processor to submit **electronically** to a local law enforcement agency **electronically** **or certain third parties** certain information relating to certain purchases of scrap metal; **providing a penalty;** and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law provides certain restrictions on the sale and purchase of scrap metal in this State and requires scrap metal processors to maintain certain records of purchases of scrap metal. (NRS 647.092-647.098) **Section # 1.3** of this bill authorizes a local law enforcement agency to establish an electronic reporting system or utilize an existing electronic reporting system to receive certain information relating to scrap metal purchases within the jurisdiction of the law enforcement agency. **Section # 1.3** requires that the system be electronically secure and accessible only to : **(1)** a scrap metal processor for the purpose of submitting certain information **and to** ; **(2)** an officer of the local law enforcement agency. **; and (3) an authorized employee of any third party that the local law enforcement agency contracts with for the purpose of receiving and storing the information submitted by a scrap metal processor.** If a local law enforcement agency establishes an electronic reporting system or utilizes an existing electronic reporting system, **section # 1.3** requires a scrap metal processor to submit electronically to the local law enforcement agency **or, if applicable, any third party that the local law enforcement agency has contracted with,** certain information relating to each purchase of scrap metal from certain persons.

Section 2 of this bill specifies that the record of purchase maintained by a scrap metal processor must include a copy of the seller's valid: **(1)** personal identification card issued by

18 the Department of Motor Vehicles; (2) driver's license issued by this State or another state or
19 territory of the United States; ~~or~~; (3) United States military identification card ~~H~~; or (4)
20 consular identification card.

21 Section 1.5 of this bill provides that a person is immune from any civil liability for
22 any action taken with respect to carrying out the provisions of this bill, so long as such
23 actions are taken in good faith and without malicious intent.

24 Section 1.7 of this bill requires a person in whose possession the information
25 required to be submitted to a local law enforcement agency is held to keep the
26 information confidential. Section 1.7 also provides that a person who knowingly and
27 willfully violates this requirement is guilty of a gross misdemeanor.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Chapter 647 of NRS is hereby amended by adding thereto ~~a new~~
2 section to read as follows:the provisions set forth as sections 1.3, 1.5 and 1.7 of
3 this act.

4 Sec. 1.3. 1. *A local law enforcement agency may establish an electronic*
5 *reporting system or utilize an existing electronic reporting system to receive*
6 *information relating to the purchase of scrap metal by a scrap metal processor*
7 *that transacts business within the jurisdiction of the local law enforcement*
8 *agency. An electronic reporting system established or utilized pursuant to this*
9 *subsection must:*

10 (a) *Be electronically secure and accessible only to:*
11 (1) *A scrap metal processor for the purpose of submitting the*
12 *information required by subsection 2; ~~and~~*
13 (2) *An officer of the local law enforcement agency ~~H~~; and*
14 (3) *If applicable, an authorized employee of any designated third party.*

15 (b) *Provide for the electronic submission of information by a scrap metal*
16 *processor.*

17 2. *If a local law enforcement agency establishes an electronic reporting*
18 *system or utilizes an existing electronic reporting system pursuant to subsection*
19 *1, each scrap metal processor that transacts business within the jurisdiction of*
20 *the local law enforcement agency shall, before 12 p.m. of each business day,*
21 *submit electronically to the local law enforcement agency or, if applicable, a*
22 *designated third party the following information regarding each purchase of*
23 *scrap metal conducted on the preceding day from a person who sold the scrap*
24 *metal in his or her individual capacity:*

25 (a) *The name of the seller;*
26 (b) *The date of the purchase;*
27 (c) *The name of the person or employee who conducted the transaction on*
28 *behalf of the scrap metal processor;*

29 (d) *The name, street, house number and date of birth listed on the*
30 *identification provided pursuant to paragraph (c) of subsection 1 of NRS 647.094*
31 *and a physical description of the seller, including the seller's gender, height, eye*
32 *color and hair color;*

33 (e) *The license number and general description of any vehicle that delivered*
34 *the scrap metal;*

35 (f) *The description of the scrap metal recorded pursuant to paragraph (h) of*
36 *subsection 1 of NRS 647.094; and*

37 (g) *The amount, in weight, of scrap metal purchased.*

1 3. If a scrap metal processor is required to submit information to a local law
2 enforcement agency electronically or, if applicable, a designated third party
3 pursuant to subsection 2, the scrap metal processor shall display prominently at
4 the point of purchase a public notice, in a form approved by the local law
5 enforcement agency, describing the information that the scrap metal processor is
6 required to submit electronically to the local law enforcement agency ~~H~~ or, if
7 applicable, the designated third party.

8 4. Nothing in this section shall be deemed to limit or otherwise abrogate any
9 duty of a scrap metal processor to maintain a book or other permanent record of
10 information pursuant to NRS 647.094.

11 5. If a local law enforcement agency establishes an electronic reporting
12 system or utilizes an existing electronic reporting system to receive information
13 pursuant to this section, the local law enforcement agency shall, on or before
14 January 15 of each odd-numbered year, submit to the Director of the Legislative
15 Counsel Bureau for transmittal to the Legislature a report regarding the effect of
16 the electronic reporting system on the incidence of crime which relates to the sale
17 or purchase of scrap metal within the jurisdiction of the law enforcement agency.

18 6. The provisions of this section do not apply to the purchase of scrap metal
19 from a business entity.

20 7. As used in this section, "designated third party" means any person with
21 whom a local law enforcement agency has entered into a contract for the purpose
22 of receiving and storing any information required to be submitted electronically
23 by a scrap metal processor pursuant to subsection 2.

24 Sec. 1.5. A person is immune from any civil liability for any action taken in
25 good faith and without malicious intent in carrying out the provisions of NRS
26 647.094 or section 1.3 of this act.

27 Sec. 1.7. 1. Except as otherwise required pursuant to section 1.3 of this
28 act, any information concerning the purchase of scrap metal, as described in
29 NRS 647.094 and section 1.3 of this act, must be kept confidential by the person
30 in whose possession such information is held.

31 2. A person who knowingly and willfully violates subsection 1 is guilty of a
32 gross misdemeanor.

33 Sec. 2. NRS 647.094 is hereby amended to read as follows:

34 647.094 1. Every scrap metal processor shall maintain in his or her place of
35 business a book or other permanent record in which must be made, at the time of
36 each purchase of scrap metal, a record of the purchase that contains:

37 (a) The date of the purchase.

38 (b) The name or other identification of the person or employee conducting the
39 transaction on behalf of the scrap metal processor.

40 (c) A copy of the seller's valid ~~person~~:

41 (1) Personal identification card ~~for valid driver's~~ issued by this State;

42 (2) Driver's license issued by ~~H~~ this State or any other state ~~or~~ ~~a copy~~
43 ~~of the seller's valid or territory of the United States;~~

44 (3) United States military identification card ~~H~~; or

45 (4) Consular identification card as defined in NRS 237.200.

46 (d) The name, street, house number and date of birth listed on the identification
47 provided pursuant to paragraph (c) and a physical description of the seller,
48 including the seller's gender, height, eye color and hair color.

49 (e) A photograph, video record or digital record of the seller.

50 (f) The fingerprint of the right index finger of the seller. If the seller's right
51 index finger is not available, the scrap metal processor must obtain the fingerprint
52 of one of the seller's remaining fingers and thumbs.

1 (g) The license number and general description of the vehicle delivering the
2 scrap metal that is being purchased.

3 (h) A description of the scrap metal that is being purchased which is consistent
4 with the standards published and commonly applied in the scrap metal industry.

5 (i) The price paid by the scrap metal processor for the scrap metal.

6 2. All records kept pursuant to subsection 1 must be legibly written in the
7 English language, if applicable.

8 3. A scrap metal processor shall document each purchase of scrap metal with
9 a photograph or video recording which must be retained on-site for not less than 60
10 days after the date of the purchase.

11 4. All scrap metal purchased by the scrap metal processor and the records
12 created in accordance with subsection 1, including, but not limited to, any
13 photographs or video recordings, must at all times during ordinary hours of
14 business be open to the inspection of a prosecuting attorney or any peace officer.
