AN ACT relating to counties; providing for the revision of the boundary line between Storey County and Washoe County; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

This bill provides for the revision of the boundary line between Storey County and Washoe County upon the adoption of resolutions by the Board of County Commissioners of Storey County and the Board of County Commissioners of Washoe County approving the revision.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. NRS 243.340 is hereby amended to read as follows:

243.340 1. (b) The common boundary line between Storey County and Washoe County is redefined on April 21, 1973, and that boundary line is established as provided in subsection 1 and NRS 243.335.

14 redefined on April 21, 1973, and that boundary line is established as provided in
15 subsection 1 and NRS 243.335.

16 **Sec. 2.** 1. All taxes and pledged revenue in existence before ~~the effective~~
17 ~~date of this act~~ July 1, 2013, must not be directly or indirectly modified in such a
18 manner as to impair adversely any outstanding obligations of Storey County, until
19 all those obligations have been discharged in full or provision for their payment and
20 redemption has been fully made.

21 2. All taxes and pledged revenue in existence before ~~the effective date of this~~
22 ~~act~~ July 1, 2013, must not be directly or indirectly modified in such a manner as to
23 impair adversely any outstanding obligations of Washoe County, until all those
24 obligations have been discharged in full or provision for their payment and
25 redemption has been fully made.

26 **Sec. 3.** 1. This section and section 2 of this act become effective upon
27 passage and approval.

28 2. Section 1 of this act becomes effective only upon the adoption, on or
