AN ACT relating to education; authorizing a qualified high school pupil who completes a public or private internship to receive credit toward his or her academic requirements for graduation from high school; ***[authorizing certain employers under whose employ and supervision such an internship is completed to receive a business tax credit;]*** and providing other matters properly relating thereto.

1 **Legislative Counsel's Digest:**

2 Existing law establishes the academic subjects and courses of study which are required to
3 receive a standard high school diploma in this State. (NRS 389.018-389.180) **Section 1** of this bill authorizes a qualified high school pupil who is enrolled in grade 11 or 12 to receive one
4 elective credit toward his or her academic requirements for graduation by completing a public
5 or private internship of not less than 60 hours. ***[Section 2 of this bill authorizes a qualified
6 employer to receive a business tax credit of \$250 for each pupil who completes such an
7 internship under the employ and supervision of the employer.]***

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 389 of NRS is hereby amended by adding thereto a new
2 section to read as follows:

3 ***1. A pupil enrolled in grade 11 or 12 at a public school who is at least 16
4 years of age must be allowed to apply not more than one credit toward the total
5 number of credits required for graduation from high school if the pupil
6 successfully completes a public or private internship which has been approved
7 pursuant to subsection 2 and which is of a duration of not less than 60 hours in a
8 school year. The credit must be applied toward the pupil's elective course credits
9 and not toward a course that is required for graduation from high school. A
10 pupil may not receive credit for the completion of an internship if the internship
11 duplicates the requirements of a course of study in which the pupil has received
12 instruction.]***

1 2. *With the approval of the State Board, the board of trustees of a school
2 district or the governing body of a charter school may authorize a qualified pupil
3 to participate in a public or private internship for the purpose of obtaining credit
4 pursuant to subsection 1. If a board of trustees or governing body of a charter
5 school authorizes the participation in a public or private internship, the board of
6 trustees or governing body shall:*

7 (a) *Prescribe:*

8 (1) *The fields, trades or occupations in which a pupil may complete a
9 public or private internship, including, without limitation, agriculture,
10 manufacturing and construction;*

11 (2) *The qualifications of a pupil for participation in a public or private
12 internship;*

13 (3) *The manner in which a qualified pupil must apply for participation in
14 a public or private internship; and*

15 (4) *The manner for verifying that a pupil has completed the requisite
16 number of hours to qualify for credit; and*

17 (b) *Establish and maintain a nonexclusive list of participating businesses,
18 agencies and organizations which offer the employment and supervision of pupils
19 for the purposes of obtaining academic credit in a public or private internship
20 pursuant to this section.*

21 ~~(c) An employer, as defined in NRS 363B.030, in this State that employs a
22 pupil as part of an internship pursuant to this section may apply for and receive a
23 tax credit in the manner set forth in section 2 of this act.]~~

24 Sec. 2. ~~[C~~hapter 363B of NRS is hereby amended by adding thereto a new
25 section to read as follows:

26 1. ~~F~~or each pupil who completes an internship pursuant to section 1 of this
27 act under the employ and supervision of an employer, the employer is entitled to a
28 credit in the amount of \$250 against any excise tax paid by the employer
29 pursuant to NRS 363B.110 for the calendar quarter in which the pupil completes
30 the internship. An employer may not receive for any calendar quarter credit
31 against the excise tax imposed pursuant to NRS 363B.110 in an amount which
32 exceeds the amount of the excise tax paid by the employer.

33 2. ~~T~~he Department shall adopt regulations prescribing:

34 (a) ~~The manner in which an employer may apply for and receive such credit;

36 (b) ~~The requirements for providing proof satisfactory to the Department of
37 the employment of a pupil and the completion of the internship.]~~ ~~(Deleted by

39 Sec. 3. This act becomes effective:

40 1. Upon passage and approval for the purpose of adopting regulations and
41 performing any other preparatory administrative tasks that are necessary to carry
42 out the provisions of this act; and

43 2. On July 1, 2013, for all other purposes.
