AN ACT relating to autonomous vehicles; requiring an autonomous vehicle that is being tested on a highway within this State to meet certain conditions relating to a human operator; prohibiting an autonomous vehicle from being registered in this State, or tested or operated on a highway within this State, unless it meets certain conditions~~;~~ relating to safety; providing that the manufacturer of a motor vehicle that has been converted to be an autonomous vehicle by a third party is immune from liability for certain injuries in certain circumstances; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law requires the Department of Motor Vehicles to adopt regulations authorizing
2 the operation of autonomous vehicles on highways within the State of Nevada. (NRS
3 482A.100) **Sections 2 and 7** of this bill exclude a vehicle that contains certain systems for
4 assisting the driver from being an autonomous vehicle unless the combined effect of all such
5 systems is to enable the vehicle to be driven without the active control or monitoring of a
6 human operator. **Section 2.5 of this bill requires a person or entity to submit to the**
7 **Department proof of insurance or other proof of financial responsibility, in the amount**
8 **of \$5,000,000, before testing an autonomous vehicle on a highway within this State.**
9 **Section 3** of this bill requires an autonomous vehicle that is being tested on a highway within
10 this State to have a human operator who is seated in the driver's seat, monitoring the safe
11 operation of the vehicle and capable of taking over control of the vehicle in an emergency.
12 **Section 4** of this bill prohibits an autonomous vehicle from being registered in this State
13 unless it meets federal standards and regulations. **Section 4** also prohibits an autonomous
14 vehicle from being tested or operated on a highway within this State unless it is equipped with
15 certain equipment to ensure its safe operation and can be operated in compliance with the
16 motor vehicle and traffic laws of this State. **Section 5** of this bill provides that the
17 manufacturer of a motor vehicle that has been converted to an autonomous vehicle by a third
18 party is not liable for an injury that results from that conversion unless the defect that caused
19 the injury was present in the vehicle as originally manufactured.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 482A of NRS is hereby amended by adding thereto the
2 provisions set forth as sections 2 to 5, inclusive, of this act.

3 **Sec. 2.** *"Autonomous technology" means technology which is installed on
4 a motor vehicle and which has the capability to drive the motor vehicle without
5 the active control or monitoring of a human operator. The term does not include
6 an active safety system or a system for driver assistance, including, without
7 limitation, a system to provide electronic blind spot detection, crash avoidance,
8 emergency braking, parking assistance, adaptive cruise control, lane keeping
9 assistance, lane departure warning, or traffic jam and queuing assistance, unless
10 any such system, alone or in combination with any other system, enables the
11 vehicle on which the system is installed to be driven without the active control or
12 monitoring of a human operator.*

13 **Sec. 2.5.** *Before a person or entity begins testing an autonomous vehicle on
14 a highway within this State, the person or entity must:*

- 15 *1. Submit to the Department proof of insurance or self-insurance
16 acceptable to the Department in the amount of \$5,000,000; or*
- 17 *2. Make a cash deposit or post and maintain a surety bond or other
18 acceptable form of security with the Department in the amount of \$5,000,000.*

19 **Sec. 3.** *If an autonomous vehicle is being tested on a highway within this
20 State, a human operator must be:*

- 21 *1. Seated in a position which allows the human operator to take immediate
22 manual control of the autonomous vehicle;*
- 23 *2. Monitoring the safe operation of the autonomous vehicle; and*
- 24 *3. Capable of taking over immediate manual control of the autonomous
25 vehicle in the event of a failure of the autonomous technology or other
26 emergency.*

27 **Sec. 4.** *1. An autonomous vehicle shall not be registered in this State
28 unless the autonomous vehicle meets all federal standards and regulations that
29 are applicable to a motor vehicle.*

30 *2. An autonomous vehicle shall not be tested or operated on a highway
31 within this State unless the autonomous vehicle is:*

32 *(a) Equipped with a means to engage and disengage the autonomous
33 technology which is easily accessible to the human operator of the autonomous
34 vehicle;*

35 *(b) Equipped with a visual indicator located inside the autonomous vehicle
36 which indicates when autonomous technology is ~~driving~~ operating the
37 autonomous vehicle;*

38 *(c) Equipped with a means to alert the human operator to take manual
39 control of the autonomous vehicle if a failure of the autonomous technology has
40 been detected and such failure affects the ability of the autonomous technology to
41 operate safely the autonomous vehicle; and*

42 *(d) Capable of being operated in compliance with the applicable motor
43 vehicle laws and traffic laws of this State.*

44 **Sec. 5.** *The manufacturer of a motor vehicle that has been converted by a
45 third party into an autonomous vehicle is not liable for damages to any person
46 injured due to a defect caused by the conversion of the motor vehicle or by any
47 equipment installed to facilitate the conversion unless the defect that caused the
48 injury was present in the vehicle as originally manufactured.*

1 **Sec. 6.** NRS 482A.010 is hereby amended to read as follows:

2 482A.010 As used in this chapter, unless the context otherwise requires, the
3 words and terms defined in NRS ~~482A.020 to 482A.050, inclusive,~~ **482A.030 and**
4 **482A.040 and section 2 of this act** have the meanings ascribed to them in those
5 sections.

6 **Sec. 7.** NRS 482A.030 is hereby amended to read as follows:

7 482A.030 “Autonomous vehicle” means a motor vehicle that ~~uses~~ **uses** **artificial**
8 ~~intelligence, sensors and global positioning system coordinates to drive itself~~
9 ~~without the active intervention of a human operator~~ **is equipped with autonomous**
10 **technology.**

11 **Sec. 8.** NRS 482A.200 is hereby amended to read as follows:

12 482A.200 The Department shall by regulation establish a driver’s license
13 endorsement for the operation of an autonomous vehicle on the highways of this
14 State. The driver’s license endorsement described in this section must, in its
15 restrictions or lack thereof, recognize the fact that a person is not required to actively
16 drive an autonomous vehicle ~~H, except in case of emergency.~~

17 **Sec. 9.** NRS 482A.020 and 482A.050 are hereby repealed.

18 **Sec. 10.** This act becomes effective on July 1, 2013.

TEXT OF REPEALED SECTIONS

482A.020 “Artificial intelligence” defined. “Artificial intelligence” means the use of computers and related equipment to enable a machine to duplicate or mimic the behavior of human beings.

482A.050 “Sensors” defined. “Sensors” includes, without limitation, cameras, lasers and radar.
