AN ACT relating to insurance; revising provisions governing the membership
voting members of the Board of Directors of the Silver State Health
Insurance Exchange; and providing other matters properly relating
thereto.

Legislative Counsel's Digest:

Under existing law, the Silver State Health Insurance Exchange is governed by a Board of Directors. The Board consists of seven voting members and three ex officio nonvoting members. Existing law provides that five of the voting members are appointed by the Governor, one voting member is appointed by the Senate Majority Leader and one voting member is appointed by the Speaker of the Assembly. Under existing law, the voting members of the Board are required to possess expertise or experience in one of several industries or as a consumer or consumer advocate for those who would benefit from the services provided by the Exchange.~~¶ and are prohibited from being affiliated with a health insurer.~~ (NRS 6951.300) ~~Section 1 of this bill adds two additional voting members to the Board who are to be appointed by the Governor. Section 1 also requires that each voting member of the Board have a minimum of 5 years of experience in one of the various industries listed, or as a consumer or consumer advocate, and adds to that list experience in the large employer health insurance market and experience in the insurance industry generally. Section 1 also~~ This bill removes the prohibition ~~on~~ against any voting member of the Board being affiliated with a health insurer. ~~Section 2 of this bill requires the Governor to appoint two new voting members to the Board on or before July 1, 2013, one with at least 5 years of experience in the large employer health insurance market and one with at least 5 years of experience in the insurance industry generally. Section 3 of this bill provides that the amendatory provisions of this bill do not affect the current term of appointment of any person who, as of the effective date of this act, is a voting member of the Board.~~

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 6951.300 is hereby amended to read as follows:
2 6951.300 1. The governing authority of the Exchange is the Board,
3 consisting of seven ~~nine~~ voting members and three ex officio nonvoting members.

- 28 collectively represented by the voting members of the Board; and
- 29 (b) The voting members of the Board represent a range and diversity of skills,
- 30 knowledge, experience and geographic and stakeholder perspectives.
- 31 5. A voting member of the Board may not be a Legislator or hold any elective

- 38 7. The following are ex officio nonvoting members of the Board who shall

6 member of the Board of Directors of the Silver State Health Insurance Exchange.]

8 Sec. 4. This act becomes effective upon passage and approval.
