AN ACT making ~~an appropriation to the Department of Administration for distribution to Teach for America, Inc.~~ appropriations for certain educational and cultural programs; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. 1. There is hereby appropriated from the State General Fund ~~the following sum\$~~ to the Special Appropriations Account within the Department of 2 Administration for distribution to Teach for America, Inc., ~~to support education in 3 Nevada:~~

4 For the Fiscal Year 2013-2014..... \$1,000,000
5 For the Fiscal Year 2014-2015, the sum of \$1,000,000 to support
6 education in Nevada.

7 2. Upon acceptance of the money distributed pursuant to subsection 1, Teach
8 for America, Inc., shall:

9 (a) Prepare and transmit a report to the Interim Finance Committee on or
10 before December 15, 2014, that describes each expenditure made from the money
11 distributed to Teach for America, Inc. pursuant to subsection 1 from the date on
12 which the money was received by Teach for America, Inc., through December 1,
13 2014;

14 (b) Prepare and transmit a final report to the Interim Finance Committee on or
15 before September 18, 2015, that describes each expenditure made from the money
16 distributed to Teach for America, Inc. pursuant to subsection 1 from the date on
17 which the money was received by Teach for America, Inc., through June 30, 2015;
18 and

19 (c) Upon request of the Legislative Commission, make available to the
20 Legislative Auditor any of the books, accounts, claims, reports, vouchers or other
21 records of information, confidential or otherwise, of Teach for America, Inc.,

1 regardless of their form or location, that the Legislative Auditor deems necessary to
2 conduct an audit of the use of the money distributed to Teach for America, Inc.
3 pursuant to subsection 1.

4 **3. Any remaining balance of the appropriation made by subsection 1**
5 **must not be committed for expenditure after June 30, 2015, by the Department**
6 **of Administration, Teach for America, Inc., or any entity to which money from**
7 **the appropriation is granted or otherwise transferred in any manner, and any**
8 **portion of the appropriated money remaining must not be spent for any**
9 **purpose after September 18, 2015, by the Department of Administration,**
10 **Teach for America, Inc., or the entity to which the money was subsequently**
11 **granted or transferred, and must be reverted to the State General Fund on or**
12 **before September 18, 2015.**

13 Sec. 2. ~~The sums appropriated by section 1 of this act are available for either~~
14 ~~fiscal year. Any remaining balance of those sums must not be committed for~~
15 ~~expenditure after June 30, 2015, by the Department of Administration, Teach for~~
16 ~~America, Inc. or any entity to which money from the appropriation is granted or~~
17 ~~otherwise transferred in any manner, and any portion of the appropriated money~~
18 ~~remaining must not be spent for any purpose after September 18, 2015, by the~~

22 Sec. 3. **1. There is hereby appropriated from the State General Fund to**
23 **the Special Appropriations Account within the Department of Administration**
24 **for distribution to Save the Children the sum of \$100,000 for in-school and**
25 **after-school programs in Nevada.**

26 **2. Any remaining balance of the appropriation made by subsection 1**
27 **must not be committed for expenditure after June 30, 2015, by the Department**
28 **of Administration, Save the Children or any entity to which money from the**
29 **appropriation is granted or otherwise transferred in any manner, and any**
30 **portion of the appropriated money remaining must not be spent for any**
31 **purpose after September 18, 2015, by the Department of Administration, Save**
32 **the Children or the entity to which the money was subsequently granted or**
33 **transferred, and must be reverted to the State General Fund on or before**
34 **September 18, 2015.**

35 Sec. 4. **1. There is hereby appropriated from the State General Fund to**
36 **the Special Appropriations Account within the Department of Administration**
37 **for distribution to Communities in Schools of Nevada, Inc., the sum of**
38 **\$400,000 to coordinate the provision of student and family services to youth in**
39 **this State.**

40 **2. Any remaining balance of the appropriation made by subsection 1**
41 **must not be committed for expenditure after June 30, 2015, by the Department**
42 **of Administration, Communities in Schools of Nevada, Inc., or any entity to**
43 **which money from the appropriation is granted or otherwise transferred in**
44 **any manner, and any portion of the appropriated money remaining must not**
45 **be spent for any purpose after September 18, 2015, by the Department of**
46 **Administration, Communities in Schools of Nevada, Inc., or the entity to which**
47 **the money was subsequently granted or transferred, and must be reverted to**
48 **the State General Fund on or before September 18, 2015.**

49 Sec. 5. **1. There is hereby appropriated from the State General Fund to**
50 **the Special Appropriations Account within the Department of Administration**
51 **for distribution to the Springs Preserve the sum of \$500,000 for the**
52 **establishment of a butterfly structure and exhibit in partnership with the**
53 **Nevada State Museum Las Vegas.**

1 2. Any remaining balance of the appropriation made by subsection 1
2 must not be committed for expenditure after June 30, 2015, by the Department
3 of Administration, the Springs Preserve or any entity to which money from the
4 appropriation is granted or otherwise transferred in any manner, and any
5 portion of the appropriated money remaining must not be spent for any
6 purpose after September 18, 2015, by either the Department of
7 Administration, the Springs Preserve or the entity to which the money was
8 subsequently granted or transferred, and must be reverted to the State
9 General Fund on or before September 18, 2015.
