AN ACT relating to water; providing for the issuance of certain nonemergency orders by the Division of Environmental Protection of the State Department of Conservation and Natural Resources; authorizing the recovery of civil penalties and the imposition of administrative fines for certain violations by a laboratory for the analysis of water; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Under existing law, the Division of Environmental Protection of the State Department of Conservation and Natural Resources is authorized to issue an emergency order requiring a supplier of water immediately to take action necessary to protect the public health if the Division determines that such order is necessary to eliminate an imminent hazard to a public water system. (NRS 445A.930) **Sections 2, 3 and 5** of this bill expand the authority of the Division to issue orders other than emergency orders to correct violations by operators of public water systems and laboratories for the analysis of water. **Section 2 also authorizes, under certain circumstances, the Division to issue a summary order against any person, directing the person to cease and desist from any further acts that constitute or would constitute a violation of certain provisions of law and regulations, or a term or condition of certain permits or certifications.**

Under existing law, a person who owns, controls or operates a public water system is liable for a civil penalty and may be subject to an administrative fine per day for certain violations. (NRS 445A.950) **Section 3** of this bill authorizes the imposition of the same daily monetary penalties against a laboratory for the analysis of water for certain violations.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 445A of NRS is hereby amended by adding thereto the
2 provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2.** 1. *If the Division has reason to believe that a person is engaging*
4 *or has engaged in any act or practice which violates the provisions of NRS*
5 *445A.800 to 445A.955, inclusive, and sections 2 and 3 of this act, or a regulation*
6 *adopted or order issued pursuant thereto, or any term or condition of a permit to*
7 *operate a public water system issued pursuant to NRS ~~445A.885~~ 445A.860 or a*
8 *certification of a laboratory for the analysis of water issued pursuant to NRS*
9 *445A.863, the Division may, in addition to any other action authorized or*
10 *required by NRS 445A.800 to 445A.955, inclusive, and sections 2 and 3 of this*
11 *act, issue an order:*

12 (a) *Specifying the provision or provisions which the Division believes or has*
13 *reason to believe the person is violating or has violated;*

14 (b) *Setting forth the facts alleged to constitute the violation;*

15 (c) *Prescribing the actions the person must take to correct the violation and*
16 *the period during which the violation must be corrected; and*

17 (d) *Requiring the person to appear before the Administrator of the Division*
18 *or a hearing officer appointed by the Administrator to show cause why the*
19 *Division should not commence an action against the person in district court for*
20 *appropriate relief.*

21 2. *If the Division has reasonable cause to believe, based on evidence*
22 *satisfactory to it, that any person is about to violate the provisions of this section*
23 *and NRS 445A.800 to 445A.955, inclusive, and section 3 of this act, or a*
24 *regulation adopted or order issued pursuant thereto, or any term or condition of a*
25 *permit to operate a public water system issued pursuant to NRS 445A.860 or a*
26 *certification of a laboratory for the analysis of water issued pursuant to NRS*
27 *445A.863, the Division may, without a prior hearing, issue a summary order*
28 *against the person, directing the person to cease and desist from any further acts*
29 *that constitute or would constitute a violation. The summary order to cease and*
30 *desist must specify the provision of this section and NRS 445A.800 to 445A.955,*
31 *inclusive, and section 3 of this act, or a regulation adopted or order issued*
32 *pursuant thereto, or the term or condition of a permit or certification which the*
33 *Division reasonably believes is about to be violated.*

34 3. *An order issued by the Division pursuant to subsection 1 or 2 is effective*
35 *immediately and is not subject to review unless the person to whom the order is*
36 *directed, not later than 30 days after the order is ~~served~~ issued, submits a*
37 *written petition to the ~~Division~~ Commission for a hearing.*

38 **Sec. 3.** 1. A laboratory for the analysis of water that:

39 (a) ~~*Violates any standard established pursuant to NRS 445A.855;*~~

40 ~~*(b) Violates any regulation adopted by the Commission pursuant to NRS*~~
41 ~~*445A.863; or*~~

42 ~~*(c) Violates or fails to comply with an order issued pursuant to*~~
43 ~~*subsection 1 or 2 of section 2 of this act,*~~

44 ~~*is liable for a civil penalty, to be recovered by the Attorney General in the*~~
45 ~~*name of the Division, of not more than \$5,000 for each day of the violation.*~~

46 2. In addition to the civil penalty described in subsection 1, the Division
47 may impose an administrative fine of not more than \$2,500 per day for each
48 violation described in subsection 1.

1 **3. The civil penalty and administrative fine authorized by this section are in**
2 **addition to any other penalties or relief prescribed by NRS 445A.800 to 445A.955,**
3 **inclusive, and sections 2 and 3 of this act.**

4 **Sec. 4.** NRS 445A.805 is hereby amended to read as follows:

5 445A.805 As used in NRS 445A.800 to 445A.955, inclusive, **and sections 2**
6 **and 3 of this act**, unless the context otherwise requires, the words and terms
7 defined in NRS 445A.807 to 445A.850, inclusive, have the meanings ascribed to
8 them in those sections.

9 **Sec. 5.** NRS 445A.950 is hereby amended to read as follows:

10 445A.950 1. Any supplier of water who:

11 (a) Violates any standard established pursuant to NRS 445A.855;

12 (b) Violates or fails to comply with an ~~emergency~~ order issued pursuant to
13 NRS 445A.930 ~~or~~ **or subsection 1 or 2 of section 2 of this act;**

14 (c) Violates any condition imposed by the Commission upon granting a
15 variance or exemption under NRS 445A.935;

16 (d) Violates a regulation adopted by the Commission pursuant to NRS
17 445A.860 ~~or~~ **445A.880; or**

18 (e) Fails to give a notice as required by NRS 445A.940,

19 is liable for a civil penalty, to be recovered by the Attorney General in the name
20 of the Division, of not more than \$5,000 for each day of the violation.

21 2. In addition to the civil penalty prescribed in subsection 1, the Division may
22 impose an administrative fine against a supplier of water who commits any
23 violation enumerated in subsection 1. The administrative fine imposed may not be
24 more than \$2,500 per day for each such violation.

25 3. The civil penalty and administrative fine prescribed in this section may be
26 imposed in addition to any other penalties or relief prescribed in NRS 445A.800 to
27 445A.955, inclusive ~~or~~ **, and sections 2 and 3 of this act.**

28 **Sec. 6.** This act becomes effective upon passage and approval.
