AN ACT relating to the State Board of Equalization; revising provisions governing the compensation paid to members of the Board; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law provides that each member of the State Board of Equalization is entitled to receive a salary of not more than \$80 for each day actually employed on the work of the Board. (NRS 361.375) This bill ~~replaces~~ revises the daily compensation rate ~~with an annual salary that is commensurate with the salary paid to the Chair and members of the Nevada Tax Commission. (NRS 360.050)~~ to provide that each member of the Board is entitled to receive a salary of not more than \$150 for each day actually employed on the work of the Board.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 361.375 is hereby amended to read as follows:

2 361.375 1. The State Board of Equalization, consisting of five members
3 appointed by the Governor, is hereby created. The Governor shall designate one of
4 the members to serve as Chair of the Board.

5 2. The Governor shall appoint:

6 (a) One member who is a certified public accountant or a registered public
7 accountant.

8 (b) One member who is a property appraiser with a professional designation.

9 (c) One member who is versed in the valuation of centrally assessed properties.

10 (d) Two members who are versed in business generally.

11 3. Only three of the members may be of the same political party and no more
12 than two may be from the same county.

13 4. An elected public officer or his or her deputy, employee or any person
14 appointed by him or her to serve in another position must not be appointed to serve
15 as a member of the State Board of Equalization.

1 5. After the initial terms, members serve terms of 4 years, except when
2 appointed to fill unexpired terms. No member may serve more than two full terms
3 consecutively.

4 6. Any member of the State Board of Equalization may be removed by the
5 Governor if, in the opinion of the Governor, that member is guilty of malfeasance
6 in office or neglect of duty.

7 7. Each member of the #The Chair of the# State Board of Equalization is
8 entitled to receive a #an annual# salary of not more than \$80,150, as fixed by
the Board, for each day actually employed on the work of the Board \$27,500,

9 8. #Each of the other members is entitled to receive an annual salary of
10 \$20,000.

11 9. While engaged in the business of the State Board of Equalization, each
12 member and employee of the Board is entitled to receive the per diem allowance
13 and travel expenses provided for state officers and employees generally.

14 10. A majority of the members of the State Board of Equalization
15 constitutes a quorum, and a majority of the Board shall determine the action of the
16 Board. The Board may adopt regulations governing the conduct of its business.

17 11. The State Board of Equalization shall comply with any applicable
18 regulation adopted by the Nevada Tax Commission.

19 12. The staff of the State Board of Equalization must be provided by the
20 Department and the Executive Director is the Secretary of the Board.

21 Sec. 2. This act becomes effective on July 1, 2013.
