AN ACT relating to child welfare; requiring an agency which provides child welfare services to obtain and examine the credit report for certain children in its custody; requiring the agency to report each potential instance of identity theft or other crime to the Attorney General and make a diligent effort to resolve any inaccuracy in the report; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law requires an agency which provides child welfare services to provide
2 maintenance and special services to children who are placed in the custody of the agency.
3 (NRS 432.020) This bill requires an agency which provides child welfare services to obtain
4 and examine the credit report of certain children placed into its custody when each child
5 reaches the age of 16 years or, if a child has reached the age of 16 years before being
6 placed into the custody of the agency, upon placement of ~~to~~ the child ~~and at certain~~
7 ~~times~~ least once annually thereafter to identify any inaccuracies in the credit report. If the
8 agency finds any inaccuracies, this bill requires the agency to report any information which
9 indicates that a potential instance of identity theft or other crime may have occurred to the
10 Attorney General and to continue to make a diligent effort to resolve each inaccuracy until all
11 inaccuracies have been corrected. This bill authorizes the Attorney General to investigate any
12 such reports and prosecute the persons responsible for any identity theft identified in the
13 investigation.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 432 of NRS is hereby amended by adding thereto a new
2 section to read as follows:

3 **1. An agency which provides child welfare services ~~shall, for each child~~**
4 ~~placed in the custody of the agency which provides child welfare services for 60~~
5 ~~or more consecutive days, request and examine, within 90 days after placement of~~
6 ~~the child, a copy of any credit report that may exist for the child.~~

7 **~~2. In addition to the requirements of subsection 1, an agency which~~**
8 ~~provides child welfare services, shall request and examine a copy of any credit~~
9 ~~report that may exist for each child who remains in the custody of the agency~~
10 ~~which provides child welfare services for 60 or more consecutive days:~~

11 **~~(a) At least once every 3 years until When the child reaches the age of 16~~**
12 ~~years, and then at least once annually thereafter as required pursuant to 42~~
13 **U.S.C. § 675(5)(I); or**

14 **~~(b) At least 6 months, but not more than 1 year, before the child will leave~~**
15 ~~the custody of the agency which provides child welfare services or, if less than 6~~
16 ~~months remain before the child will leave the custody of the agency which~~
17 ~~provides child welfare services, as soon as practicable after the agency which~~
18 ~~provides child welfare services determines that the child will leave its custody,~~
19 ~~and~~

20 **~~(c) Within 1 week after the child leaves the custody of the agency which~~**
21 ~~provides child welfare services.~~

22 **~~3. If the child has reached the age of 16 years before the child is placed in~~**
23 ~~the custody of the agency which provides child welfare services, upon the~~
24 ~~placement of the child in the custody of the agency which provides child welfare~~
25 ~~services, and then at least once annually thereafter as required pursuant to 42~~
26 **U.S.C. § 675(5)(I).**

27 **2. An agency which provides child welfare services shall determine from the**
28 **examination of a credit report pursuant to this section whether the credit report**
29 **contains inaccurate information and whether the credit report indicates that**
30 **identity theft or any other crime has been committed against the child.**

31 **~~4. If the agency which provides child welfare services determines that~~**
32 **~~an inaccuracy exists in the credit report of a child, the agency which provides~~**
33 **~~child welfare services must:~~**

34 **~~(a) Report any information which may indicate identity theft or other crime~~**
35 **~~to the Attorney General;~~**

36 **~~(b) Make a diligent effort to resolve the inaccuracy as soon as practicable;~~**

38 **~~(c) Continue to make diligent efforts to resolve the inaccuracy if it remains~~**
39 **~~unresolved after the child has left the custody of the agency which provides child~~**
40 **~~welfare services until the inaccuracy is corrected.~~**

41 **~~5. The Attorney General may investigate each potential instance of~~**
42 **~~identity theft or crime reported pursuant to subsection 4 and prosecute in~~**
43 **~~accordance with law each person responsible for any identity theft identified in~~**
44 **~~the investigation.~~**

45 **Sec. 2.** This act becomes effective on July 1, 2013.
