AN ACT relating to education; expanding the scope of the Kenny C. Guinn Memorial Millennium Scholarship by requiring the Board of Trustees of the College Savings Plans of Nevada to award the Memorial Scholarship to two eligible recipients each year; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law requires the Board of Trustees of the College Savings Plans of  
2 Nevada to award annually the Kenny C. Guinn Memorial Millennium Scholarship  
3 to one eligible recipient who is a senior or rising senior at a university, state college  
4 or community college within the Nevada System of Higher Education or at certain  
5 other accredited colleges or universities in this State. (NRS 396.945) This bill  
6 requires the Board to award annually the Memorial Scholarship to: (1) one eligible  
7 recipient who is a student enrolled at the University of Nevada, Reno, Great Basin  
8 College, Sierra Nevada College or any other eligible college or university  
9 designated by the Board as representative of northern Nevada; and (2) one eligible  
10 recipient who is a student enrolled at the University of Nevada, Las Vegas, Nevada  
11 State College or any other eligible college or university designated by the Board as  
12 representative of southern Nevada.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1      **Section 1.** NRS 396.945 is hereby amended to read as follows:  
2      396.945 1. ***The Board shall annually award the Memorial***  
3 ***Scholarship to:***  
4      ***(a) One recipient who is a student enrolled at:***

1           (1) *The University of Nevada, Reno, Great Basin College or*  
2 *Sierra Nevada College; or*

3           (2) *Any other college or university which awards a*  
4 *bachelor's degree in education and which is designated by the*  
5 *Board as an institution representative of northern Nevada; and*

6           (b) *One recipient who is a student enrolled at:*

7           (1) *The University of Nevada, Las Vegas, or Nevada State*  
8 *College; or*

9           (2) *Any other college or university which awards a*  
10 *bachelor's degree in education and which is designated by the*  
11 *Board as an institution representative of southern Nevada.*

12          2. The Board shall establish *additional* criteria governing the  
13 annual selection of ~~the~~ *each* recipient of the Memorial  
14 Scholarship, which must include, without limitation, a requirement  
15 that ~~the~~ *a* recipient:

16           (a) Be in or entering his or her senior year at an ~~eligible~~  
17 *academic* institution ~~is~~ *described in subsection 1;*

18           (b) Be on the list of eligible students for a Millennium  
19 Scholarship which is certified to the State Treasurer pursuant to  
20 NRS 396.934;

21           (c) Have a college grade point average of not less than 3.5 on a  
22 4.0 grading scale;

23           (d) Have a declared major in elementary education or secondary  
24 education;

25           (e) Have a stated commitment to teaching in this State following  
26 graduation; and

27           (f) Have a commendable record of community service.

28          ~~2~~ 3. A student who satisfies the criteria established pursuant  
29 to ~~subsection~~ *this section* may apply for a Memorial Scholarship  
30 by submitting an application to the Office of the State Treasurer on  
31 a form provided on the Internet website of the State Treasurer.

32          ~~3~~ 4. The State Treasurer shall forward all applications  
33 received pursuant to subsection ~~2~~ 3 to the Board. The Board shall  
34 review and evaluate each application received from the State  
35 Treasurer and select ~~the~~ *each* recipient of the Memorial  
36 Scholarship ~~is~~.

37          ~~4~~ *in accordance with the criteria established pursuant to this*  
38 *section.*

39          5. To the extent of available money in the account established  
40 pursuant to NRS 396.940, the annual Memorial Scholarship may be  
41 awarded to ~~the~~ *each* selected recipient in an amount not to exceed  
42 \$4,500 to pay the educational expenses of the recipient for the  
43 school year which are authorized by subsection ~~5~~ 6 and which are  
44 not otherwise paid for by the Millennium Scholarship awarded to  
45 the recipient.

1        ~~15-~~ **6.** A Memorial Scholarship must be used only:

- 2            (a) For the payment of registration fees and laboratory fees and  
3            expenses;  
4            (b) To purchase required textbooks and course materials; and  
5            (c) For other costs related to the attendance of the student at the  
6            ~~eligible academic~~ institution ~~in which he or she is enrolled.~~

7        **—6.** As used in this section, “Board” means the Board of  
8            Trustees of the College Savings Plans of Nevada created by  
9            NRS 353B.005.

10      **Sec. 2.** This act becomes effective on July 1, 2013.
