

SENATE BILL NO. 13—COMMITTEE ON TRANSPORTATION

(ON BEHALF OF THE DEPARTMENT OF MOTOR VEHICLES)

PREFILED DECEMBER 19, 2012

Referred to Committee on Transportation

SUMMARY—Authorizes the Department of Motor Vehicles to suspend the registration of a motor vehicle under certain circumstances. (BDR 43-368)

AN ACT relating to motor vehicles; authorizing the Department of Motor Vehicles to suspend the registration of a motor vehicle of a person whose payment to the Department for registration is dishonored; providing for the reinstatement of the registration upon payment of certain fees; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Under existing law, the Department of Motor Vehicles is required to cancel the registration of a motor vehicle if the registration and license plates were issued erroneously or improperly or obtained illegally. (NRS 482.465) Existing law also requires a person to pay fees and penalties if the person does not pay the governmental services tax for a vehicle for the next period of registration before the expiration of the current period of registration, or if the person operates a vehicle upon the highways of this State without having paid the registration fee. (NRS 371.140, 482.515) Existing law also authorizes the Department to waive any applicable delinquent fees and penalties if the Department determines that the dishonored payment: (1) was caused by circumstances beyond the registered owner's control; (2) occurred despite the registered owner's exercise of ordinary care; and (3) was not a result of the registered owner's willful neglect. (NRS 482.188) **Section 1** of this bill authorizes the Department to suspend the registration of a motor vehicle if the check or other method of payment for the registration fee is returned to the Department or otherwise dishonored. If the Department suspends the registration of a motor vehicle of a person, the person is required to immediately return to the Department the certificate of registration and the license plates of the motor vehicle. The Department must provide notice of the suspension by mail to the registered owner of the motor vehicle which must include

20 information concerning the reinstatement of the registration. The registration must
21 be reinstated and the license plates returned to the registered owner upon payment
22 of the applicable registration and license plate fees, governmental services tax, and
23 any delinquent fees or penalties and other outstanding debts owed to the
24 Department.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 482 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *1. The Department may suspend the registration of a motor
4 vehicle and require the return to the Department of the certificate
5 of registration and the license plates of the motor vehicle if a
6 check, draft, electronic transfer of money or other method of
7 payment provided to the Department to register the motor vehicle
8 is returned to the Department or otherwise dishonored by the
9 financial institution on which the check, draft or electronic
10 transfer of money is drawn.*

11 *2. If the registration of a motor vehicle of a person is
12 suspended pursuant to this section, the person shall immediately
13 return the certificate of registration and license plates to the
14 Department.*

15 *3. The period of suspension of the registration of a motor
16 vehicle that is suspended pursuant to this section begins on the
17 effective date of the suspension as set forth in the notice thereof.*

18 *4. The Department shall mail to the registered owner of the
19 motor vehicle a notice of the suspension. The notice must include:*

20 *(a) The effective date of the suspension;
21 (b) The reason for the suspension;
22 (c) The requirement for the return of the certificate of
23 registration and the license plates of the motor vehicle;
24 (d) The method by which the registration may be reinstated;
25 and
26 (e) Any other information the Department deems necessary.*

27 *5. Except as otherwise provided in NRS 353C.125, the
28 Department shall reinstate the registration of a motor vehicle and
29 issue license plates to the registered owner of the motor vehicle
30 only upon the payment of:*

31 *(a) Any registration and other fees or penalties required
32 pursuant to this chapter;*

33 *(b) Any governmental services tax required pursuant to
34 chapter 371 of NRS; and*

35 *(c) Any fees and penalties required pursuant to NRS 41.620,
36 371.140 or 481.079.*

1 **Sec. 2.** NRS 482.480 is hereby amended to read as follows:

2 482.480 There must be paid to the Department for the
3 registration or the transfer or reinstatement of the registration of
4 motor vehicles, trailers and semitrailers, fees according to the
5 following schedule:

6 1. Except as otherwise provided in this section, for each stock
7 passenger car and each reconstructed or specially constructed
8 passenger car registered to a person, regardless of weight or number
9 of passenger capacity, a fee for registration of \$33.

10 2. Except as otherwise provided in subsection 3:

11 (a) For each of the fifth and sixth such cars registered to
12 a person, a fee for registration of \$16.50.

13 (b) For each of the seventh and eighth such cars registered to a
14 person, a fee for registration of \$12.

15 (c) For each of the ninth or more such cars registered to a
16 person, a fee for registration of \$8.

17 3. The fees specified in subsection 2 do not apply:

18 (a) Unless the person registering the cars presents to the
19 Department at the time of registration the registrations of all the cars
20 registered to the person.

21 (b) To cars that are part of a fleet.

22 4. For every motorcycle, a fee for registration of \$33 and for
23 each motorcycle other than a trimobile, an additional fee of \$6 for
24 motorcycle safety. The additional fee must be deposited in the State
25 Highway Fund for credit to the Account for the Program for the
26 Education of Motorcycle Riders.

27 5. For each transfer of registration, a fee of \$6 in addition to
28 any other fees.

29 6. Except as otherwise provided in subsection 7 of
30 NRS 485.317, to reinstate the registration of a motor vehicle that is
31 suspended pursuant to that section:

32 (a) A fee as specified in NRS 482.557 for a registered owner
33 who failed to have insurance on the date specified by the
34 Department, which fee is in addition to any fine or penalty imposed
35 pursuant to NRS 482.557; or

36 (b) A fee of \$50 for a registered owner of a dormant vehicle who
37 cancelled the insurance coverage for that vehicle or allowed the
38 insurance coverage for that vehicle to expire without first cancelling
39 the registration for the vehicle in accordance with subsection 3 of
40 NRS 485.320,

41 → both of which must be deposited in the Account for Verification
42 of Insurance which is hereby created in the State Highway Fund.
43 The money in the Account must be used to carry out the provisions
44 of NRS 485.313 to 485.318, inclusive.

45 7. For every travel trailer, a fee for registration of \$27.

1 8. For every permit for the operation of a golf cart, an annual
2 fee of \$10.

3 9. For every low-speed vehicle, as that term is defined in
4 NRS 484B.637, a fee for registration of \$33.

5 10. To reinstate the registration of a motor vehicle that is
6 suspended pursuant to NRS 482.451 ~~H~~ or section 1 of this act, a fee
7 of \$33.

8 **Sec. 3.** This act becomes effective upon passage and approval.
