SUMMARY—Authorizes the Nevada Silver Haired Legislative Forum to request the drafting of not more than one legislative measure for each regular session of the Legislature. (BDR 17-924)

AN ACT relating to legislative measures; authorizing the Nevada Silver Haired Legislative Forum to request the drafting of not more than one legislative measure for each regular session of the Legislature; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

- 1 Existing law creates the Nevada Silver Haired Legislative Forum and
- 2 prescribes the powers and duties of the Forum. (NRS 427A.320-427A.400)
- 3 Existing law further prescribes the number of legislative measures which may be
- 4 requested by various departments, agencies and other entities of this State for each
- 5 regular session of the Legislature. (NRS 218D.100-218D.215)
- 6 This bill authorizes the Forum to request for each regular session of the
- 7 Legislature the drafting of not more than one legislative measure which relates to
- 8 matters within the scope of the Forum.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 218D of NRS is hereby amended by
2 adding thereto a new section to read as follows:

3 **1. For a regular session, the Nevada Silver Haired Legislative**
4 **Forum created by NRS 427A.320 may request the drafting of not**
5 **more than 1 legislative measure which relates to matters within**
6 **the scope of the Forum. The request must be submitted to the**
7 **Legislative Counsel on or before September 1 preceding the**
8 **regular session.**

9 **2. A request made pursuant to this section must be on a form**
10 **prescribed by the Legislative Counsel. A legislative measure**
11 **requested pursuant to this section must be prefiled on or before**
12 **December 20 preceding the regular session. A legislative measure**
13 **that is not prefiled on or before that date shall be deemed**
14 **withdrawn.**

15 **Sec. 2.** NRS 218D.100 is hereby amended to read as follows:

16 218D.100 1. The provisions of NRS 218D.100 to 218D.215,
17 inclusive, **and section 1 of this act** apply to requests for the drafting
18 of legislative measures for a regular session.

19 2. Except as otherwise provided by a specific statute, joint rule
20 or concurrent resolution, the Legislative Counsel shall not honor a
21 request for the drafting of a legislative measure if the request:

22 (a) Exceeds the number of requests authorized by NRS
23 218D.100 to 218D.215, inclusive, **and section 1 of this act** for the
24 requester; or

25 (b) Is submitted by an authorized nonlegislative requester
26 pursuant to NRS 218D.175 to 218D.215, inclusive, **and section 1 of**
27 **this act** but is not in a subject related to the function of the requester.

28 3. The Legislative Counsel shall not:

29 (a) Except as otherwise provided in NRS 218D.150, 218D.155
30 and 218D.160, assign a number to a request for the drafting of a
31 legislative measure to establish the priority of the request until
32 sufficient detail has been received to allow complete drafting of the
33 legislative measure.

34 (b) Honor a request to change the subject matter of a request for
35 the drafting of a legislative measure after it has been submitted for
36 drafting.

37 (c) Honor a request for the drafting of a legislative measure
38 which has been combined in violation of Section 17 of Article 4 of
39 the Nevada Constitution.
