

SENATE BILL NO. 320—SENATORS HARDY AND DENIS

MARCH 18, 2013

Referred to Committee on Education

SUMMARY—Revises provisions governing medical care in schools. (BDR 34-831)

EXPLANATION – Matter in *bolded italics* is new; matter between brackets ~~omitted material~~ is material to be omitted.

AN ACT relating to education; providing that a pupil with diabetes must not be prohibited from enrolling in a public school; requiring school nurses or, in certain circumstances, local health officers or the designees of local health officers, to prescribe training programs for employees of public and private schools who volunteer to serve as unlicensed assistive personnel; authorizing public and private schools to provide assistance to pupils with diabetes in the care and management of the disease under certain circumstances; authorizing the parent or legal guardian of a pupil with diabetes to request such assistance; prescribing the duties of unlicensed assistive personnel; providing for the authorization of a pupil with diabetes to self-administer medication and otherwise care for and manage the diabetes under certain circumstances; providing immunity from civil liability for school nurses, unlicensed assistive personnel and other school personnel, the board of trustees of a school district, the governing body of a private school, local health officers and the designees of local health officers under certain circumstances; providing an exemption for unlicensed assistive personnel from state licensing requirements for practicing nursing in this State; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 **Section 8** of this bill provides that the board of trustees of a school district or a  
2 principal of a public school shall not: (1) prohibit any pupil with diabetes from  
3 enrolling in any public school in which the pupil would otherwise be able to enroll  
4 if the pupil did not have diabetes; or (2) require the parent or guardian of a pupil to  
5 provide any service or assistance to the pupil to care for or manage the diabetes  
6 while the pupil is on the grounds of a public school, participating in certain  
7 activities or on a school bus.

8 **Section 9** of this bill requires each school nurse or, if a public school does not  
9 have a school nurse, the local health officer or the local health officer's designee, to  
10 prescribe a training program for employees of public schools who volunteer to  
11 serve as unlicensed assistive personnel. The training program must include certain  
12 instruction and be provided by a school nurse, the local health officer or the local  
13 health officer's designee, as applicable.

14 **Section 10** of this bill establishes a procedure pursuant to which the parent or  
15 legal guardian of a pupil with diabetes in a public school may request that the  
16 public school provide assistance with the care and management of the diabetes  
17 while the pupil is on the grounds of a public school, participating in an activity  
18 sponsored by a public school or on a school bus. **Section 10** authorizes the school  
19 nurse or the principal, as applicable, to provide a written notice to all employees of  
20 the public school seeking volunteers to serve as unlicensed assistive personnel. The  
21 notice must provide that serving as unlicensed assistive personnel is voluntary and  
22 that employees who choose not to volunteer will not be subject to any retaliatory or  
23 disciplinary action, and must include a description of the training program  
24 prescribed pursuant to **section 9** that employees must complete to become  
25 unlicensed assistive personnel. **Section 11.5** of this bill provides for the  
26 development of an individualized health plan for a pupil with diabetes by the school  
27 nurse or the local health officer or his or her designee, as applicable, upon the  
28 approval of a request submitted pursuant to **section 10**. **Section 12** of this bill  
29 describes the written authorization that the parent or legal guardian must submit to  
30 the school nurse or the principal of the school, as applicable, upon receiving  
31 approval of such a request, and **section 13** of this bill sets forth the duties of the  
32 school nurse or principal, as applicable, upon receiving such an authorization.

33 **Section 14** of this bill sets forth the specific acts that unlicensed assistive  
34 personnel may perform in assisting a pupil with diabetes.

35 **Section 15** of this bill provides a procedure pursuant to which a pupil with  
36 diabetes may be authorized to self-administer medication for the treatment of the  
37 diabetes and otherwise care for and manage the diabetes while on the grounds of a  
38 public school, at an activity sponsored by a public school or on a school bus.

39 **Section 16** of this bill requires the State Board of Education, in cooperation  
40 with the State Board of Nursing, to adopt necessary regulations to carry out the  
41 provisions of **sections 3-17** of this bill.

42 **Section 17** provides that a school nurse, unlicensed assistive personnel, other  
43 school personnel, the board of trustees of a school district, local health officers and  
44 the designees of local health officers are not subject to civil liability, and a school  
45 nurse, unlicensed assistive personnel and other school personnel and local health  
46 officers and designees of local health officers are not subject to any disciplinary  
47 action, for certain acts performed by any person in carrying out any duty or  
48 authorized activity set forth in this bill.

49 **Sections 19-32** of this bill set forth provisions similar to **sections 3-17** which  
50 apply to private schools.

51 Existing law requires a person who practices or offers to practice nursing in this  
52 State to be licensed by the State Board of Nursing. (NRS 632.315) Existing law  
53 also provides certain exemptions from that requirement. (NRS 632.340) **Section 33**  
54 of this bill revises those exemptions to include unlicensed assistive personnel who

55 provide assistance to a pupil with diabetes in the care and management of the  
56 diabetes in accordance with the provisions of **sections 3-17 or 19-32.**

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1       **Section 1.** NRS 391.208 is hereby amended to read as follows:  
2       391.208 A school nurse shall, for each school at which he or  
3 she is responsible for providing nursing services:  
4       1. Ensure that each pupil enrolled in the school has been  
5 immunized in accordance with, is exempt from or has otherwise  
6 complied with, the requirements set forth in NRS 392.435 to  
7 392.446, inclusive.  
8       2. Assess and evaluate the general health and physical  
9 development of the pupils enrolled in the school to identify those  
10 pupils who have physical or mental conditions that impede their  
11 ability to learn.  
12       3. Report the results of an evaluation conducted pursuant to

15       (b) Each administrator and teacher directly involved with the

18 need the information to assist the pupil with the pupil's health or

20       4. Design and carry out a plan of nursing care for a pupil with  
21 special needs which incorporates *any individualized health plan*  
22 *and* any plan specified by the pupil's physician or provider of health  
23 care, as defined in NRS 629.031, ~~and~~ which is approved by the  
24 pupil's parent or guardian. ~~The~~ *Except as otherwise provided in*  
25 *sections 3 to 17, inclusive, of this act, the* nursing services provided  
26 pursuant to a plan of nursing care must be performed in compliance  
27 with chapter 632 of NRS. *As used in this subsection,*  
28 *"individualized health plan" has the meaning ascribed to it in*  
29 *section 5 of this act.*  
30       5. When appropriate, refer a pupil and the pupil's parent or  
31 guardian to other sources in the community to obtain services  
32 necessary for the health of the pupil.  
33       6. Interpret medical and nursing information that relates to a  
34 pupil's individual educational plan or individualized  
35 accommodation plan and make recommendations to:  
36       (a) Professional personnel directly involved with that pupil; and  
37       (b) The parents or guardian of that pupil.

2 thereto the provisions set forth as sections 3 to 17, inclusive, of this

4       **Sec. 3.** *As used in sections 3 to 17, inclusive, of this act,*  
5 *unless the context otherwise requires, the words and terms defined*  
6 *in sections 5 to 7.5, inclusive, of this act have the meanings*

9       **Sec. 5.** *“Individualized health plan” means the plan*

18       **Sec. 7.5.** *“Unlicensed assistive personnel” means the*  
19 *employees of a public school who have received training pursuant*  
20 *to section 9 of this act to provide assistance to a pupil with*  
21 *diabetes.*

22       **Sec. 8.** 1. *The board of trustees of a school district or a*  
23 *principal of a public school shall not:*

24       (a) *Prohibit any pupil with diabetes from enrolling in any*  
25 *public school in which the pupil would otherwise be able to enroll*  
26 *if the pupil did not have diabetes.*

27       (b) *Require the parent or legal guardian of a pupil with*  
28 *diabetes to provide any service or assistance to the pupil to care for*  
29 *or manage the diabetes while the pupil is on the grounds of a*  
30 *public school, participating in an activity sponsored by a public*  
31 *school or on a school bus.*

32       2. *The provisions of this section apply regardless of whether a*  
33 *public school has a school nurse or unlicensed assistive personnel.*

34       **Sec. 9.** 1. *Each school nurse shall prescribe a training*  
35 *program for employees of a public school who volunteer to*  
36 *become unlicensed assistive personnel for pupils. If a public*  
37 *school does not have a school nurse, the local health officer or the*  
38 *local health officer’s designee shall prescribe the training*  
39 *program.*

40       2. *The training program must provide instruction by the*  
41 *school nurse, the local health officer or the local health officer’s*  
42 *designee, as applicable, in accordance with nationally recognized*  
43 *standards and best practices for diabetes care, in:*

44       (a) *Recognizing the symptoms of hypoglycemia and*  
45 *hyperglycemia;*



1       (b) *The appropriate treatment for a pupil who exhibits the*  
2 *symptoms of hypoglycemia or hyperglycemia;*

3       (c) *Recognizing situations that require emergency medical*

7           (1) *Understanding the appropriate treatment for the pupil if*  
8 *the pupil's blood glucose level is not within the target range*  
9 *identified in the individualized health plan;*

10          (2) *Understanding instructions set forth in the*  
11 *individualized health plan concerning necessary medications;*

12          (3) *Performing blood glucose and ketone tests and*  
13 *recording the results of those tests;*

14          (4) *Administering insulin, glucagon or other medication*  
15 *and recording the results of the administration; and*

16          (5) *Understanding the relationship between the*  
17 *recommended diet of the pupil set forth in the individualized*  
18 *health plan and actions which may be taken if the recommended*  
19 *diet is not followed.*

20       **Sec. 10.** 1. *A parent or legal guardian of a pupil with*  
21 *diabetes may submit to the school nurse of the public school in*  
22 *which the pupil is enrolled or, if the public school does not have a*  
23 *school nurse, to the principal of the public school a request that*  
24 *the public school assist the pupil with the care and management of*  
25 *the diabetes while the pupil is on the grounds of a public school,*  
26 *participating in an activity sponsored by a public school or on a*  
27 *school bus.*

28       2. *Upon receipt of a request submitted pursuant to subsection*  
29 *1, the school nurse or, if the public school does not have a school*  
30 *nurse, the principal of the public school may provide written*  
31 *notice to employees of the public school seeking volunteers to*  
32 *serve as unlicensed assistive personnel at the public school. The*  
33 *written notice must include, without limitation:*

34           (a) *A description of the duties of unlicensed assistive*  
35 *personnel;*

36           (b) *A statement that serving as unlicensed assistive personnel*  
37 *is voluntary and that employees who choose not to volunteer will*  
38 *not be subject to any retaliatory or disciplinary action;*

39           (c) *A description of the training program prescribed pursuant*  
40 *to section 9 of this act that employees must complete to become*  
41 *unlicensed assistive personnel; and*

42           (d) *A statement that employees who serve as unlicensed*  
43 *assistive personnel are entitled to the immunity set forth in section*

1       3. *Employees who volunteer pursuant to subsection 2 must*  
2 *participate in and complete the training program prescribed*  
3 *pursuant to section 9 of this act to become unlicensed assistive*  
4 *personnel.*

5       4. *If the public school has unlicensed assistive personnel, the*  
6 *school nurse or the principal, as applicable, may:*

7       (a) *Authorize the unlicensed assistive personnel to provide*  
8 *assistance to the pupil whose parent or legal guardian submitted*  
9 *the request; and*

10       (b) *Notify the parent or legal guardian of the pupil of the*  
11 *approval and the requirements of sections 11.5 and 12 of this act.*

12       5. *If the public school does not have unlicensed assistive*  
13 *personnel, the school nurse or the principal, as applicable, may*  
14 *notify the parent or legal guardian of the pupil that the request*  
15 *cannot be accommodated at that time.*

16       **Sec. 11.** (Deleted by amendment.)

17       **Sec. 11.5.** *If a school nurse or principal of a public school*  
18 *approves a request pursuant to section 10 of this act, the school*  
19 *nurse or, if the public school does not have a school nurse, the*  
20 *local health officer or the local health officer's designee shall*  
21 *develop an individualized health plan for the pupil in coordination*  
22 *with the pupil's parent or legal guardian. The individualized*  
23 *health plan must be consistent with the diabetes treatment*  
24 *prescribed by the pupil's provider of health care and set forth the*  
25 *services the pupil requires to care for and manage diabetes.*

26       **Sec. 12.** *The parent or legal guardian of a pupil with*  
27 *diabetes, upon receiving approval of a request pursuant to section*  
28 *10 of this act, shall submit to the school nurse or, if the public*  
29 *school does not have a school nurse, the principal of the public*  
30 *school, on a form approved by the board of trustees of the school*  
31 *district and provided by the school, a signed statement of the*  
32 *parent or legal guardian authorizing:*

33       1. *The school nurse and unlicensed assistive personnel to*  
34 *provide assistance to the pupil to care for and manage the diabetes*  
35 *in accordance with the individualized health plan of the pupil*  
36 *while the pupil is on the grounds of a public school, participating*  
37 *in an activity sponsored by a public school or on a school bus; and*

38       2. *The school nurse or, if the public school does not have a*  
39 *school nurse, the principal to provide notice that the pupil has*  
40 *diabetes to each employee of the school who has primary*  
41 *responsibility for supervising the pupil and each driver of a school*  
42 *bus who transports the pupil to and from the public school or an*  
43 *activity sponsored by a public school.*

44       **Sec. 13.** *The school nurse or, if the public school does not*  
45 *have a school nurse, the principal of the public school, upon*



1 *receiving the authorization pursuant to section 12 of this act and*  
2 *the development of the individualized health plan of a pupil with*  
3 *diabetes pursuant to section 11.5 of this act, shall:*

4 *1. Notify each employee of the public school who has primary*  
5 *responsibility for supervising the pupil and each driver of a school*  
6 *bus who transports the pupil to and from the public school or to*  
7 *an activity sponsored by a public school that the pupil has*  
8 *diabetes.*

9 *2. Ensure that training is provided to each employee who has*  
10 *primary responsibility for supervising the pupil and each driver of*  
11 *a school bus in recognizing the symptoms of hypoglycemia and*  
12 *hyperglycemia and the proper treatment of a pupil who is*  
13 *hypoglycemic or hyperglycemic.*

14 *3. Ensure the presence of the school nurse or unlicensed*  
15 *assistive personnel during regular school hours and during all*  
16 *school sponsored activities to assist the pupil with the care and*  
17 *management of the diabetes in accordance with the individualized*  
18 *health plan of the pupil.*

19 *4. Ensure the provisions by the school nurse or unlicensed*  
20 *assistive personnel of the services set forth in the individualized*  
21 *health plan of the pupil to care for and manage the diabetes.*

22 **Sec. 14.** *Unlicensed assistive personnel, in assisting a pupil*  
23 *with diabetes in accordance with the individualized health plan of*  
24 *the pupil, may:*

25 *1. Test the blood glucose level of the pupil and record the*  
26 *result;*

27 *2. Test the ketone level of the pupil and record the result;*

28 *3. Treat a pupil whose blood glucose levels are not within the*  
29 *target range set forth in the individualized health plan;*

30 *4. Administer insulin, glucagon or other medication to the*  
31 *pupil in accordance with the individualized health plan;*

32 *5. Ensure that the pupil follows his or her recommended diet;*  
33 *and*

34 *6. Assist the pupil in performing any act described in this*  
35 *section.*

36 **Sec. 15.** *1. The parent or legal guardian of a pupil with*  
37 *diabetes who is enrolled in a public school may submit a written*  
38 *request to the school nurse of the public school or, if the public*  
39 *school does not have a school nurse, the principal of the public*  
40 *school to allow the pupil to self-administer medication for the*  
41 *treatment of the diabetes and otherwise care for and manage the*  
42 *diabetes while the pupil is on the grounds of a public school,*  
43 *participating in an activity sponsored by a public school or on a*  
44 *school bus, which may include, without limitation:*

45 *(a) Performing blood glucose tests;*

- 1 (b) *Administering insulin, glucagon or other medication;*
- 2 (c) *Treating hypoglycemia and hyperglycemia; and*
- 3 (d) *Otherwise attending to the care and management of the*
- 4 *diabetes.*

5 2. *A written request made pursuant to subsection 1 must*

6 *include:*

7 (a) *A signed statement of the pupil's provider of health care*

8 *indicating that the pupil has diabetes and is able to self-administer*

9 *the medication and otherwise care for and manage the diabetes*

10 *while the pupil is on the grounds of a public school, participating*

11 *in an activity sponsored by a public school or on a school bus; and*

12 (b) *A signed statement of the parent or legal guardian*

13 *indicating that the parent or legal guardian grants permission for*

14 *the pupil to self-administer the medication or otherwise care for*

15 *and manage the diabetes while the pupil is on the grounds of a*

16 *public school, participating in an activity sponsored by a public*

17 *school or on a school bus.*

18 3. *Upon receipt of a written request submitted pursuant to*

19 *subsection 1, the school nurse or the principal of the school, as*

20 *applicable, shall provide written authorization for the pupil to*

21 *carry and self-administer medication and otherwise care for and*

22 *manage the diabetes while the pupil is on the grounds of a public*

25 *the files of the public school and must include, without limitation:*

34 *health care and the name and telephone number of the person to*

35 *contact in case of a medical emergency concerning the pupil.*

36 4. *The written authorization provided pursuant to subsection*

37 *3 is valid for 1 school year but may be revoked at any time at the*

38 *discretion of the school nurse or the principal of the school, as*

39 *applicable, upon notification of the parent or legal guardian of the*

40 *pupil. If a parent or legal guardian submits a new written request*

41 *that complies with subsection 2, the school nurse or the principal*

12 *assistive personnel are entitled to the immunity set forth in section*  
13 *32 of this act.*

14 *3. Employees who volunteer pursuant to subsection 2 must*  
15 *participate in and complete the training program prescribed*  
16 *pursuant to section 24 of this act to become unlicensed assistive*  
17 *personnel.*

18 *4. If the private school has unlicensed assistive personnel, the*  
19 *school nurse, principal or other person in charge of the private*  
20 *school, as applicable, may:*

21 *(a) Authorize the unlicensed assistive personnel to provide*  
22 *assistance to the pupil whose parent or legal guardian submitted*  
23 *the request; and*

24 *(b) Notify the parent or legal guardian of the pupil of the*  
25 *approval and the requirements of sections 26.5 and 27 of this act.*

26 *5. If the private school does not have unlicensed assistive*  
27 *personnel, the school nurse, principal or other person in charge of*

32 **Sec. 26.5.** *If a school nurse, a principal or other person in*

4 *1. The school nurse and unlicensed assistive personnel to*  
5 *provide assistance to the pupil to care for and manage the diabetes*  
6 *in accordance with the individualized health plan of the pupil*  
7 *while the pupil is on the grounds of a private school, participating*  
8 *in an activity sponsored by a private school or on a school bus;*  
9 *and*

10 *2. The school nurse or, if the private school does not have a*  
11 *school nurse, the principal or other person in charge of the private*  
12 *school to provide notice that the pupil has diabetes to each*  
13 *employee of the school with primary responsibility for supervising*  
14 *the pupil and each driver of a school bus who transports the pupil*  
15 *to and from the private school or an activity sponsored by a private*  
16 *school.*

17 **Sec. 28.** *The school nurse or, if the private school does not*  
18 *have a school nurse, the principal or other person in charge of the*  
19 *private school, upon receiving the authorization pursuant to*  
20 *section 27 of this act and the development of the individualized*  
21 *health plan of a pupil with diabetes pursuant to section 26.5 of this*  
22 *act, shall:*

23 *1. Notify each employee who has primary responsibility for*

41 *with diabetes in accordance with the individualized health plan of*  
42 *the pupil, may:*

43 *1. Test the blood glucose level of the pupil and record the*

45 *2. Test the ketone level of the pupil and record the result;*



1       3. *Treat a pupil whose blood glucose levels are not within the*  
2 *target range set forth in the individualized health plan;*

3       4. *Administer insulin, glucagon or other medication to the*  
4 *pupil in accordance with the individualized health plan;*

5       5. *Ensure that the pupil follows his or her recommended diet;*  
6 *and*

7       6. *Assist the pupil in performing any act described in this*  
8 *section.*

9       **Sec. 30.** *1. The parent or legal guardian of a pupil with*  
10 *diabetes who is enrolled in a private school may submit a written*  
11 *request to the school nurse of the private school or, if the private*  
12 *school does not have a school nurse, the principal or other person*  
13 *in charge of the private school to allow the pupil to self-administer*  
14 *medication for the treatment of the diabetes and otherwise care for*  
15 *and manage the diabetes while the pupil is on the grounds of a*  
16 *private school, participating in an activity sponsored by a private*  
17 *school or on a school bus, which may include, without limitation:*

18       (a) *Performing blood glucose tests;*

19       (b) *Administering insulin, glucagon or other medication;*

20       (c) *Treating hypoglycemia and hyperglycemia; and*

21       (d) *Otherwise attending to the care and management of the*  
22 *diabetes.*

23       2. *A written request made pursuant to subsection 1 must*  
24 *include:*

25       (a) *A signed statement of the pupil's provider of health care*  
26 *indicating that the pupil has diabetes and is able to self-administer*  
27 *the medication and otherwise care for and manage the diabetes*  
28 *while the pupil is on the grounds of a private school, participating*

29 **Sec. 31.** 1. *The Board, in cooperation with the State Board*  
30 *of Nursing, shall adopt such regulations as it determines*  
31 *necessary to carry out the provisions of sections 19 to 32,*  
32 *inclusive, of this act.*

33 2. *The regulations must be substantially similar to the*  
34 *regulations adopted by the Board pursuant to section 16 of this*

36 **Sec. 32.** *School nurses, unlicensed assistive personnel and*  
37 *other school personnel, the governing body of a private school,*  
38 *local health officers and designees of local health officers are not*  
39 *subject to civil liability, and school nurses, unlicensed assistive*  
40 *personnel and other school personnel and local health officers*  
41 *and designees of local health officers are not subject to any*  
42 *disciplinary action, for any act performed by any person in*  
43 *carrying out any duty or authorized activity set forth in sections 19*  
44 *to 32, inclusive, of this act, or any regulation adopted pursuant*  
45 *thereto, if the act is performed in such a manner as an ordinarily*



1 *prudent person would reasonably perform the act under similar*  
2 *circumstances.*

3 **Sec. 33.** NRS 632.340 is hereby amended to read as follows:

4 632.340 The provisions of NRS 632.315 do not prohibit:

5 1. Gratuitous nursing by friends or by members of the family  
6 of a patient.

7 2. The incidental care of the sick by domestic servants or  
8 persons primarily employed as housekeepers as long as they do not  
9 practice nursing within the meaning of this chapter.

10 3. Nursing assistance in the case of an emergency.

11 4. The practice of nursing by students enrolled in accredited

40 9. *Unlicensed assistive personnel from assisting a pupil with*  
41 *diabetes in the care and management of the diabetes pursuant to*  
42 *the provisions of sections 3 to 17, inclusive, or sections 19 to 32,*  
43 *inclusive, of this act. As used in this subsection, "unlicensed*  
44 *assistive personnel" means employees of a public school or a*



1 *private school who have received training pursuant to section 9 or*  
2 *24 of this act to provide assistance to a pupil with diabetes.*

3 **10.** A natural person from providing supported living  
4 arrangement services if:

5 (a) That person has been issued a certificate pursuant to NRS  
6 435.3305 to 435.339, inclusive, and the regulations adopted  
7 pursuant to NRS 435.3305 to 435.339, inclusive; or

8 (b) That person is employed or retained as an independent  
9 contractor by a partnership, firm, corporation or association, state or  
10 local government or agency thereof that has been issued a certificate  
11 pursuant to NRS 435.3305 to 435.339, inclusive, and the regulations  
12 adopted pursuant to NRS 435.3305 to 435.339, inclusive.

13 ↪ As used in this subsection, “supported living arrangement  
14 services” has the meaning ascribed to it in NRS 435.3315.

15 **Sec. 34.** On or before January 1, 2014, the State Board of  
16 Education, in cooperation with the State Board of Nursing, shall  
17 adopt regulations pursuant to sections 16 and 31 of this act.

18 **Sec. 35.** This act becomes effective:

19 1. On July 1, 2013, for the purposes of adopting regulations  
20 and performing any preparatory administrative tasks necessary to  
21 carry out the provisions of this act; and

22 2. On January 1, 2014, for all other purposes.
