SUMMARY—Changes the term “mental retardation” to “intellectual disability” in NRS. (BDR 39-52)

EXPLANATION – Matter in *bolded italics* is new; matter between brackets ~~omitted material~~ is material to be omitted.

AN ACT relating to mental health; changing the term “mental retardation” to “intellectual disability” and related terms in a similar manner in the Nevada Revised Statutes; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law provides that it is the policy of this State that persons with
2 intellectual disabilities and persons with related conditions are referred to using
3 language which is commonly viewed as respectful and which refers to the person
4 before referring to his or her disability. (NRS 435.009) Existing law also
5 establishes that the term “persons with intellectual disabilities” is preferred and that
6 the terms “mental retardation” and “mentally retarded” are not preferred. (NRS
7 220.125) **Sections 1-119** of this bill replace the term “mental retardation” with
8 “intellectual disability,” replace the term “mentally retarded” with “intellectually
9 disabled” and change other similar words and terms in a similar manner. These
10 changes are intended to mirror changes made by the federal law commonly cited as
11 “Rosa’s Law.” (Pub. L. No. 111-256) **Section 120** of this bill provides that the
12 amendatory provisions of this bill shall be construed as nonsubstantive and that it
13 is not the intent of the Nevada Legislature to modify any existing application,
14 construction or interpretation of any statute which has been so amended.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. NRS 433.003 is hereby amended to read as follows:
433.003 The Legislature hereby declares that it is the intent of
this title:

1. To eliminate the forfeiture of any civil and legal rights of
any person and the imposition of any legal disability on any person,
based on an allegation of mental illness or ~~mental retardation~~
intellectual disability or a related condition, by any method other
than a separate judicial proceeding resulting in a determination of
incompetency, wherein the civil and legal rights forfeited and the
legal disabilities imposed are specifically stated; and

2. To charge the Division of Mental and Developmental
Services, and the Division of Child and Family Services, of the
Department with recognizing their duty to act in the best interests of
their respective consumers by placing them in the least restrictive
environment.

Sec. 2. NRS 433.014 is hereby amended to read as follows:

433.014 "Administrative officer" means a person with overall
executive and administrative responsibility for those state or
nonstate mental health or ~~mental retardation~~ *intellectual disability*
facilities designated by the Administrator.

Sec. 3. NRS 433.134 is hereby amended to read as follows:

433.134 "Medical director" means the chief medical officer of
any division mental health or ~~mental retardation~~ *intellectual*
disability program.

Sec. 4. NRS 433.174 is hereby amended to read as follows:

433.174 ~~"Mental retardation"~~ *"Intellectual disability"* means
significantly subaverage general intellectual functioning existing
concurrently with deficits in adaptive behavior and manifested
during the developmental period.

Sec. 5. NRS 433.184 is hereby amended to read as follows:

433.184 ~~"Mental retardation"~~ *"Intellectual disability"* center"
means an organized program for providing appropriate services and
treatment to persons with ~~mental retardation~~ *intellectual*
disabilities and persons with related conditions. ~~A mental~~
~~retardation~~ *An intellectual disability* center may include facilities
for residential treatment and training.

Sec. 6. NRS 433.211 is hereby amended to read as follows:

433.211 "Persons with related conditions" means persons who
have a severe, chronic disability which:

1. Is attributable to:

(a) Cerebral palsy or epilepsy; or



(b) Any other condition, other than mental illness, found to be closely related to ~~{mental-retardation}~~ *an intellectual disability* because the condition results in impairment of general intellectual functioning or adaptive behavior similar to that of a person with ~~{mental-retardation}~~ *an intellectual disability* and requires treatment or services similar to those required by a person with ~~{mental-retardation}~~ *an intellectual disability*;

2. Is manifested before the person affected attains the age of 22 years;

3. Is likely to continue indefinitely; and

4. Results in substantial functional limitations in three or more of the following areas of major life activity:

(a) Taking care of oneself;

(b) Understanding and use of language;

(c) Learning;

(d) Mobility;

(e) Self-direction; and

(f) Capacity for independent living.

Sec. 7. NRS 433.214 is hereby amended to read as follows:

433.214 "Training" means a program of services directed primarily toward enhancing the health, welfare and development of persons with ~~{mental-retardation}~~ *intellectual disabilities* and persons with related conditions through the process of providing those experiences that will enable the person to:

1. Develop his or her physical, intellectual, social and emotional capacities to the fullest extent;

2. Live in an environment that is conducive to personal dignity; and

3. Continue development of those skills, habits and attitudes essential to adaptation in contemporary society.

Sec. 8. NRS 433.233 is hereby amended to read as follows:

433.233 1. The division facilities providing mental health services are designated as:

(a) Northern Nevada Adult Mental Health Services;

(b) Southern Nevada Adult Mental Health Services;

(c) Rural clinics; and

(d) Lakes Crossing Center.

2. The division facilities providing services for persons with ~~{mental-retardation}~~ *intellectual disabilities* and persons with related conditions are designated as:

(a) Desert Regional Center;

(b) Sierra Regional Center; and

(c) Rural Regional Center.



3. Division facilities established after July 1, 1981, must be named by the Administrator, subject to the approval of the Director of the Department.

Sec. 9. NRS 433.244 is hereby amended to read as follows:

433.244 1. The Administrator must have:

(a) Training and demonstrated administrative qualities of leadership in any one of the professional fields of psychiatry, medicine, psychology, social work, education or administration; and

(b) Administrative training or experience in programs relating to mental health, including care, treatment or training, or any combination thereof, of persons with mental illness or ~~mental retardation~~ *intellectual disabilities* and persons with related conditions.

2. The Administrator is in the unclassified service of the State.

Sec. 10. NRS 433.279 is hereby amended to read as follows:

433.279 1. The Division shall carry out a vocational and educational program for the certification of ~~mental health mental retardation~~ *mental health-intellectual disability* technicians, including forensic technicians:

(a) Employed by the Division, or other employees of the Division who perform similar duties, but are classified differently.

(b) Employed by the Division of Child and Family Services of the Department.

➔ The program must be carried out in cooperation with the Nevada System of Higher Education.

2. A ~~mental health mental retardation~~ *mental health-intellectual disability* technician is responsible to the director of the service in which his or her duties are performed. The director of a service may be a licensed physician, dentist, podiatric physician, psychiatrist, psychologist, rehabilitation therapist, social worker, registered nurse or other professionally qualified person. This section does not authorize a ~~mental health mental retardation~~ *mental health-intellectual disability* technician to perform duties which require the specialized knowledge and skill of a professionally qualified person.

3. The Division shall adopt regulations to carry out the provisions of this section.

4. As used in this section, ~~“mental health mental retardation”~~ *“mental health-intellectual disability”* technician” means an employee of the Division of Mental Health and Developmental Services or the Division of Child and Family Services who, for compensation or personal profit, carries out procedures and techniques which involve cause and effect and which are used in the care, treatment and rehabilitation of persons with mental illness or ~~mental retardation~~ *intellectual disabilities*, persons who are



1 emotionally disturbed and persons with related conditions, and who
2 has direct responsibility for:

3 (a) Administering or carrying out specific therapeutic
4 procedures, techniques or treatments, excluding medical
5 interventions, to enable consumers to make optimal use of their
6 therapeutic regime, their social and personal resources, and their
7 residential care; or

8 (b) The application of interpersonal and technical skills in the
9 observation and recognition of symptoms and reactions of
10 consumers, for the accurate recording of such symptoms and
11 reactions, and for carrying out treatments authorized by members of
12 the interdisciplinary team that determines the treatment of the
13 consumers.

14 **Sec. 11.** NRS 433.314 is hereby amended to read as follows:

15 433.314 The Commission shall:

16 1. Establish policies to ensure adequate development and
17 administration of services for persons with mental illness, ~~mental~~
18 ~~retardation~~ *intellectual disabilities* or co-occurring disorders and
19 persons with related conditions, including services to prevent mental
20 illness, ~~mental-retardation~~ *intellectual disabilities* and co-
21 occurring disorders and related conditions, and services provided
22 without admission to a facility or institution;

23 2. Set policies for the care and treatment of persons with
24 mental illness, ~~mental-retardation~~ *intellectual disabilities* or co-
25 occurring disorders and persons with related conditions provided by
26 all state agencies;

27 3. Review the programs and finances of the Division; and

28 4. Report at the beginning of each year to the Governor and at
29 the beginning of each odd-numbered year to the Legislature on the
30 quality of the care and treatment provided for persons with mental
31 illness, ~~mental-retardation~~ *intellectual disabilities* or co-occurring
32 disorders and persons with related conditions in this State and on
33 any progress made toward improving the quality of that care and
34 treatment.

35 **Sec. 12.** NRS 433.316 is hereby amended to read as follows:

36 433.316 The Commission may:

37 1. Collect and disseminate information pertaining to mental
38 health, ~~mental-retardation~~ *intellectual disabilities* and co-occurring
39 disorders and related conditions.

40 2. Request legislation pertaining to mental health, ~~mental~~
41 ~~retardation~~ *intellectual disabilities* and co-occurring disorders and
42 related conditions.

43 3. Investigate complaints about the care of any person in a
44 public facility for the treatment of persons with mental illness,



1 ~~{mental-retardation}~~ *intellectual disabilities* or co-occurring
2 disorders and persons with related conditions.

3 4. Accept, as authorized by the Legislature, gifts and grants of
4 money and property.

5 5. Take appropriate steps to increase the availability of and to
6 enhance the quality of the care and treatment of persons with mental
7 illness, ~~{mental-retardation}~~ *intellectual disabilities* or co-occurring
8 disorders and persons with related conditions provided through state
9 agencies, hospitals and clinics.

10 6. Promote programs for the treatment of persons with mental
11 illness, ~~{mental-retardation}~~ *intellectual disabilities* or co-occurring
12 disorders and persons with related conditions and participate in and
13 promote the development of facilities for training persons to provide
14 services for persons with mental illness, ~~{mental-retardation}~~
15 *intellectual disabilities* or co-occurring disorders and persons with
16 related conditions.

17 7. Create a plan to coordinate the services for the treatment of
18 persons with mental illness, ~~{mental-retardation}~~ *intellectual*
19 *disabilities* or co-occurring disorders and persons with related
20 conditions provided in this State and to provide continuity in the
21 care and treatment provided.

22 8. Establish and maintain an appropriate program which
23 provides information to the general public concerning mental
24 illness, ~~{mental-retardation}~~ *intellectual disabilities* and co-
25 occurring disorders and related conditions and consider ways to
26 involve the general public in the decisions concerning the policy on
27 mental illness, ~~{mental-retardation}~~ *intellectual disabilities* and co-
28 occurring disorders and related conditions.

29 9. Compile statistics on mental illness and study the cause,
30 pathology and prevention of that illness.

31 10. Establish programs to prevent or postpone the commitment
32 of residents of this State to facilities for the treatment of persons
33 with mental illness, ~~{mental-retardation}~~ *intellectual disabilities* or
34 co-occurring disorders and persons with related conditions.

35 11. Evaluate the future needs of this State concerning the
36 treatment of mental illness, ~~{mental-retardation}~~ *intellectual*
37 *disabilities* and co-occurring disorders and related conditions and
38 develop ways to improve the treatment already provided.

39 12. Take any other action necessary to promote mental health
40 in this State.

41 **Sec. 13.** NRS 433.318 is hereby amended to read as follows:

42 433.318 1. The Commission may appoint a subcommittee or
43 an advisory committee composed of members who have experience
44 and knowledge of matters relating to persons with mental illness,
45 ~~{mental-retardation}~~ *intellectual disabilities* or co-occurring



1 disorders and related conditions and who, to the extent practicable,
2 represent the ethnic and geographic diversity of this State.

3 2. A subcommittee or advisory committee appointed pursuant
4 to this section shall consider specific issues and advise the
5 Commission on matters related to the duties of the Commission.

6 3. The members of a subcommittee or advisory committee
7 appointed pursuant to this section serve at the pleasure of the
8 Commission. The members serve without compensation, except that
9 each member is entitled, while engaged in the business of the
10 subcommittee or advisory committee, to the per diem allowance and
11 travel expenses provided for state officers and employees generally
12 if funding is available for this purpose.

13 **Sec. 14.** NRS 433.324 is hereby amended to read as follows:

14 433.324 1. The Commission shall adopt regulations:

15 (a) For the care and treatment of persons with mental illness,
16 ~~{mental-retardation}~~ *intellectual disabilities* or co-occurring
17 disorders and persons with related conditions by all state agencies
18 and facilities, and their referral to private facilities;

19 (b) To ensure continuity in the care and treatment provided to
20 persons with mental illness, ~~{mental-retardation}~~ *intellectual*
21 *disabilities* or co-occurring disorders and persons with related
22 conditions in this State; and

23 (c) Necessary for the proper and efficient operation of the
24 facilities of the Division.

25 2. The Commission may adopt regulations to promote
26 programs relating to mental health, ~~{mental-retardation}~~ *intellectual*
27 *disabilities* and co-occurring disorders and related conditions.

28 **Sec. 15.** NRS 433.325 is hereby amended to read as follows:

29 433.325 The Commission or its designated agent may inspect
30 any state facility providing services for persons with mental illness,
31 ~~{mental-retardation}~~ *intellectual disabilities* or co-occurring
32 disorders and persons with related conditions to determine if the
33 facility is in compliance with the provisions of this title and any
34 regulations adopted pursuant to those provisions.

35 **Sec. 16.** NRS 433.334 is hereby amended to read as follows:

36 433.334 The Division may, by contract with general hospitals
37 or other institutions having adequate facilities in the State of
38 Nevada, provide for inpatient care of consumers with mental illness
39 or ~~{mental-retardation}~~ *intellectual disabilities* and consumers with
40 related conditions.

41 **Sec. 17.** NRS 433.344 is hereby amended to read as follows:

42 433.344 The Division may contract with appropriate persons
43 professionally qualified in the field of psychiatric mental health to
44 provide inpatient and outpatient care for persons with mental illness
45 or ~~{mental-retardation}~~ *intellectual disabilities* and persons with



1 related conditions when it appears that they can be treated best in
2 that manner.

3 **Sec. 18.** NRS 433.395 is hereby amended to read as follows:

4 433.395 1. Upon approval of the Director of the Department,
5 the Administrator may accept:

6 (a) Donations of money and gifts of real or personal property;
7 and

8 (b) Grants of money from the Federal Government,
9 ➔ for use in public or private programs that provide services to
10 persons in this State with mental illness or ~~mental retardation~~
11 *intellectual disabilities* and persons with related conditions.

12 2. The Administrator shall disburse any donations, gifts and
13 grants received pursuant to this section to programs that provide
14 services to persons with mental illness or ~~mental retardation~~
15 *intellectual disabilities* and persons with related conditions in a
16 manner that supports the plan to coordinate services created by the
17 Commission pursuant to subsection 7 of NRS 433.316. In the
18 absence of a plan to coordinate services, the Administrator shall
19 make disbursements to programs that will maximize the benefit
20 provided to persons with mental illness or ~~mental retardation~~
21 *intellectual disabilities* and persons with related conditions in
22 consideration of the nature and value of the donation, gift or grant.

23 3. Within limits of legislative appropriations or other available
24 money, the Administrator may enter into a contract for services
25 related to the evaluation and recommendation of recipients for the
26 disbursements required by this section.

27 **Sec. 19.** NRS 433.404 is hereby amended to read as follows:

28 433.404 1. The Division shall establish a fee schedule for
29 services rendered through any program supported by the State
30 pursuant to the provisions of chapters 433 to 436, inclusive, of NRS.
31 The schedule must be submitted to the Commission and the Director
32 of the Department for joint approval before enforcement. The fees
33 collected by facilities operated by the Division pursuant to this
34 schedule must be deposited in the State Treasury to the credit of the
35 State General Fund, except as otherwise provided in NRS 433.354
36 for fees collected pursuant to contract or agreement and in NRS
37 435.120 for fees collected for services to consumers with ~~mental~~
38 ~~retardation~~ *intellectual disabilities* and related conditions.

39 2. For a facility providing services for the treatment of persons
40 with mental illness or ~~mental retardation~~ *intellectual disabilities*
41 and persons with related conditions, the fee established must
42 approximate the cost of providing the service, but if a consumer is
43 unable to pay in full the fee established pursuant to this section, the
44 Division may collect any amount the consumer is able to pay.



Sec. 20. NRS 433.424 is hereby amended to read as follows:

433.424 A mental health and ~~mental retardation~~ *intellectual disability* center revolving account up to the amount of \$5,000 is hereby created for each division mental health and ~~mental retardation~~ *intellectual disability* center, and may be used for the payment of mental health or ~~mental retardation~~ *intellectual disability* center bills requiring immediate payment and for no other purposes. The respective administrative officers shall deposit the money for the respective revolving accounts in one or more banks or credit unions of reputable standing. Payments made from each account must be promptly reimbursed from appropriated money of the respective mental health or ~~mental retardation~~ *intellectual disability* centers on claims as other claims against the State are paid.

Sec. 21. NRS 433.444 is hereby amended to read as follows:

433.444 1. For the purpose of facilitating the return of nonresident consumers to the state in which they have legal residence, the Administrator may enter into reciprocal agreements, consistent with the provisions of this title, with the proper boards, commissioners or officers of other states for the mutual exchange of consumers confined in, admitted or committed to a mental health or ~~mental retardation~~ *intellectual disability* facility in one state whose legal residence is in the other, and may give written permission for the return and admission to a division facility of any resident of this state when such permission is conformable to the provisions of this title governing admissions to a division facility.

2. The county clerk and board of county commissioners of each county, upon receiving notice from the Administrator that an application for the return of an alleged resident of this state has been received, shall promptly investigate and report to the Administrator their findings as to the legal residence of the consumer.

Sec. 22. NRS 433.458 is hereby amended to read as follows:

433.458 "Administrative officer" means a person with overall executive and administrative responsibility for a facility that provides services relating to mental health or ~~mental retardation~~ *intellectual disabilities* and related conditions and that is operated by any public or private entity.

Sec. 23. NRS 433.494 is hereby amended to read as follows:

433.494 1. An individualized written plan of mental health or ~~mental retardation~~ *intellectual disability* services or plan of services for a related condition must be developed for each consumer of each facility. The plan must:

(a) Provide for the least restrictive treatment procedure that may reasonably be expected to benefit the consumer; and

(b) Be developed with the input and participation of:

(1) The consumer, to the extent that he or she is able to provide input and participate; and

(2) To the extent that the consumer is unable to provide input and participate, the parent or guardian of the consumer if the consumer is under 18 years of age and is not legally emancipated, or the legal guardian of a consumer who has been adjudicated mentally incompetent.

2. The plan must be kept current and must be modified, with the input and participation of the consumer, the parent or guardian of the consumer or the legal guardian of the consumer, as appropriate, when indicated. The plan must be thoroughly reviewed at least once every 3 months.

3. The person in charge of implementing the plan of services must be designated in the plan.

Sec. 24. NRS 433A.012 is hereby amended to read as follows:

433A.012 "Administrative officer" means a person with overall executive and administrative responsibility for those state or nonstate facilities for mental health or ~~mental-retardation~~ *intellectual disabilities* designated by the Administrator.

Sec. 25. NRS 433A.020 is hereby amended to read as follows:

433A.020 The administrative officer of a facility of the Division must:

1. Be selected on the basis of training and demonstrated administrative qualities of leadership in any one of the fields of psychiatry, medicine, psychology, social work, education or administration.

2. Be appointed on the basis of merit as measured by administrative training or experience in programs relating to mental health, including care and treatment of persons with mental illness or ~~mental-retardation~~ *intellectual disabilities* and persons with related conditions.

3. Have additional qualifications which are in accordance with criteria prescribed by the Division of Human Resource Management of the Department of Administration.

Sec. 26. NRS 433A.115 is hereby amended to read as follows:

433A.115 1. As used in NRS 433A.115 to 433A.330, inclusive, unless the context otherwise requires, "person with mental illness" means any person whose capacity to exercise self-control, judgment and discretion in the conduct of the person's affairs and social relations or to care for his or her personal needs is diminished, as a result of a mental illness, to the extent that the person presents a clear and present danger of harm to himself or herself or others, but does not include any person in whom that capacity is diminished by epilepsy, ~~mental-retardation,~~ *intellectual disability*, dementia, delirium, brief periods of intoxication caused by alcohol or drugs, or



1 dependence upon or addiction to alcohol or drugs, unless a mental
2 illness that can be diagnosed is also present which contributes to the
3 diminished capacity of the person.

4 2. A person presents a clear and present danger of harm to
5 himself or herself if, within the immediately preceding 30 days, the
6 person has, as a result of a mental illness:

7 (a) Acted in a manner from which it may reasonably be inferred
8 that, without the care, supervision or continued assistance of others,
9 the person will be unable to satisfy his or her need for nourishment,
10 personal or medical care, shelter, self-protection or safety, and if
11 there exists a reasonable probability that the person's death, serious
12 bodily injury or physical debilitation will occur within the next
13 following 30 days unless he or she is admitted to a mental health
14 facility pursuant to the provisions of NRS 433A.115 to 433A.330,
15 inclusive, and adequate treatment is provided to the person;

16 (b) Attempted or threatened to commit suicide or committed
17 acts in furtherance of a threat to commit suicide, and if there exists a
18 reasonable probability that the person will commit suicide unless he
19 or she is admitted to a mental health facility pursuant to the
20 provisions of NRS 433A.115 to 433A.330, inclusive, and adequate
21 treatment is provided to the person; or

22 (c) Mutilated himself or herself, attempted or threatened to
23 mutilate himself or herself or committed acts in furtherance of a
24 threat to mutilate himself or herself, and if there exists a reasonable
25 probability that he or she will mutilate himself or herself unless the
26 person is admitted to a mental health facility pursuant to the
27 provisions of NRS 433A.115 to 433A.330, inclusive, and adequate
28 treatment is provided to the person.

29 3. A person presents a clear and present danger of harm to
30 others if, within the immediately preceding 30 days, the person has,
31 as a result of a mental illness, inflicted or attempted to inflict serious
32 bodily harm on any other person, or made threats to inflict harm and
33 committed acts in furtherance of those threats, and if there exists a
34 reasonable probability that he or she will do so again unless the
35 person is admitted to a mental health facility pursuant to the
36 provisions of NRS 433A.115 to 433A.330, inclusive, and adequate
37 treatment is provided to him or her.

38 **Sec. 27.** NRS 435.005 is hereby amended to read as follows:

39 435.005 Unless specifically excluded by law, the provisions of
40 this chapter apply to all facilities within the Division offering
41 services to persons with ~~mental retardation~~ *intellectual disabilities*
42 and persons with related conditions.

43 **Sec. 28.** NRS 435.007 is hereby amended to read as follows:

44 435.007 As used in this chapter, unless the context otherwise
45 requires:



1 1. "Child" means any person under the age of 18 years who
2 may be eligible for ~~mental retardation~~ *intellectual disability*
3 services or services for a related condition.

4 2. "Parent" means the parent of a child. The term does not
5 include the parent of a person who has attained the age of 18 years.

6 3. "Person" includes a child and any other consumer with
7 ~~mental retardation~~ *an intellectual disability* or a related condition
8 who has attained the age of 18 years.

9 4. "Residential facility for groups" means a structure similar to
10 a private residence which will house a small number of persons in a
11 homelike atmosphere.

12 **Sec. 29.** NRS 435.010 is hereby amended to read as follows:

13 435.010 1. The boards of county commissioners of the
14 various counties shall make provision for the support, education and
15 care of the children with ~~mental retardation~~ *intellectual disabilities*
16 and children with related conditions of their respective counties.

17 2. For that purpose, they are empowered to make all necessary
18 contracts and agreements to carry out the provisions of this section
19 and NRS 435.020 and 435.030. Any such contract or agreement
20 may be made with any responsible person or facility in or without
21 the State of Nevada.

22 3. The provisions of this section and NRS 435.020 and 435.030

If the Supreme Court entertains the appeal, or if it otherwise appears necessary, it may enter an order staying the trial for such time as may be required.

3. The defendant only may appeal from a final judgment or verdict in a criminal case.
