SUMMARY—Revises provisions relating to charter schools.

AN ACT relating to charter schools; authorizing the Director of the Department of Business and Industry to issue bonds, notes and other obligations to finance the acquisition, construction, improvement, restoration or rehabilitation of property, buildings and facilities for charter schools; establishing the procedure for the issuance of such obligations; providing for the payment of the obligations; revising provisions relating to the closure of a charter school and the payment of its debts; authorizing a charter school to incorporate as a nonprofit corporation, borrow money and encumber its assets; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

This bill authorizes the Director of the Department of Business and Industry to issue bonds and other obligations to finance the acquisition, construction, improvement, restoration or rehabilitation of property, buildings and facilities for charter schools. **Sections 1-22** of this bill enact the Charter School Financing Law and provide for the issuance of such obligations by the Director.

Section 29 of this bill revises provisions governing the closure of a charter school to provide, among other things, for notice of the closure, the development of a plan for closure, an audit and the winding up of the financial affairs of the charter school. **Section 30** of this bill authorizes a charter school to incorporate as a nonprofit corporation. **Section 31** of this bill authorizes a charter school to borrow money and encumber its property and other assets, and to use public money to purchase property with the approval of the charter school's sponsor.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Chapter 386 of NRS is hereby amended by adding thereto the provisions set forth as sections 2 to 22, inclusive, of this act.

Sec. 2. *Sections 2 to 22, inclusive, of this act may be cited as the Charter School Financing Law.*

Sec. 3. *As used in sections 2 to 22, inclusive, of this act, unless the context otherwise requires, the words and terms defined in sections 4 to 8, inclusive, of this act have the meanings ascribed to them in those sections.*

Sec. 4. *“Bond” or “revenue bond” means any bond, note, security or other evidence of indebtedness issued pursuant to sections 2 to 22, inclusive, of this act.*

Sec. 4.3. *“Cost of the project” means all or a designated part of the cost of any project, including any incidental cost pertaining to the project. The cost of a project may include, without limitation, the costs of:*

1. Surveys, audits, preliminary plans, other plans, specifications, estimates and other costs of preparations;

2. Appraising, printing, estimating, advice and services of engineers, architects, financial consultants, attorneys, clerical personnel and other agents and employees;

3. Publishing, posting, mailing and otherwise giving notice, filing or recording instruments, taking options and fees to banks;

4. Establishment of a reserve for contingencies;

5. Interest on bonds for any time which does not exceed the estimated period of construction plus 1 year, discounts on bonds, reserves for the payment of the principal of and interest on bonds, replacement expenses and other costs of issuing bonds;

6. Amending any resolution or other instrument authorizing the issuance of, or otherwise relating to, bonds for the project; and

7. Short-term financing and the expense of operation and maintenance of the project.

Sec. 4.5. *“Director of the Department of Business and Industry” means the Director of the Department of Business and Industry or any person within the Department of Business and Industry designated by the Director to perform duties in connection with a project or the issuance of bonds pursuant to sections 2 to 22, inclusive, of this act.*

Sec. 4.7. *“Expense of operation and maintenance” means any reasonable and necessary expense of the State for the operation, maintenance and administration of a project or of the*

1 *collection and administration of revenues from a project and*
2 *includes, without limitation:*

3 1. *Expenses for engineering, auditing, reporting, legal*
4 *services and other expenses of the Director of the Department of*
5 *Business and Industry which are directly related to the*
6 *administration of projects.*

7 2. *Premiums for fidelity bonds and policies of property and*
8 *liability insurance pertaining to projects, and shares of the*
9 *premiums of blanket bonds and policies which may be reasonably*
10 *allocated to the State.*

11 3. *Payments to pension, retirement, health insurance and*
12 *other insurance funds.*

13 4. *Reasonable charges made by any paying agent,*
14 *commercial bank, credit union, trust company or other depository*
15 *bank pertaining to bonds issued pursuant to sections 2 to 22,*
16 *inclusive, of this act.*

17 5. *Services rendered under the terms of a contract, services of*
18 *professionally qualified persons, salaries, administrative expenses*
19 *and the cost of materials, supplies and labor pertaining to the*
20 *issuance of any bonds pursuant to sections 2 to 22, inclusive, of*
21 *this act, including the expenses of any trustee, receiver or other*
22 *fiduciary.*

23 6. *Costs incurred in the collection and any refund of*
24 *revenues from a project, including the amount of the refund.*

25 7. *Fees and costs incurred by the Director of the Department*
26 *of Business and Industry for ensuring compliance with the*
27 *provisions of sections 2 to 22, inclusive, of this act.*

28 **Sec. 5.** *“Finance” or “financing” includes, without*
29 *limitation, the issuance of bonds by the Director of the*
30 *Department of Business and Industry for the purpose of using all*
31 *or any part of the proceeds to pay for or to reimburse a user or the*
32 *designee of a user for the cost of acquiring, improving or*
33 *equipping the facilities of a project, or to provide money for the*
34 *project itself, where appropriate, whether these costs are incurred*
35 *by the obligor or a designee of the obligor.*

36 **Sec. 5.5.** *“Financing agreement” means an agreement by*
37 *which the Director of the Department of Business and Industry*
38 *agrees to issue bonds pursuant to sections 2 to 22, inclusive, of this*
39 *act to finance one or more projects and the obligor agrees to:*

40 1. *Make payments directly or through notes, debentures,*
41 *bonds or other secured or unsecured debt obligations of the*
42 *obligor executed and delivered by the obligor to the Director or his*
43 *or her designee or assignee, including a trustee, sufficient to pay*
44 *the principal of, premium, if any, and interest on the bonds;*



2. *Pay other amounts required by sections 2 to 22, inclusive, of this act; and*

3. *Comply with all the applicable provisions of sections 2 to 22, inclusive, of this act.*

Sec. 6. *"Mortgage" means a mortgage, trust deed or other security device.*

Sec. 6.5. *"Obligor" means a charter school, natural person, partnership, firm, company, corporation, association, trust, estate, political subdivision, state agency or any other legal entity, or its legal representative, agent or assigns, who agrees to make the payments required by a financing agreement.*

Sec. 7. *"Project" means:*

1. *Any building, structure or real property owned, to be acquired or used by a charter school for any of its educational purposes and all related appurtenances, easements, rights-of-way, improvements, paving, utilities, landscaping and parking facilities, together with all the personal property necessary, convenient or appurtenant thereto; or*

2. *Any capital equipment owned, to be acquired or used by a charter school for any of its educational purposes.*

Sec. 7.5. *"Revenues" includes, with respect to a project, payments under a lease, agreement of sale or financing agreement, or under notes, debentures, bonds and other secured or unsecured debt obligations of an obligor executed and delivered by the obligor to the Director of the Department of Business and Industry or his or her designee or assignee, including a trustee, pursuant to a lease, agreement of sale or financing agreement, or under any guarantee of or insurance with respect to any such lease, agreement of sale or financing agreement.*

Sec. 8. (Deleted by amendment.)

Sec. 8.1. 1. *It is the intent of the Legislature to authorize the Director of the Department of Business and Industry to finance facilities or other improvements to be owned, acquired and used by a charter school for any of its educational purposes.*

2. *The Director of the Department of Business and Industry has all the powers necessary to accomplish the purposes set forth in sections 2 to 22, inclusive, of this act, but these powers must be exercised for the health, safety, convenience, prosperity and welfare of the inhabitants of this State.*

3. *Sections 2 to 22, inclusive, of this act must be liberally construed in conformity with the purposes set forth in this section.*

Sec. 8.3. *When the Director of the Department of Business and Industry has received requests from one or more charter schools, lessees, purchasers or other obligors, the Director may issue revenue bonds to obtain money to fulfill the requests. Title to*



1 or in a project may at all times remain in the obligor or the
2 obligor's designee or assignee and, in that case, the bonds must be
3 secured by a pledge of one or more notes, debentures, bonds or
4 other secured or unsecured debt obligations of the obligor.

5 **Sec. 8.5.** *Except as otherwise provided in section 9.9 of this*
6 *act, the Director of the Department of Business and Industry shall*
7 *not finance a project unless, before financing the project, the*
8 *Director finds and the State Board of Finance approves the*
9 *findings of the Director that:*

10 1. *The project consists of any land, building or other*
11 *improvement, and all real and personal properties necessary in*
12 *connection therewith, which is suitable for new construction,*
13 *improvement, restoration or rehabilitation of charter school*
14 *facilities;*

15 2. *The charter school for whose benefit the project is being*
16 *financed is not in default under the written charter granted by its*
17 *sponsor, as determined by the sponsor;*

18 3. *There are sufficient safeguards to ensure that all money*
19 *provided by the Director of the Department of Business and*
20 *Industry will be expended solely for the purposes of the project;*

21 4. *There are sufficient safeguards to ensure that the Director*
22 *of the Department of Business and Industry will have the ability to*
23 *monitor compliance with the provisions of sections 2 to 22,*
24 *inclusive, of this act on an ongoing basis with respect to the*
25 *project;*

26 5. *Through the advice of counsel or other reliable source, the*
27 *project has received all approvals by the local, state and federal*
28 *governments which may be necessary to proceed with*
29 *construction, improvement, rehabilitation or redevelopment of the*
30 *project; and*

31 6. *There has been a request by a charter school, lessee,*
32 *purchaser or other obligor to have the Director of the Department*
33 *of Business and Industry issue bonds to finance the project.*

34 **Sec. 8.7.** 1. *Except as otherwise provided in section 9.9 of*
35 *this act, before financing a project pursuant to section 8.5 of this*
36 *act, the Director of the Department of Business and Industry and*
37 *the State Board of Finance must:*

38 (a) *Determine the total amount of money necessary to be*
39 *provided by the Director of the Department of Business and*
40 *Industry for financing the project.*

41 (b) *Except as otherwise provided in this subsection, receive a*
42 *5-year operating history from the contemplated charter school,*
43 *lessee, purchaser or other obligor that will make or guarantee the*
44 *payment of the principal, premium, if any, and interest on any*
45 *bond issued. An operating history is not required if the bonds:*



1 (1) Are to be sold only to qualified institutional buyers, as
2 defined in Rule 144A of the Securities and Exchange Commission,
3 17 C.F.R. § 230.144A, in minimum denominations of at least
4 \$100,000; or

5 (2) Will receive a rating within one of the top four rating
6 categories of Moody's Investors Service, Inc., Standard and
7 Poor's Rating Services or Fitch IBCA, Inc.

8 (c) Consider whether the contemplated charter school, lessee,
9 purchaser or other obligor that will make or guarantee the
10 payment of the principal, premium, if any, and interest on any
11 bonds issued has received within the 12 months immediately
12 preceding the date of the findings of the Director of the
13 Department of Business and Industry, or then has or has not in
14 effect, a rating within one of the top four rating categories of
15 Moody's Investors Service, Inc., Standard and Poor's Rating
16 Services or Fitch IBCA, Inc.

17 (d) Consider the extent to which the project is affected by any
18 federal, state or local governmental action, activity, program or
19 development.

20 (e) Consider the length of time the charter school, lessee,
21 purchaser or other obligor of the project has maintained facilities
22 appropriate to the community in this State.

23 2. The Director of the Department of Business and Industry
24 may adopt regulations to set forth additional factors to be
25 considered by the Director and the State Board of Finance before
26 financing a project pursuant to section 8.5 of this act.

27 **Sec. 8.9.** 1. The Director of the Department of Business
28 and Industry may provide financing for a project pursuant to
29 sections 2 to 22, inclusive, of this act if:

30 (a) The financing is limited in amount and purpose to the
31 payment of the costs associated with:

32 (1) The acquisition, construction, improvement, restoration
33 or rehabilitation of the project; and

34 (2) The cost of the project;

35 (b) The Director makes the findings required by section 8.5 of
36 this act; and

37 (c) The Director complies with the guidelines established by
38 the Director pursuant to subsection 2.

39 2. The Director of the Department of Business and Industry
40 shall establish guidelines for the provision of financing for a
41 project pursuant to sections 2 to 22, inclusive, of this act.

42 **Sec. 9.** (Deleted by amendment.)

43 **Sec. 9.1.** 1. All bonds issued by the Director of the
44 Department of Business and Industry pursuant to sections 2 to 22,
45 inclusive, of this act are special, limited obligations of the State.



1 *The principal of and interest on such bonds are payable, subject to*
2 *the security provisions of sections 2 to 22, inclusive, of this act,*
3 *solely out of the revenues derived from the financing, leasing or*
4 *sale of the project or projects to be financed by the bonds.*

5 *2. The bonds and interest coupons, if any, which are part of*
6 *those bonds do not constitute the debt or indebtedness of the State*
7 *or any city or county within the meaning of any provision or*
8 *limitation of the Constitution of the State of Nevada or statutes,*
9 *and do not constitute or give rise to a pecuniary liability of the*
10 *State or a charge against its general credit or taxing powers. This*
11 *limitation must be plainly stated on the face of each bond.*

12 **Sec. 9.3.** *1. Any bonds issued pursuant to sections 2 to 22,*
13 *inclusive, of this act must be authorized by an order of the*
14 *Director of the Department of Business and Industry and must:*

- 15 *(a) Be in denominations;*
16 *(b) Bear the date or dates;*
17 *(c) Mature at the time or times, not exceeding 40 years after*
18 *their respective dates;*
19 *(d) Bear interest at a rate or rates;*
20 *(e) Be in the form;*
21 *(f) Carry the registration privileges;*
22 *(g) Be executed in the manner;*
23 *(h) Be payable at the place or places within or without the*
24 *State; and*

25 *(i) Be subject to the terms of redemption,*
26 *↪ as provided by the order authorizing their issuance.*

27 *2. Any bonds issued pursuant to sections 2 to 22, inclusive, of*
28 *this act may be sold in one or more series at par, or below or above*
29 *par, in the manner and for the price or prices which the Director*
30 *of the Department of Business and Industry determines in his or*
31 *her discretion, and are not required to obtain a credit rating. As an*
32 *incidental expense to any project to be financed by the bonds, the*
33 *Director may employ financial and legal consultants in regard to*
34 *the financing of the project on an ongoing basis.*

35 *3. Any bonds issued pursuant to sections 2 to 22, inclusive, of*
36 *this act are fully negotiable under the terms of the Uniform*
37 *Commercial Code—Investment Securities.*

38 **Sec. 9.5.** *The principal of, the interest on and any prior*
39 *redemption premiums due in connection with the bonds issued*
40 *pursuant to sections 2 to 22, inclusive, of this act are payable*
41 *from, secured by a pledge of, and constitute a lien on the revenues*
42 *out of which the bonds have been made payable. In addition, they*
43 *may, in the discretion of the Director of the Department of*
44 *Business and Industry, be secured by:*



1 1. A mortgage or mortgages covering all or part of any
2 project financed with the proceeds of the bonds, or upon any other
3 property of the lessees, purchasers or obligors of those projects, or
4 by a pledge of the lease, the agreement of sale or the financing
5 agreement with respect to one or more of the projects, or both.

6 2. A pledge of one or more notes, debentures, bonds or other
7 secured or unsecured debt obligations of the obligor of one or
8 more of the projects.

9 3. The proceeds of the bonds and income from investment of
10 the proceeds and of revenues.

11 **Sec. 9.7.** *The Director of the Department of Business and*
12 *Industry shall adopt regulations to carry out the provisions of*
13 *sections 2 to 22, inclusive, of this act, including, without*
14 *limitation, regulations for:*

15 1. *Investment and reinvestment of the proceeds from the sale*
16 *of the bonds, including, without limitation:*

17 (a) *Bonds or other obligations of the United States of America.*

18 (b) *Bonds or other obligations, the payment of the principal*
19 *and interest of which is unconditionally guaranteed by the United*
20 *States of America.*

21 (c) *Obligations issued or guaranteed as to principal and*
22 *interest by any agency or person controlled or supervised by and*
23 *acting as an instrumentality of the United States of America*
24 *pursuant to authority granted by the Congress of the United States*
25 *of America.*

26 (d) *Obligations issued or guaranteed by any state of the United*
27 *States of America, or any political subdivision of any state.*

28 (e) *Prime commercial paper.*

29 (f) *Prime finance company paper.*

30 (g) *Bankers' acceptances drawn on and accepted by*
31 *commercial banks.*

32 (h) *Repurchase agreements fully secured by obligations issued*
33 *or guaranteed as to principal and interest by the United States of*
34 *America or by any person controlled or supervised by and acting*
35 *as an instrumentality of the United States of America pursuant to*
36 *authority granted by the Congress of the United States of America.*

37 (i) *Certificates of deposit issued by credit unions or*
38 *commercial banks, including banks domiciled outside of the*
39 *United States of America.*

40 (j) *Money market mutual funds that:*

41 (1) *Are registered with the Securities and Exchange*
42 *Commission;*

43 (2) *Are rated by a nationally recognized rating service as*
44 *"AAA" or its equivalent; and*

1 (3) *Invest only in securities issued or guaranteed as to*
2 *payment of principal and interest by the Federal Government, or*
3 *its agencies or instrumentalities, or in repurchase agreements that*
4 *are fully collateralized by such securities.*

5 2. *Receiving, holding and disbursing of proceeds of the sale*
6 *of bonds by one or more banks, credit unions or trust companies*
7 *located within or without this State.*

8 **Sec. 9.9.** 1. *Any bonds issued pursuant to sections 2 to 22,*
9 *inclusive, of this act may be refunded by the Director of the*
10 *Department of Business and Industry by the issuance of refunding*
11 *bonds in an amount which the Director determines necessary to*
12 *refund the principal of the bonds to be so refunded, any unpaid*
13 *interest thereon and any premiums and incidental expenses*
14 *necessary to be paid in connection with refunding.*

15 2. *Refunding may be carried out whether the bonds to be*
16 *refunded have matured or thereafter mature, either by sale of the*
17 *refunding bonds and the application of the proceeds to the*
18 *payment of the bonds to be refunded, or by exchange of*
19 *the refunding bonds for the bonds to be refunded. The holders of*
20 *the bonds to be refunded must not be compelled, without their*
21 *consent, to surrender their bonds for payment or exchange before*
22 *the date on which they are payable by maturity, option to redeem*
23 *or otherwise, or if they are called for redemption before the date*
24 *on which they are by their terms subject to redemption by option*
25 *or otherwise.*

26 3. *All refunding bonds issued pursuant to this section must be*
27 *payable solely from revenues and other money out of which the*
28 *bonds to be refunded thereby are payable or from revenues out of*
29 *which bonds of the same character may be made payable under*
30 *this or any other law then in effect at the time of the refunding.*

31 4. *The Director of the Department of Business and Industry*
32 *shall not issue refunding bonds unless, before the refinancing, the*
33 *Director finds that issuance of refunding bonds will provide a*
34 *lower cost of financing for the obligor or provide some other*
35 *public benefit, but the findings, determinations and approval*
36 *required by section 8.5 of this act are not required with respect to*
37 *refunding bonds issued pursuant to this section.*

38 **Sec. 10.** (Deleted by amendment.)

39 **Sec. 10.1.** 1. *Except as otherwise provided in subsection 2,*
40 *bonds and other securities issued pursuant to sections 2 to 22,*
41 *inclusive, of this act, their transfer and the income produced by*
42 *the bonds and other securities is and must forever be and remain*
43 *free and exempt from taxation by this State or any political*
44 *subdivision of this State.*

2. *The provisions of subsection 1 do not apply to the tax on the transfers of taxable estates imposed by chapter 375A of NRS or the tax on generation-skipping transfers imposed by chapter 375B of NRS.*

Sec. 10.3. *No action may be brought questioning the legality of any contract, lease, agreement, indenture, mortgage, order or bonds executed, adopted or taken in connection with any project or improvements authorized by sections 2 to 22, inclusive, of this act more than 30 days after the effective date of the order of the Director of the Department of Business and Industry authorizing the issuance of those bonds.*

Sec. 10.5. *The faith of the State is hereby pledged that sections 2 to 22, inclusive, of this act will not be repealed, amended or modified to impair any outstanding bonds or any revenues pledged to their payment, or to impair, limit or alter the rights or powers vested in a charter school to acquire, finance, improve and equip a project in any way that would jeopardize the interest of any lessee, purchaser or other obligor, or to limit or alter the rights or powers vested in the Director of the Department of Business and Industry to perform any agreement made with any lessee, purchaser or other obligor, until all bonds have been discharged in full or provisions for their payment and redemption have been fully made.*

Sec. 10.7. 1. *Sections 2 to 22, inclusive, of this act, without reference to other statutes of this State, constitute full authority for the exercise of powers granted in those sections, including, without limitation, the authorization and issuance of bonds.*

2. *No other act or law with regard to the authorization or issuance of bonds that provides for an election, requires an approval, or in any way impedes or restricts the carrying out of the acts authorized by sections 2 to 22, inclusive, of this act, to be done, applies to any proceedings taken or acts done pursuant to those sections, except for laws to which reference is expressly made in those sections or by necessary implication of those sections.*

3. *The provisions of no other law, either general or local, except as provided in sections 2 to 22, inclusive, of this act, apply to the doing of the things authorized in those sections to be done, and no board, agency, bureau, commission or official not designated in those sections has any authority or jurisdiction over the doing of any of the acts authorized in those sections to be done, except as otherwise provided in those sections.*

4. *A project is not subject to any requirements relating to public buildings, structures, ground works or improvements imposed by the statutes of this State or any other similar*



1 *requirements which may be lawfully waived by this section, and*
2 *any requirement of competitive bidding or other restriction*
3 *imposed on the procedure for award of contracts for such purpose*
4 *or the lease, sale or other disposition of property is not applicable*
5 *to any action taken pursuant to sections 2 to 22, inclusive, of this*
6 *act, except that the provisions of NRS 338.010 to 338.090,*
7 *inclusive, apply to any contract for new construction, repair or*
8 *reconstruction for which tentative approval for financing is*
9 *granted on or after July 1, 2013, by the Director of the Department*
10 *of Business and Industry for work to be done on a project.*

11 5. *Any bank or trust company located within or without this*
12 *State may be appointed and act as a trustee with respect to bonds*
13 *issued and projects financed pursuant to sections 2 to 22,*
14 *inclusive, of this act without the necessity of associating with any*
15 *other person or entity as cofiduciary, but such an association is*
16 *not prohibited.*

17 6. *The powers conferred by sections 2 to 22, inclusive, of this*
18 *act are in addition and supplemental to, and not in substitution*
19 *for, and the limitations imposed by those sections do not affect, the*
20 *powers conferred by any other law.*

21 7. *No part of sections 2 to 22, inclusive, of this act repeals or*
22 *affects any other law or part thereof, except to the extent that*
23 *those sections are inconsistent with any other law, it being*
24 *intended that those sections provide a separate method of*
25 *accomplishing its objectives, and not an exclusive one.*

26 8. *The Director of the Department of Business and Industry*
27 *or a person designated by the Director may take any actions and*
28 *execute and deliver any instruments, contracts, certificates and*
29 *other documents, including the bonds, necessary or appropriate*
30 *for the sale and issuance of the bonds or accomplishing the*
31 *purposes of sections 2 to 22, inclusive, of this act without the*
32 *assistance or intervention of any other officer.*

2 school deliberately causes a decline in the enrollment of pupils in
3 the school district or charter school to receive a higher
4 apportionment pursuant to subsection 2 or 3, including, without
5 limitation, by eliminating grades or moving into smaller facilities,
6 the enrollment number from the current school year must be used
7 for purposes of apportioning money from the State Distributive
8 School Account to that school district or charter school pursuant to
9 NRS 387.124.

10 5. Pupils who are excused from attendance at examinations or
11 have completed their work in accordance with the rules of the board
12 of trustees must be credited with attendance during that period.

13 6. Pupils who are incarcerated in a facility or institution
14 operated by the Department of Corrections must not be counted for
15 the purpose of computing basic support pursuant to this section. The
16 average daily attendance for such pupils must be reported to the
17 Department of Education.

18 7. Pupils who are enrolled in courses which are approved by
19 the Department as meeting the requirements for an adult to earn a
20 high school diploma must not be counted for the purpose of
21 computing basic support pursuant to this section.
