

SENATE BILL NO. 392—SENATOR SEGERBLOM

Referred to Committee on Education

SUMMARY—Directs the Legislative Committee on Education to conduct an interim study concerning gifts and bequests relating to education. (BDR S-147)

AN ACT relating to education; directing the Legislative Committee on Education to conduct an interim study concerning gifts or bequests of money or property to the State Board of Education or the board of trustees of a school district; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill directs the Legislative Committee on Education to conduct an interim
2 study concerning gifts or bequests of money or property to the State Board of
3 Education or the board of trustees of a school district. This bill also requires the
4 Committee to submit a copy of the final written report of the results of the study
5 and any recommendations for legislation to the Director of the Legislative Counsel
6 Bureau for transmittal to the 78th Session of the Nevada Legislature.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** (Deleted by amendment.)

2 **Sec. 2.** (Deleted by amendment.)

3 **Sec. 2.5.** 1. The Legislative Committee on Education shall
4 conduct a study concerning gifts or bequests of money or property
5 to the State Board of Education or the board of trustees of a school
6 district. The study must include, without limitation, a review of:

7 (a) The transparency of the process of making gifts and bequests
8 of money and property;



1 (b) The feasibility and advisability of imposing disclosure
2 requirements for gifts or bequests of money or property;

3 (c) The feasibility and advisability of restricting the ability of
4 the State Board or the board of trustees of a school district to accept
5 certain kinds of gifts or bequests of money or property;

6 (d) The feasibility and advisability of limiting the conditions
7 donors may place on gifts or bequests of money or property,
8 including, without limitation, directions concerning the manner in
9 which a gift or bequest is to be used;

10 (e) The feasibility and advisability of imposing limitations on
11 the purposes for which a gift or bequest of money or property may
12 be used; and

13 (f) Any other issues relating to gifts or bequests of money or
14 property the Committee deems to be relevant.

15 2. The Committee shall recommend such action as may be
16 necessary as a result of its findings.

17 3. On or before February 1, 2015, the Committee shall prepare
18 a final written report of the results of the study and submit a copy of
19 the report and any recommendations for legislation to the Director
20 of the Legislative Counsel Bureau for transmittal to the 78th Session
21 of the Nevada Legislature.

22 **Sec. 3.** This act becomes effective on July 1, 2013.
