AN ACT relating to the reorganization of State Government; continuing the transfer of the powers and duties of the Consumer Affairs Division of the Department of Business and Industry and the Commissioner of Consumer Affairs to the Office of the Attorney General; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 The 75th Session of the Nevada Legislature temporarily eliminated the
2 Consumer Affairs Division of the Department of Business and Industry and the
3 Commissioner of Consumer Affairs for the 2009-2011 biennium and transferred
4 the powers and duties of the Division and the Commissioner to the Office of the
5 Attorney General. (Chapter 475, Statutes of Nevada 2009, pp. 2695-2733) The 76th
6 Session of the Nevada Legislature continued for the 2011-2013 biennium the
7 temporary elimination of the Division and the Commissioner and the transfer of
8 the powers and duties of the Division and the Commissioner to the Office of the
9 Attorney General. (Chapter 440, Statutes of Nevada 2011, p. 2652) The bill
10 continues for the 2013-2015 biennium the temporary elimination of the Division and
11 the Commissioner and the transfer of the powers and duties of the Division and
12 the Commissioner to the Office of the Attorney General.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Section 80 of chapter 475, Statutes of Nevada 2009,
2 as amended by chapter 440, Statutes of Nevada 2011, at page 2652,
3 is hereby amended to read as follows:

4 Sec. 80. 1. This section and sections 1 to 35,
5 inclusive, 36 to 57, inclusive, and 58 to 79, inclusive, of this
6 act become effective on July 1, 2009.

7 2. The amendatory provisions of sections 3, 4, 36 to 51,
8 inclusive, 57, 58 to 75, inclusive, and subsection 2 of section
9 77 of this act expire by limitation on June 30, ~~2013~~ 2015.

10 3. Sections 35.1 to 35.95, inclusive, and 57.5 of this act
11 become effective on July 1, ~~2013~~ 2015.

12 **Sec. 2.** This act becomes effective upon passage and approval.
