AN ACT making an appropriation to Teach for America, Inc.; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     **Section 1.** 1. There is hereby appropriated from the State  
2     General Fund the following sums to Teach for America, Inc., to  
3     support education in Nevada:  
4         For the Fiscal Year 2013-2014..... \$1,000,000  
5         For the Fiscal Year 2014-2015..... \$1,000,000  
6     2. Upon acceptance of the money appropriated by subsection 1,  
7     Teach for America, Inc., shall:  
8         (a) Prepare and transmit a report to the Interim Finance  
9     Committee on or before December 15, 2014, that describes each  
10    expenditure made from the money appropriated by subsection 1  
11    from the date on which the money was received by Teach for  
12    America, Inc., through December 1, 2014;  
13         (b) Prepare and transmit a final report to the Interim Finance  
14    Committee on or before September 18, 2015, that describes each  
15    expenditure made from the money appropriated by subsection 1  
16    from the date on which the money was received by Teach for  
17    America, Inc., through June 30, 2015; and  
18         (c) Upon request of the Legislative Commission, make available  
19    to the Legislative Auditor any of the books, accounts, claims,  
20    reports, vouchers or other records of information, confidential or



1 otherwise, of Teach for America, Inc., regardless of their form or  
2 location, that the Legislative Auditor deems necessary to conduct an  
3 audit of the use of the money appropriated pursuant to subsection 1.

4 **Sec. 2.** The sums appropriated by section 1 of this act are  
5 available for either fiscal year. Any remaining balance of those sums  
6 must not be committed for expenditure after June 30, 2015, by  
7 Teach for America, Inc., or any entity to which money from the  
8 appropriation is granted or otherwise transferred in any manner, and  
9 any portion of the appropriated money remaining must not be spent  
10 for any purpose after September 18, 2015, by either Teach for  
11 America, Inc., or the entity to which the money was subsequently  
12 granted or transferred, and must be reverted to the State General  
13 Fund on or before September 18, 2015.

14 **Sec. 3.** This act becomes effective on July 1, 2013.
