AN ACT making an appropriation to the Department of Administration for distribution to Teach for America, Inc.; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** 1. There is hereby appropriated from the State  
2 General Fund the following sums to the Special Appropriations  
3 Account within the Department of Administration for distribution to  
4 Teach for America, Inc., to support education in Nevada:

5              For the Fiscal Year 2013-2014 ..... \$1,000,000  
6              For the Fiscal Year 2014-2015 ..... \$1,000,000

7        2. Upon acceptance of the money distributed pursuant to  
8 subsection 1, Teach for America, Inc., shall:

9              (a) Prepare and transmit a report to the Interim Finance  
10 Committee on or before December 15, 2014, that describes each  
11 expenditure made from the money distributed to Teach for America,  
12 Inc. pursuant to subsection 1 from the date on which the money was  
13 received by Teach for America, Inc., through December 1, 2014;

14              (b) Prepare and transmit a final report to the Interim Finance  
15 Committee on or before September 18, 2015, that describes each  
16 expenditure made from the money distributed to Teach for America,  
17 Inc. pursuant to subsection 1 from the date on which the money was  
18 received by Teach for America, Inc., through June 30, 2015; and

1       (c) Upon request of the Legislative Commission, make available  
2 to the Legislative Auditor any of the books, accounts, claims,  
3 reports, vouchers or other records of information, confidential or  
4 otherwise, of Teach for America, Inc., regardless of their form or  
5 location, that the Legislative Auditor deems necessary to conduct an  
6 audit of the use of the money distributed to Teach for America, Inc.  
7 pursuant to subsection 1.

8       **Sec. 2.** The sums appropriated by section 1 of this act are  
9 available for either fiscal year. Any remaining balance of those sums  
10 must not be committed for expenditure after June 30, 2015, by the  
11 Department of Administration, Teach for America, Inc. or any entity  
12 to which money from the appropriation is granted or otherwise  
13 transferred in any manner, and any portion of the appropriated  
14 money remaining must not be spent for any purpose after  
15 September 18, 2015, by the Department of Administration, Teach  
16 for America, Inc. or the entity to which the money was subsequently  
17 granted or transferred, and must be reverted to the State General  
18 Fund on or before September 18, 2015.

19       **Sec. 3.** This act becomes effective on July 1, 2013.
