Assembly Bill No. 181.

Remarks by Assemblyman Bobzien.

ASSEMBLYMAN BOBZIEN:

Assembly Bill 181 makes it unlawful for an employer to require an employee or prospective employee to disclose a user name, password, or any other information that provides access to the person's social media account. It also prohibits an employer from discharging, disciplining, or discriminating against an employee or prospective employee who refuses to disclose this information. The bill expressly allows an employer to require disclosure of such information for the purpose of accessing the employer's own internal computer or information system. The bill also prohibits an employer from requiring employees and applicants to provide a consumer credit report for the purposes of hiring, promotion, reassignment, or retention unless certain criteria are met.

JOURNAL OF THE ASSEMBLY

This has been dubbed the "Facebook Bill," and we will be one of a handful of states that are taking this proactive measure to update privacy protections for people in the digital age. I would urge passage.

Remarks by Assemblywoman Diaz.

ASSEMBLYWOMAN DIAZ:

Senate Bill 15 authorizes certain public utilities to request a waiver from the requirement to submit a resource plan to the Public Utilities Commission of Nevada. The utilities include those that furnish water for municipal, industrial, or domestic purposes or sewage disposal services, or both, and that have an annual gross operating revenue of \$1 million or more for at least one year during the immediately preceding three years. The request for a waiver must include proof that the public utility will not experience a significant increase in demand for its services or require the acquisition or construction of additional infrastructure during the three-year period covered by the resource plan the public utility would have submitted.

The measure requires the Commission to issue an order approving or denying the request within 45 days after receiving the request for a waiver. Additionally, the Commission is prohibited from approving a request for a waiver for consecutive three-year periods.
