MOTIONS, RESOLUTIONS AND NOTICES

By Senators Settelmeyer, Gustavson, Hutchison, Cegavske, Goicoechea; Assemblymen Wheeler, Grady, Hansen and Kirner:

Senate Joint Resolution No. 3—Claiming sovereignty under the Tenth Amendment to the *United States Constitution*.

Senator Settelmeyer moved that the resolution be referred to the Committee on Legislative Operations and Elections.

Motion carried.

By Senators Denis, Roberson; Assemblymen Kirkpatrick and Hickey:

Senate Concurrent Resolution No. 3—Providing for the voluntary transfer of a portion of Legislators' salaries to the State General Fund.

WHEREAS, The State of Nevada has faced a staggering budgetary deficit as a result of the impact of a prolonged national recession on Nevada's economy, and the State continues to struggle as a result of the financial hardship experienced by its residents; and

WHEREAS, To meet its constitutional duty to balance the State's budget for the 2011-2013 biennium, the 76th Regular Session of the Nevada Legislature was required to make difficult decisions, including, without limitation, making significant cuts to the State's budget and

providing for a 2.5 percent reduction of the salaries of state employees and imposing furlough requirements on state employees which, when combined, amounted to a 4.8 percent reduction of those salaries; and

WHEREAS, Despite the financial burden of the salary reduction, public employees of this State have continued to perform their duties with diligence, dedication and professionalism; and WHEREAS, The Nevada Constitution prohibits the increase or decrease of the salaries of

state officers during their terms of office; and

WHEREAS, In recognition of the financial sacrifice of our State's public workforce during this biennium, the members of the 77th Regular Session of the Nevada Legislature pledge to voluntarily take a comparable 4.8 percent reduction of their salaries for the 77th Regular Session of the Nevada Legislature; now, therefore, be it

RESOLVED BY THE SENATE OF THE STATE OF NEVADA, THE ASSEMBLY CONCURRING, That the Legislature hereby directs the Accounting Unit of the Legislative Counsel Bureau to withhold 4.8 percent of each Legislator's salary for the 77th Regular Session of the Nevada Legislature; and be it further

RESOLVED, That the Accounting Unit of the Legislative Counsel Bureau shall pay the total amount of such withholdings to the State Treasurer for credit to the unrestricted balance of the State General Fund; and be it further

RESOLVED, That the Accounting Unit of the Legislative Counsel Bureau shall not reduce the salary of any Legislator who did not vote in favor of passage of this resolution and who notifies the Director of the Legislative Counsel Bureau that the Legislator does not wish to have the withholding made from his or her salary.

Senator Denis moved the adoption of the resolution.

Remarks by Senator Denis.

The State of Nevada has faced staggering budget challenges in recent years, and the Nevada Legislature has been required to make difficult decisions regarding budget cuts. One of these decisions included imposing furlough requirements and salary reductions on State employees. They continue to perform their duties with diligence, dedication and professionalism. In recognition of the financial sacrifice of our State's public workforce, this Resolution provides for the voluntary transfer of a portion of the Legislators' salaries to the State General Fund. I hope you all will support it.

Resolution adopted.

Senator Denis moved that all necessary rules be suspended, and that Senate Concurrent Resolution No. 3 be immediately transmitted to the Assembly.

Motion carried unanimously.

Resolution ordered transmitted to the Assembly.

By the Committee on Health and Human Services:

Senate Concurrent Resolution No. 4—Encouraging the Department of Health and Human Services and the Commissioner of Insurance to work with health care providers and insurers to develop a patient-centered medical home model of care and adopt payment models that allow for its implementation.

Senator Jones moved that the resolution be referred to the Committee on Health and Human Services.

Motion carried.

INTRODUCTION, FIRST READING AND REFERENCE

By Senator Settelmeyer:

Senate Bill No. 89—AN ACT relating to public assistance; requiring persons who apply for public assistance to submit to a test to detect the presence of a controlled substance; requiring the Division of Welfare and Supportive Services of the Department of Health and Human Services to deny public assistance to a person whose test result indicates the presence of a controlled substance unless the person participates in a treatment program; providing exceptions for certain persons; providing for the confidentiality of test results; and providing other matters properly relating thereto.

Senator Settelmeyer moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By Senator Settelmeyer; Assemblymen Grady and Ellison:

Senate Bill No. 90—AN ACT relating to confidential information; establishing a procedure for the submission to a local governmental entity of records which are claimed to be confidential and which are required by the entity as a condition of its consideration of an application for a license, permit or similar approval; providing for the determination of such a claim of confidentiality and the status and disposition of the records; authorizing an agency of a county to request a copy of certain confidential records from the Department of Business and Industry under certain circumstances; establishing the procedures by and conditions under which the Department must review and approve such a request; and providing other matters properly relating thereto.

Senator Settelmeyer moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By the Committee on Health and Human Services:

Senate Bill No. 91—AN ACT relating to background investigations; revising provisions relating to criminal background investigations of certain employees and independent contractors of certain agencies, facilities and homes that provide medical or other care to persons; and providing other matters properly relating thereto.

Senator Jones moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By the Committee on Health and Human Services:

Senate Bill No. 92—AN ACT relating to public health; requiring that infants be tested for critical congenital heart disease; providing an exception for written parental objection; and providing other matters properly relating thereto.

Senator Jones moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.
