Senate Bill No. 237—AN ACT relating to crimes; revising the definition of "protected site" as it relates to certain graffiti offenses; providing a penalty; and providing other matters properly relating thereto.

Senator Segerblom moved that the bill be referred to the Committee on Judiciary.

Senate Bill No. 238—AN ACT relating to taxation; providing for the appointment by the Department of Taxation of a hearing officer to review certain decisions made by a county recorder; and providing other matters properly relating thereto.

GENERAL FILE AND THIRD READING

Senate Bill No. 11.

Bill read third time.

Remarks by Senator Goicoechea.

Senate Bill No. 11 makes it unlawful for a person to possess in Nevada any wildlife that was acquired, hunted, taken or transported from another country or state in violation of a law or regulation of that country or state. It brings Nevada law in line with the Lacey Act which relates to wildlife. I urge your support.

Remarks by Senator Hammond.

Senate Bill No. 24 authorizes the Attorney General to establish a program and adopt regulations necessary to assist law enforcement and prosecuting attorneys in complying with Article 36 of the Vienna Convention on Consular Relations.

Remarks by Senators Spearman, Cegavske and Parks.

#### SENATOR SPEARMAN:

Senate Bill No. 25 authorizes the Attorney General to investigate and prosecute technological crimes, pursue the forfeiture of property in relation to these crimes and bring action to enjoin or obtain equitable relief to prevent the occurrence or continuation of technological crimes. It also revises the definition of theft to include the theft of audio or visual services.

Finally, Senate Bill No. 25 revises, from a two-thirds to a simple majority, the number of members of the Technological Crime Advisory Board who must vote to approve the appointment of the Board's Executive Director.

#### SENATOR CEGAVSKE:

Thank you, Mr. President. I would like to ask someone on the Committee if they could answer a question for me: Does this help someone who had email, website and any other Internet-based property broken into? Does this help with, not only business Internet, but personal Internet-based sites as well?

# SENATOR PARKS:

Thank you, Mr. President. To my colleague in Senate District 8, my understanding of this bill is no, it would not deal with the individual when it comes to identity theft directly.

# SENATOR CEGAVSKE:

Thank you, Mr. President. I did not mean to suggest personal identity, rather, I sponsored a bill a few sessions back, where there was an individual who was having his email broken into and another was using his email to send false personal accusations from his personal email address. I was hoping to assess whether this bill helps assist someone with this kind of issue.

# SENATOR PARKS:

Thank you, Mr. President. Yes, this bill will authorize the Attorney General to investigate and prosecute any alleged technological crime and it will also authorize the forfeiture of property relating to technological crimes from such individuals who attempt to profit from the use of stolen technological data.

Remarks by Senator Parks.

Thank you, Mr. President. Senate Bill No. 46 changes the name of the Motor Pool Division of the Department of Administration to the Fleet Services Division and makes the Fleet Services Division a permanent division of the Department of Administration. This bill becomes effective upon passage and approval.

Senate Bill No. 53.

Bill read third time.

Remarks by Senator Segerblom.

Thank you, Mr. President. Senate Bill No. 53 deals with the State Registrar of Vital Statistics. It provides that information relating to birth certificates be released 125 years after the date of birth and information relating to a certificate of death may be released 50 years after the date of death.

Senate Bill No. 73.

Bill read third time.

Remarks by Senator Manendo.

Thank you, Mr. President. Senate Bill No. 73 removes the provision that a report of an act of cruelty against an animal is confidential. It protects the identity of the person making the report, which better matches the intent of Senate Bill 223 of the 76th Session, while still allowing the report itself to be viewed for the purposes of law enforcement.

Senate Bill No. 73 having received a constitutional majority, Mr. President declared it passed.

Senate Bill No. 80.

Bill read third time.

Remarks by Senator Settelmeyer.

Senate Bill No. 80 makes various changes governing dairy products and dairy substitutes. Specifically, the measure authorizes the State Dairy Commission to impound and dispose of any adulterated milk or milk product or any misbranded milk or milk product and impose a civil penalty of not more than \$1,000 for a violation of certain provisions governing permits for the sale of milk and cream. Additionally, Senate Bill No. 80 revises membership qualifications for certain members of the Commission, and it allows the Commission to accept gifts and grants to promote and develop the economic viability of the dairy industry in this State. The bill also makes various changes to frozen desserts and distributors of fluid milk and cream. Finally, the measure revises various definitions for certain dairy products and eliminates numerous provisions governing dairy products and dairy substitutes.

Senate Bill No. 110.

Bill read third time.

Remarks by Senator Kihuen.

Thank you, Mr. President. I rise in support of Senate Bill No. 110 which enacts an amendment to Article 4A of the Uniform Commercial Code, which was promulgated by the Uniform Law Commission and the American Law Institute. The amendment provides that Article 4A applies to a remittance transfer that is not an electronic funds transfer under the federal Electronic Fund Transfer Act. In addition, the amendment to the Uniform Commercial Code clarifies that the federal statute governs in the case of any inconsistency between the applicable provision of Article 4A and the Electronic Fund Transfer Act. This bill passed unanimously out of Committee. I urge your support.

Senate Bill No. 114.

Bill read third time.

Remarks by Senator Roberson.

Thank you, Mr. President. I rise in support of Senate Bill No. 114. I would like to thank my colleague from Senate District 4 who Chairs the Committee on Commerce, Labor and Energy, for being the primary sponsor of this bill along with me. Senate Bill No. 114 relates to the filing of insurance rates and insurance modernization. It provides that a rate filing made by an insurer

service organization must include a proposed effective date for those rates and be filed with the Commissioner of Insurance not less than 30 days before the proposed effective date of those rates. A filing for a proposed rate increase or decrease may include a request that the Commissioner authorize an earlier effective date than the date proposed. If within 15 days after a proposal is filed the Commissioner determines that the proposal is incomplete, the Commissioner must notify the insurer or rate service organization of that determination. The bill changes from 60 to 30 the number of days within which the Commissioner must approve or disapprove a proposed rate change after determining the proposal is complete. If the proposal is not approved, the Commissioner must submit a written notice to the insurer or rate service organization of the disapproval within that same 30-day period and provide the reasons why the proposal was disapproved. The insurer or rate service organization may, within 30 days of receiving a notice of disapproval, request a reconsideration of the proposal. The Commissioner must approve or disapprove the reconsidered proposal not later than 30 days after receipt of the request for reconsideration. I urge my colleagues to support Senate Bill No. 114.

I would like to thank my colleague from Senate District 7 for bringing this bill to the Committee on Judiciary where it received unanimous support. I urge a yes vote.

#### PRESIDENT KROLICKI:

We have some very special guests in the Chamber for Canada Day at the Nevada Legislature. I think you all understand the incredible importance of the relationship of brotherhood we have with the country of Canada. We treasure the relationship and value the friendships we have had for a very long time on the longest border in the world that secures peace and comfort.

One indulgence here if I may, when we think of Canada we think of hockey, maple leaves, maple syrup, Royal Canadian Mounted Police and we also think of curling. I shared with the Consul General and his team today that the International Continental Cup of Curling—the Holy Grail of curling, like the America's Cup—is a big deal around the world, and especially in Canada. This contest has never before been held outside of Canada. In January of 2014, the International Continental Cup of Curling will be held in our very own Las Vegas. We are delighted to further enhance, through elite international sports, curling in Nevada.
