Remarks by Senators Spearman, Hardy, Hutchison, Hammond and Settelmeyer.

SENATOR SPEARMAN:

Thank you, Mr. President pro Tempore. This is a very special day because I believe that it punctuates the Nevada Legislature's commitment to equality, equal access and equal protection under the law. There have been times in our history, both at the federal level and at the State level, when things have happened that upon later reflection, they do not adequately express who we are as children of God. Today we make those wrongs right.

For those among us who happen to be different but who are still created by God, and as someone who has experienced multiple incidences of discrimination in my lifetime, I am glad to see this day has come for the rest of our citizens.

SENATOR HARDY:

Thank you, Mr. President pro Tempore. Yesterday afternoon we had an amendment to Senate Bill No. 139. In researching that amendment and in talking with the Majority Leader, Assistant Majority Leader and Legal Counsel Brenda Erdoes last night, a concern I raised in 2011 still remains. As defined in 2011, gender identity means a gender-related identity, appearance, expression or behavior of a person regardless of the person's assigned sex at birth.

When we look at how the Federal Bureau of Investigation and the federal statute define it and recall our need to match the federal language, we have a mismatch. Regarding the intent of the behavior, when I look at it as amended, I am concerned that we are potentially giving a "super free speech" to a group of people seeking equality. I agree with equality but I do not agree with "super free speech."

I have tried to get my head and my soul around what we can do as a Body that would allow us to recognize there are parameters around free speech. In the spirit of equality, if we could add slightly different language such as, "gender identity or gender expression" I could be very supportive of this bill. As it stands now with "gender identity or expression," I feel it gives a "super free speech" and I cannot be supportive.

SENATOR HUTCHISON:

Thank you, Mr. President pro Tempore. I rise for two purposes today. First, I rise to echo what I understood from the deliberations of my colleagues in the Senate Committee on Judiciary: in the phrase "gender identity or expression," the word gender modifies both identity and expression. Similar to the phrase "blue car or truck" indicating both a blue car and a blue

truck. Thus, I read the phrase "gender identity or expression" to mean gender identity or gender expression.

Beyond that, I rise in support of Senate Bill No. 139. I support this bill because if there is actual legal evidence proving that a violent crime was motivated by a victim's race, color, religion, national origin, physical or mental disability, sexual orientation or gender identity, there is proof of premeditation in the commission of a crime. In my view, this premeditation warrants an enhancement of the penalty for the crime imposed under Nevada law. In my judgment, this law does not address crimes of passion or opportunity or the like. This law applies when there is actual evidence that violence or criminal activity was visited on a victim, merely because of these enumerated characteristics.

As I noted in the Senate Committee on Judiciary when Senator Spearman presented Senate Bill No. 139, the history of my own religious faith is littered with instances of men, women and children being subjected to violent crimes and unspeakable acts because of their religious convictions. I believe they would have benefitted greatly from a law such as Senate Bill No. 139, and I believe all Nevadans will benefit from this law.

SENATOR HAMMOND:

Thank you, Mr. President pro Tempore. I rise in support of Senate Bill No. 139 and the comments already made by my fellow Senators. My colleague in Senate District 6 said it all and said it best. As we heard in the Senate Committee on Judiciary, Senate Bill No. 139 addresses those individuals who would target someone because of a certain characteristic as enumerated by my colleague in Senate District 6, not necessarily because of a crime of passion or opportunity, but because of who someone is. The intent of this bill is to send the message back to those who perpetrate harm on another because of a certain characteristic, and because of that, I rise in support of it and hope my colleagues will also support passage of this bill.

SENATOR SETTELMEYER:

Thank you, Mr. President pro Tempore. I appreciate the concerns that were expressed by my colleague in Senate District 12. I hope the sponsor of the Senate Bill No. 139, if this bill passes and moves to the Assembly, will have an opportunity to work on the expressed concerns. I think the concerns are valid.

As a Body, when we discuss enhancements and multipliers, we need to look at the concept that incarceration should be as long as necessary to decrease recidivism. I worry that we are taking the flexibility away from the courts and the parole boards in defining the appropriate time of incarceration.
