Chair Daly:

We have two bills on work session today. Before we get into those, I will let the Committee know that we have a few more bills so we will have a fuller schedule coming up. As we progress, we will try to work them through and make sure you get enough information in enough time to answer any questions you might have. The first bill on the agenda today is Assembly Bill 128.

Assembly Bill 128: Exempts a person from the payment of a fee for the management of aquatic invasive species under certain circumstances. (BDR 43-809)

There was an amendment ([Exhibit C](#)) to Assembly Bill 128 that has been on Nevada Electronic Legislative Information System (NELIS) since last week, I believe. I would accept a motion to amend and due pass with the amendment that is on NELIS and then we will have discussion.

ASSEMBLYMAN WHEELER MOVED TO AMEND AND DO PASS
ASSEMBLY BILL 128.

ASSEMBLYMAN CARRILLO SECONDED THE MOTION.

I know there was one question, but I think it was answered for one of our members. Are there any other questions or comments on A.B. 128? [There were none.]

THE MOTION PASSED UNANIMOUSLY.

I will have Assemblyman Carrillo do the floor assignment.

Assembly Joint Resolution 4, as you recall, was one of the two grazing bills.

Assembly Joint Resolution 4: Urges the Bureau of Land Management and the United States Forest Service to assist the State of Nevada with the prevention and suppression of wildfires in this State. (BDR R-209)

We took some language out of Assembly Joint Resolution 2, put it into Assembly Joint Resolution 4 ([Exhibit D](#)), which was the Committee bill on public lands. I spoke to the sponsors. I spoke with the former chair of the Committee on Public Lands, Mr. Goicoechea on the Senate side, and everybody is okay or I would not have put it up on work session. With that, I will accept a motion to amend and do pass A.J.R. 4 with the amendment that is on NELIS.

ASSEMBLYMAN AIZLEY MOVED TO AMEND AND DO PASS
ASSEMBLY JOINT RESOLUTION 4.

ASSEMBLYMAN ELLISON SECONDED THE MOTION.

[There was no response.]


MOTION PASSED UNANIMOUSLY.
