BDR 34-198 Revises provisions governing the P-16 Advisory Council. (Later introduced as [Assembly Bill 259](#).)

Assemblyman Hickey asked whether the bill draft request had a fiscal note attached. Chair Carlton explained that it did not.

Assemblyman Kirner asked for information concerning the P-16 Council. Assemblywoman Flores, a member of the Council, explained that the Council would address the lack of emphasis placed on the learning capabilities of children ages 0-5 in the proposed legislation.

Cindy Jones, Assembly Fiscal Analyst, Fiscal Analysis Division, Legislative Counsel Bureau, explained the additional proposed change in statute to enable licensed teachers to instruct pupils in the curriculum required for Common Core Standards.
