- **BDR 18-1136:** Revises provisions relating to the transfer of duties and consolidation of certain governmental agencies. (Later introduced as Assembly Bill 488.)
- BDR 31-779: Revises provisions governing the fees charged by state agencies for accepting payments by credit cards, debit cards and electronic transfers. (Later introduced as Assembly Bill 489.)
- BDR S-533: Makes an appropriation to Communities in Schools of Nevada, Inc. to coordinate the provision of student and family services to youth in this State. (Later introduced as Assembly Bill 490.)
- BDR S-1162: Temporarily revises various provisions relating to state financial administration. (Later introduced as Assembly Bill 491.)
- BDR 16-1144: Transfers the parole functions of the Department of Public Safety to the Department of Corrections. (Later introduced as Assembly Bill 497.)
