<u>SENATE JOINT RESOLUTION 5</u>: Urges Congress to reintroduce and pass the Marketplace Fairness Act. (BDR R-697)

Carol M. Stonefield:

<u>Senate Joint Resolution 5</u> was brought to this Committee by Senator Joyce Woodhouse and sponsored by other Senators. I have provided a work session document on this resolution (<u>Exhibit D</u>). There was no opposition expressed. There is a technical amendment proposed by Chair Spearman, <u>Exhibit D</u>, page 2. Since <u>S.J.R. 5</u> was filed and introduced, the Marketplace Fairness Act was reintroduced as Senate Resolution 336 of the 113th Congress and House of Representative Resolution 684 of the 113th Congress. The technical amendment would make the resolution conform to the legislation in Congress.

SENATOR CEGAVSKE MOVED TO AMEND AND DO PASS AS AMENDED S.J.R. 5.
