- [S.B. 5](#) (R1) Revises provisions governing elections for nonpartisan offices. (BDR 24-90)
- [S.B. 19](#) (R1) Authorizes the board of trustees of a school district to place an advisory question on the ballot at a general election. (BDR 24-477)
- [S.J.R. 3](#) (R1) Proposes to amend the Nevada Constitution to provide for the Lieutenant Governor to be elected jointly with the Governor. (BDR C-486)
- [S.J.R. 17](#) (R1) Proposes to amend the Nevada Constitution to expand the rights guaranteed to victims of crime. (BDR C-952)

- [S.B. 248](#) (R1) Revises provisions relating to the provision of assistance to certain voters. (BDR 24-982)
- [S.J.R. 1](#) (R1) Urges Congress to enact legislation transferring title to certain public lands to the State of Nevada in accordance with the report prepared by the Nevada Land Management Task Force. (BDR R-451)
- [S.J.R. 5](#) (R1) Expresses support for the 2014 Nevada Greater Sage-Grouse Conservation Plan developed by the Sagebrush Ecosystem Council and urges the United States Fish and Wildlife Service not to list the greater sage-grouse as endangered or threatened under the Endangered Species Act of 1973. - [S.J.R. 21](#) (R1) Urges Congress to enact comprehensive immigration reform. (BDR R-1266)
