S.J.R. 5 Expresses support for the 2014 Nevada Greater Sage-Grouse Conservation Plan developed by the Sagebrush Ecosystem Council and urges the United States Fish and Wildlife Service not to list the greater sage-grouse as endangered or threatened under the Endangered Species Act of 1973. (BDR R-480)

S.B. 19 Authorizes the board of trustees of a school district to place an advisory question on the ballot at a general election. (BDR 24-477)

S.B. 62 Revises provisions governing the employment, promotion, dismissal, demotion and suspension of state employees. (BDR 23-285)
