AN ACT relating to counties; extending the deadline for approval of the revisions of the boundary line between Storey County and Washoe County by the Board of County Commissioners of Storey County and the Board of County Commissioners of Washoe County; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law provides for the revision of the boundary line between Storey
2 County and Washoe County upon the adoption of resolutions by the Board of
3 County Commissioners of Storey County and the Board of County Commissioners
4 of Washoe County approving the revisions. The deadline for the approval of the
5 revisions by the respective boards is June 30, 2015. (NRS 243.340; chapter 94,
6 Statutes of Nevada 2013, p. 307) This bill extends the deadline for the approval of
7 the revisions by the respective boards until June 30, 2017.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Section 3 of chapter 94, Statutes of Nevada 2013, at
2 page 312, is hereby amended to read as follows:
3 Sec. 3. 1. This section and section 2 of this act
4 become effective upon passage and approval.
5 2. Section 1 of this act becomes effective only upon the
6 adoption, on or after July 1, 2013, and on or before June 30,



1 ~~{2015,}~~ 2017, of a resolution by the Board of County
2 Commissioners of Storey County and the Board of County
3 Commissioners of Washoe County, respectively, approving
4 the revisions described in the amendatory provisions of
5 section 1 of this act to the boundary line between the
6 respective Counties.

7 3. Section 1.5 of this act becomes effective only upon
8 the adoption, on or after July 1, 2013, and on or before
9 June 30, ~~{2015,}~~ 2017, of a resolution by the Board of County
10 Commissioners of Storey County and the Board of County
11 Commissioners of Washoe County, respectively, approving
12 the revisions described in the amendatory provisions of
13 section 1.5 of this act to the boundary line between the
14 respective Counties.

15 **Sec. 2.** This act becomes effective upon passage and approval.
