AN ACT relating to private investigations; exempting the Private Investigator's Licensing Board from certain administrative procedures governing professional licensing boards; exempting certain professionals who provide information security from regulation as a private investigator; deleting provisions requiring a licensee or applicant for a license to maintain a principal place of business in this State; authorizing the Board to revoke the registration of a registered employee under certain circumstances; revising certain provisions relating to licensure and registration by the Board; revising provisions relating to disciplinary actions by the Board; providing penalties; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law requires the Private Investigator's Licensing Board to comply with certain administrative procedures governing certain professional licensing boards. (Chapter 622A of NRS) Sections 1, 4 and 5 of this bill exempt the Board from complying with such procedures.

Existing law provides that a person engaging in the business of a private investigator must be licensed ~~by~~ and is subject to ~~the~~ regulation ~~of the Private Investigator's Licensing~~ by the Board. (NRS 648.060) Existing law defines a private investigator to include a person who conducts an investigation through the review or analysis of computerized data not available to the public. (NRS 648.012) ~~Section 1.3~~ Section 1.3 of this bill defines the term "information security." Section 2.5 of this bill revises the definition of "private investigator" to exclude from the definition certain professionals who provide information security. Section 3 of this bill exempts certain professionals who provide information security from the provisions of NRS governing private investigators.

Existing law prohibits a person from engaging in any business regulated by the Board or advertising such business unless the person is licensed by the Board. Existing law further prohibits the employment by a licensee of a person unless the person is a registered employee. Existing law requires the Board to assess certain administrative fines for violations of these provisions and specifies the amounts of such administrative fines. (NRS 648.060, 648.165) Section 14 of this bill authorizes rather than requires the

20 Board to assess such administrative fines and provides the Board with discretion as to
21 the amount of such administrative fines.

22 Sections 7, 8, 10 and 11 of this bill delete provisions requiring a licensee or an
23 applicant for a license to maintain a principal place of business in Nevada.

24 Section 9 of this bill provides that each registered employee employed in this State
25 by a licensee must be supervised by the licensee or his or her designated agent who is
26 physically present in this State.

27 Under existing law, the Board is required to issue a registration to a person who, in
28 addition to certain other requirements, has not been convicted of, or entered a plea of
29 nolo contendere to, a felony or a crime involving moral turpitude or the illegal use or
30 possession of a dangerous weapon. (NRS 648.1493) Existing law provides that a licensee
31 may employ only persons who have not been convicted of a felony or a crime involving
32 moral turpitude or the illegal use or possession of a dangerous weapon. (NRS 648.060)
33 Sections 6 and 12 of this bill remove this prohibition, effectively providing the Board
34 with the discretion to issue a registration to a person who is otherwise qualified to obtain
35 a registration but has been convicted of such crimes.

36 Section 1.7 of this bill authorizes the Board to revoke the registration of a registered
37 employee under certain circumstances. Section 13 of this bill expands the authority of
38 the Board to investigate the actions of a person holding or claiming to hold a license to
39 include investigations of the actions of a person holding or claiming to hold a
40 registration. Section 13.5 of this bill provides that it is grounds for the suspension or
41 revocation of a registration or application for registration that a registered employee or
42 applicant for a registration fails to comply with a notice of violation issued by the Board.
43 Sections 14.5 and 15 of this bill similarly expand provisions of existing law relating to
44 disciplinary action by the Board to include disciplinary action with regard to registered
45 employees.

2. Any regulatory body which is exempted from the provisions of this chapter pursuant to subsection 1 may elect by regulation to follow the provisions of this chapter or any portion thereof.

~~Section 1.1~~ *Sec. 1.1.* Chapter 648 of NRS is hereby amended by adding thereto ~~the provisions set forth as sections 1.3, 1.5 and 1.7 of this act.~~ the provisions set forth as sections 1.3, 1.5 and 1.7 of this act.

Sec. 1.3. "Information security" has the meaning ascribed to it in 44 U.S.C. § 3552. The term includes restoring the integrity, confidentiality and availability of information and information systems after a data breach, suspected data breach or other data security incident.

Sec. 1.5. "Registered employee" means a person to whom the Board has issued a registration pursuant to NRS 648.1493.

Sec. 1.7. The Board may revoke the registration of a registered employee if the Board finds, after a hearing conducted pursuant to NRS 648.166 and 648.170, that the registered employee:

1. Failed to disclose any fact or misstated or otherwise misled the Board with respect to any fact contained in any application for the issuance or renewal of a registration submitted to the Board by the registered employee;

2. On or after the date on which the Board issues a registration to the registered employee, the registered employee commits or attempts or conspires to commit any act prohibited by this chapter or any regulation adopted or order issued pursuant thereto; or

3. On or after the date on which the Board issues a registration to the registered employee, the registered employee is convicted of, or enters a plea of nolo contendere to, a felony or a crime involving moral turpitude or the illegal use or possession of a dangerous weapon.

Sec. 2. NRS 648.005 is hereby amended to read as follows:

648.005 As used in this chapter, unless the context otherwise requires, the words and terms defined in NRS 648.006 to 648.016, inclusive, ~~and section 1.3 and 1.5 of this act~~ have the meanings ascribed to them in those sections.

Sec. 2.5. NRS 648.012 is hereby amended to read as follows:

648.012 *1.* "Private investigator" means any person who for any consideration engages in business or accepts employment to furnish, or agrees to make or makes any investigation for the purpose of obtaining ~~including, without limitation, through the review, analysis and investigation of computerized data not available to the public,~~ information with reference to:

~~1-1~~ *(a)* The identity, habits, conduct, business, occupation, honesty, integrity, credibility, knowledge, trustworthiness, efficiency, loyalty, activity, movement, whereabouts, affiliations, associations, transactions, acts, reputation or character of any person;

~~1-2~~ *(b)* The location, disposition or recovery of lost or stolen property;

~~1-3~~ *(c)* The cause or responsibility for fires, libels, losses, accidents or damage or injury to persons or to property;

~~1-4~~ *(d)* A crime or tort that has been committed, attempted, threatened or suspected, except an expert witness or a consultant who is retained for litigation or a trial, or in anticipation of litigation or a trial, and who performs duties and tasks within his or her field of expertise that are necessary to form his or her opinion;

~~1-5~~ *(e)* Securing evidence to be used before any court, board, officer or investigating committee; or

~~1-6~~ *(f)* The prevention, detection and removal of surreptitiously installed devices for eavesdropping or observation.

5 **Sec. 3.** NRS 648.018 is hereby amended to read as follows:

6 648.018 Except as to polygraphic examiners and interns, this chapter does not
7 apply:

8 1. To any detective or officer belonging to the law enforcement agencies of
9 the State of Nevada or the United States, or of any county or city of the State of
10 Nevada, while the detective or officer is engaged in the performance of his or her
11 official duties.

12 2. To special police officers appointed by the police department of any city,
13 county, or city and county within the State of Nevada while the officer is engaged
14 in the performance of his or her official duties.

15 3. To insurance adjusters and their associate adjusters licensed pursuant to the
16 Nevada Insurance Adjusters Law who are not otherwise engaged in the business of
17 private investigators.

18 4. To any private investigator, private patrol officer, process server, dog
19 handler or security consultant employed by an employer regularly in connection
20 with the affairs of that employer if a bona fide employer-employee relationship
21 exists, except as otherwise provided in NRS 648.060, 648.140 and 648.203.

22 5. To a reposessor employed exclusively by one employer regularly in
23 connection with the affairs of that employer if a bona fide employer-employee
24 relationship exists, except as otherwise provided in NRS 648.060, 648.140 and
25 648.203.

26 6. To a person engaged exclusively in the business of obtaining and
27 furnishing information as to the financial rating of persons.

28 7. To a charitable philanthropic society or association incorporated under the
29 laws of this State which is organized and maintained for the public good and not for
30 private profit.

31 8. To an attorney at law in performing his or her duties as such.

32 9. To a collection agency unless engaged in business as a reposessor,
33 licensed by the Commissioner of Financial Institutions, or an employee thereof
34 while acting within the scope of his or her employment while making an
35 investigation incidental to the business of the agency, including an investigation of
36 the location of a debtor or his or her assets and of property which the client has an
37 interest in or lien upon.

38 10. To admitted insurers and agents and insurance brokers licensed by the
39 State, performing duties in connection with insurance transacted by them.

40 11. To any bank organized pursuant to the laws of this State or to any national
41 bank engaged in banking in this State.

42 12. To any person employed to administer a program of supervision for
43 persons who are serving terms of residential confinement.

44 13. To any commercial registered agent, as defined in NRS 77.040, who
45 obtains copies of, examines or extracts information from public records maintained
46 by any foreign, federal, state or local government, or any agency or political
47 subdivision of any foreign, federal, state or local government.

48 14. To any holder of a certificate of certified public accountant issued by the
49 Nevada State Board of Accountancy pursuant to chapter 628 of NRS while
50 performing his or her duties pursuant to the certificate.

51 15. To a person performing the repair or maintenance of a computer who
52 performs a review or analysis of data contained on a computer solely for the

1 purposes of diagnosing a computer hardware or software problem and who is not
2 otherwise engaged in the business of a private investigator.

3 *16. To any person who for any consideration engages in business or accepts*
4 *employment to provide information security.*

5 **Sec. 4. NRS 648.033 is hereby amended to read as follows:**

6 648.033 1. The Board shall maintain a public record of:

7 (a) The business it transacts at its regular and special meetings; and

8 (b) The applications received by it together with the record of the disposition
9 of each application.

10 2. Except as otherwise provided in NRS 239.0115, information obtained by
11 the Board from other than public sources concerning the:

12 (a) Financial condition; or

13 (b) Criminal record,

14 ↪ of an applicant or a licensee is confidential and may be revealed only to the
15 extent necessary for the proper administration of the provisions of this chapter.

16 3. The Board may release information described in subsection 2 to an agency
17 of the Federal Government, of a state or of a political subdivision of this State.

18 4. The Board shall adopt by regulation a procedure for notifying the applicant

27 requesting that such documents and information be made public records.

28 6. The charging documents filed with the Board to initiate disciplinary action
29 ~~pursuant to chapter 622A of NRS~~ and all other documents and information
30 considered by the Board when determining whether to impose discipline are public
31 records.

32 7. The provisions of this section do not prohibit the Board from
33 communicating or cooperating with or providing any documents or other
34 information to any other licensing board or any other agency that is investigating a
35 person, including, without limitation, a law enforcement agency.

36 **Sec. 5. NRS 648.040 is hereby amended to read as follows:**

37 648.040 1. There is hereby created in the State General Fund the Fund for
38 the Private Investigator's Licensing Board, to be administered by the Board.

39 2. Except as otherwise provided in subsection 7, all money received pursuant
40 to the provisions of this chapter must be deposited in the State Treasury for credit to
41 the Fund for the Private Investigator's Licensing Board and must be used by the
42 Board for the administration of this chapter and to pay the expenses and salary of
43 members, agents and employees of the Board.

44 3. All claims against the Fund must be paid as other claims against the State
45 are paid. Any amount remaining in the Fund at the end of a fiscal year must be
46 carried forward into the next fiscal year.

47 4. The Board through majority vote controls exclusively the expenditures
48 from the Fund. The Board may not make expenditures or incur liabilities in a total
49 amount greater than the amount of money actually available in the Fund.

28 licensed pursuant to this chapter.

15 the directors and officers of a corporate applicant, as it considers necessary. An
16 applicant shall deposit with the Board at the time of making an initial application

29 the suspension or revocation of a license under this chapter.

30 (b) Committed any act constituting dishonesty or fraud.

31 (c) Demonstrated untruthfulness or a lack of integrity.

32 (d) Been refused a license under this chapter or had a license revoked.

33 (e) Been an officer, director, partner or manager of any firm, partnership,
34 association or corporation which has been refused a license under this chapter or
35 whose license has been revoked.

36 (f) While unlicensed, performed any act for which a license is required by this
37 chapter.

38 (g) Knowingly made any false statement in the application.

39 (h) Refused to provide any information required by the Board.

40 4. The Board shall provide the applicant with a copy of the report of the
41 investigation within a reasonable time after it receives the completed report.

42 **Sec. 9. NRS 648.140 is hereby amended to read as follows:**

43 648.140 1. Any license obtained pursuant to the provisions of this chapter
44 gives the licensee or any bona fide employee of the licensee authority to engage in
45 the type of business for which he or she is licensed in any county or city in the State
46 of Nevada. A county or city shall not enact ordinances regulating persons licensed
47 pursuant to this chapter, except general business regulations designed to raise
48 revenue or assure compliance with building codes and ordinances or regulations
49 concerning zoning and safety from fire.

50 2. Except for polygraphic examiners and interns, a licensee may employ, in
51 connection with his or her business, as many ~~persons registered pursuant to this
52 chapter~~ registered employees as may be necessary, but at all times every licensee:

19 (c) The number and date of the license.

20 (d) The expiration date of the license.

21 (e) If the licensee is a corporation, the name of the person or persons affiliated
22 with the corporation on the basis of whose qualifications such license is issued.

23 (f) The classification or classifications of work which the license authorizes.

24 2. The license shall at all times be posted in a conspicuous place in the
25 licensee's principal place of business ; {in this State;}

26 3. Upon the issuance of a license, a pocket card of such size, design and
27 content as may be determined by the Board shall be issued without charge to each
28 licensee, if an individual, or if the licensee is a person other than an individual, to
29 its manager and to each of its officers, directors and partners, which card shall be
30 evidence that the licensee is duly licensed pursuant to this chapter. When any
31 person to whom a card is issued terminates his or her position, office or association
32 with the licensee, the card shall be surrendered to the licensee and within 5 days
33 thereafter shall be mailed or delivered by the licensee to the Board for cancellation.

34 4. A licensee shall, within 30 days after such change, notify the Board of any
35 and all changes of his or her address, of the name under which the licensee does
36 business, and of any change in its officers, directors or partners.

37 5. A license issued under this chapter is not assignable.

38 **Sec. 11. NRS 648.148 is hereby amended to read as follows:**

39 648.148 1. Each licensee shall:

40 (a) Maintain a principal place of business ; {in this State;} and

41 (b) File with the Board the complete address of his or her principal place of
42 business ; {in this State;} including the name and number of the street, or, if the
43 street where the business is located is not numbered, the number of the post office
44 box. The Board may require the filing of other information for the purpose of
45 identifying such principal place of business.

46 2. Every advertisement by a licensee soliciting or advertising business shall
47 contain the licensee's name and the number of the licensee's license as they appear
48 in the records of the Board.

49 **Sec. 12. NRS 648.1493 is hereby amended to read as follows:**

50 648.1493 1. To obtain a registration, a person must:

51 (a) Be a natural person;

52 (b) File a written application for registration with the Board;

53 (c) Comply with the applicable requirements of this chapter; and

1 (d) Pay an application fee set by the Board of not more than \$135.

2 2. An application for registration must include:

3 (a) A fully completed application for registration as an employee;

4 (b) A passport size photo;

5 (c) A completed set of fingerprint cards or a receipt for electronically
6 submitted fingerprints of the applicant submitted as required by the Board; and

7 (d) Any other information or supporting materials required pursuant to the
8 regulations adopted by the Board or by an order of the Board. Such information or
9 supporting materials may include, without limitation, other forms of identification
10 of the person.

31 5. A registration issued pursuant to this section and the cards issued pursuant
32 to subsection 4 expire 5 years after the date the registration is issued, unless it is
33 renewed. To renew a registration, the holder of the registration must submit to the
34 Board on or before the date the registration expires:

35 (a) A fully completed application for renewal of registration as an employee;

36 (b) A passport size photo;

37 (c) A completed set of fingerprint cards or a receipt for electronically
38 submitted fingerprints of the applicant submitted as required by the Board;

39 (d) A renewal fee set by the Board of not more than \$135; and

40 (e) Any other information or supporting materials required pursuant to the
