SUMMARY—Revises provisions relating to the Governor Guinn
Millennium Scholarship. (BDR 34-96)

AN ACT relating to education; increasing the number of credit
hours required for certain students to be eligible for the
Governor Guinn Millennium Scholarship; revising
the amount of money a student who is eligible for the
Governor Guinn Millennium Scholarship may receive per
semester; and providing other matters properly relating
thereto.

Legislative Counsel's Digest:

Existing law establishes the Governor Guinn Millennium Scholarship Program to provide money to certain students for secondary education and the certain criteria for eligibility for such a scholarship. Such criteria includes a requirement that a student be enrolled in a certain number of credit hours in a community college or other eligible institution. (NRS 396.926, 396.930) **Sections 1 and 2** of this bill increase, over a period of 2 years beginning July 1, 2015, the number of credit hours in which a community college student must be enrolled in order to be eligible for a Millennium Scholarship. The number of credit hours is increased from 6 credit hours to 9 credit hours beginning July 1, 2015, and is increased to 12 credit hours beginning July 1, 2016, and continuing thereafter. Existing law further limits the total amount of money that a student may receive from a Millennium Scholarship to not more than the cost of 12 semester credits per semester and a total amount of not more than \$10,000. (NRS 396.934) **Section 3** of this bill increases the amount that such a student may receive from a Millennium Scholarship for a semester to not more than the cost of 15 semester credits per semester but the

16 cumulative maximum amount of money that such a student may receive remains
17 unchanged at \$10,000.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 396.930 is hereby amended to read as follows:

Such criteria must provide for the award of Millennium Scholarships to those students who qualify for the exemption and who otherwise meet the eligibility criteria to the extent that money is available to award Millennium Scholarships to the students after all other obligations for the award of Millennium Scholarships for the current school year have been satisfied.

396.934 1. Except as otherwise provided in this section, within the limits of money available in the Trust Fund, a student who is eligible for a Millennium Scholarship is entitled to receive:

(a) If he or she is enrolled in a community college within the System, including, without limitation, a summer academic term, \$40 per credit for each lower division course and \$60 per credit for each upper division course in which the student is enrolled, or the amount



1 of money that is necessary for the student to pay the costs of
2 attending the community college that are not otherwise satisfied by
3 other grants or scholarships, whichever is less. The Board of
4 Regents shall provide for the designation of upper and lower
5 division courses for the purposes of this paragraph.

6 (b) If he or she is enrolled in a state college within the System,
7 including, without limitation, a summer academic term, \$60 per
8 credit for which the student is enrolled, or the amount of money that
9 is necessary for the student to pay the costs of attending the state
10 college that are not otherwise satisfied by other grants or
11 scholarships, whichever is less.

12 (c) If he or she is enrolled in another eligible institution,
13 including, without limitation, a summer academic term, \$80 per
14 credit for which the student is enrolled, or the amount of money that
15 is necessary for the student to pay the costs of attending the
16 university that are not otherwise satisfied by other grants or
17 scholarships, whichever is less.

18 (d) If he or she is enrolled in more than one eligible institution,
19 including, without limitation, a summer academic term, the amount
20 authorized pursuant to paragraph (a), (b) or (c), or a combination
21 thereof, in accordance with procedures and guidelines established by
22 the Board of Regents.

23 ➤ In no event may a student who is eligible for a Millennium
24 Scholarship receive more than the cost of ~~142~~ 15 semester credits

26 2. No student may be awarded a Millennium Scholarship:

27 (a) To pay for remedial courses.

28 (b) For a total amount in excess of \$10,000.

29 3. A student who receives a Millennium Scholarship shall:

30 (a) Make satisfactory academic progress toward a recognized
31 degree or certificate, as determined by the Board of Regents
32 pursuant to subsection 8; and

33 (b) If the student graduated from high school after May 1, 2003,
34 maintain:

35 (1) At least a 2.60 grade point average on a 4.0 grading scale
36 for each semester during the first year of enrollment in the Governor
37 Guinn Millennium Scholarship Program.

38 (2) At least a 2.75 grade point average on a 4.0 grading scale
39 for each semester during the second year of enrollment in the
40 Governor Guinn Millennium Scholarship Program and for each
41 semester during each year of enrollment thereafter.

42 4. A student who receives a Millennium Scholarship is
43 encouraged to volunteer at least 20 hours of community service for
44 this State, a political subdivision of this State or a charitable
45 organization that provides service to a community or the residents of



1 a community in this State during each year in which the student
2 receives a Millennium Scholarship.

3 5. If a student does not satisfy the requirements of subsection 3
4 during one semester of enrollment, excluding a summer academic
5 term, he or she is not eligible for the Millennium Scholarship for the
6 succeeding semester of enrollment. If such a student:

7 (a) Subsequently satisfies the requirements of subsection 3 in a
8 semester in which he or she is not eligible for the Millennium
9 Scholarship, the student is eligible for the Millennium Scholarship
10 for the student's next semester of enrollment.

11 (b) Fails a second time to satisfy the requirements of subsection
12 3 during any subsequent semester, excluding a summer academic
13 term, the student is no longer eligible for a Millennium Scholarship.

14 6. A Millennium Scholarship must be used only:

15 (a) For the payment of registration fees and laboratory fees and
16 expenses;

17 (b) To purchase required textbooks and course materials; and

18 (c) For other costs related to the attendance of the student at the
19 eligible institution.

20 7. The Board of Regents shall certify a list of eligible students
21 to the State Treasurer. The State Treasurer shall disburse a
22 Millennium Scholarship for each semester on behalf of an eligible
23 student directly to the eligible institution in which the student is
24 enrolled, upon certification from the eligible institution of the
25 number of credits for which the student is enrolled, which must
26 meet or exceed the minimum number of credits required for
27 eligibility and certification that the student is in good standing and
28 making satisfactory academic progress toward a recognized degree
29 or certificate, as determined by the Board of Regents pursuant to
30 subsection 8. The Millennium Scholarship must be administered by
31 the eligible institution as other similar scholarships are administered
32 and may be used only for the expenditures authorized pursuant to
33 subsection 6. If a student is enrolled in more than one eligible
34 institution, the Millennium Scholarship must be administered by the
35 eligible institution at which the student is enrolled in a program of
36 study leading to a recognized degree or certificate.

37 8. The Board of Regents shall establish:

38 (a) Criteria for determining whether a student is making
39 satisfactory academic progress toward a recognized degree or
40 certificate for purposes of subsection 7.

41 (b) Procedures to ensure that all money from a Millennium
42 Scholarship awarded to a student that is refunded in whole or in part
43 for any reason is refunded to the Trust Fund and not the student.



1 (c) Procedures and guidelines for the administration of a
2 Millennium Scholarship for students who are enrolled in more than
3 one eligible institution.

4 **Sec. 4.** 1. This section and sections 1 and 3 of this act
5 become effective on July 1, 2015.

6 2. Section 2 of this act becomes effective on July 1, 2016.
