AN ACT relating to occupational safety; revising provisions governing the expiration and renewal of certain completion cards obtained by construction workers and supervisory employees; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law requires each construction worker and supervisory employee to
2 obtain, within 15 days after the date he or she is hired, a completion card for taking
3 a course in construction industry safety and health hazard recognition which is: (1)
4 developed by the Occupational Safety and Health Administration of the United
5 States Department of Labor; and (2) approved by the Division of Industrial
6 Relations of the Department of Business and Industry. Each completion card
7 obtained by a construction worker or supervisory employee expires 5 years after the
8 date it is issued and may be renewed by: (1) completing another such course in
9 construction industry safety and health hazard recognition within the previous 5
10 years; or (2) completing certain requirements for continuing education within that
11 period. (NRS 618.983) This bill provides that a completion card obtained by a
12 construction worker does not expire or require renewal. This bill also provides that
13 each completion card obtained by a supervisory employee expires 10 years, rather
14 than 5 years, after the date it is issued and may be renewed by completing another
15 such course or completing those requirements for continuing education within the
16 previous 10 years.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 618.983 is hereby amended to read as follows:
2 618.983 1. Not later than 15 days after the date a construction
3 worker other than a supervisory employee is hired, the construction
4 worker must obtain a completion card for an OSHA-10 course
5 which is issued upon completion of a course approved by the
6 Division pursuant to NRS 618.977.
7 2. Not later than 15 days after the date a supervisory employee
8 is hired, the supervisory employee must obtain a completion card for
9 an OSHA-30 course which is issued upon completion of a course
10 approved by the Division pursuant to NRS 618.977.
11 3. Any completion card used to satisfy the requirements of
12 ~~this section~~ **subsection 2** expires ~~5~~ **10** years after the date it is
13 issued and may be renewed by:
14 (a) Completing an ~~OSHA-10 course or~~ OSHA-30 course ~~as~~
15 ~~applicable,~~ within the previous ~~5~~ **10** years; or
16 (b) Providing proof satisfactory to the Division that the
17 ~~construction worker~~ **supervisory employee** has completed
18 continuing education within the previous ~~5~~ **10** years consisting of
19 job-specific training that meets the guidelines established by the
20 Division pursuant to NRS 618.977 in an amount of ~~5~~
21 ~~— (1) For a completion card issued for an OSHA-10 course, not~~
22 ~~less than 5 hours; or~~
23 ~~— (2) For a completion card issued for an OSHA-30 course,~~
24 not less than 15 hours.
