AN ACT relating to courts; removing certain obsolete provisions relating to security services provided by the Capitol Police Division of the Department of Public Safety; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law authorizes the Supreme Court of Nevada to employ certain  
2 persons to provide for the security of the justices of the Supreme Court, judges of  
3 the Court of Appeals and employees of the Supreme Court and for the security of  
4 certain judicial facilities. (NRS 2.295, 333.710) This bill removes obsolete  
5 language relating to the assignment of personnel of the Capitol Police Division of  
6 the Department of Public Safety to provide security services to the Supreme Court.  
7 (NRS 331.140)

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 331.140 is hereby amended to read as follows:  
2 331.140 1. The Administrator shall take proper care to  
3 prevent any unlawful activity on or damage to any state property  
4 under the supervision and control of the Administrator, and to  
5 protect the safety of any persons on that property.



1        2. The Director of the Department of Public Safety shall  
2 appoint to the Capitol Police Division of that Department such  
3 personnel as may be necessary to assist the Administrator and the  
4 Buildings and Grounds Section in the enforcement of subsection 1.  
5 The salaries and expenses of the personnel appointed pursuant to  
6 this subsection must, within the limits of legislative authorization,  
7 be paid out of the Buildings and Grounds Operating Fund.

8        ~~[3. Personnel of the Capitol Police Division who are assigned  
9 to protect the safety of the justices of the Supreme Court and the  
10 judges of the Court of Appeals have the authority to provide any  
11 necessary security services, at the request of the Court  
12 Administrator, to the justices of the Supreme Court and the judges  
13 of the Court of Appeals while the justices or judges are performing  
14 work duties at any location in this State. No money may be  
15 expended from the Buildings and Grounds Operating Fund for such  
16 security services unless the money has been specifically  
17 appropriated for such a purpose.]~~

18        **Sec. 2.** This act becomes effective upon passage and approval.
