Comment: Law Enforcement is currently focusing on training officers in the intricacies of dealing with persons with mental illness, including but not limited to veterans returning from war. Training hours are limited and there are already a number of mandated topics which have to be balanced within the average officer's training hours for a year. This unfunded bill would have a significant fiscal impact on the Washoe County Sheriff's Office. There are approximately 422 sworn Deputies of all rank, which would require this additional training at an average cost of approximately \$300 per sworn member.

This amounts to approximately \$127,000 which does not include the overtime hours required to backfill for their position. This would be an additional \$420 per sworn member backfilled in order to attend the days training. Research within our Risk Management section revealed that in the past 5 years there are no cases of an officer using lethal force on a dog in performance of their duties. The training cost at \$300 for 422 officers would cost \$126,000.

Comment: The class to train officers in effective responses to incidents involving dogs is currently offered online at no cost to the County. However, if this would change and the class would become an in-person training instead of an online training, the anticipated initial training cost would be approximately \$38,000 to provide all of our current peace officers with the required training and an additional \$7,000 per year after that to accommodate training for positions as they turn over. In addition to the training costs, the County would have an increase in overtime and related benefits to cover shifts when officers are absent from their duty to attend training. The above numbers are estimates only as the actual costs are not known at this time.
