Comment: BDR 52-756 expands the type of personal information that must be protected from public disclosure. The Nevada Commission on Ethics collects various forms and documents from members of the public which may include personal information. Most documents collected by the Commission are deemed public records. The Commission must review all such records before disclosing them to the public. The Commission presently reviews all submitted documents for any personal information and redacts that information accordingly before disclosing such records to the public. However, the forms and information collected by the Commission rarely include information protected from disclosure under current law. This bill would broaden the scope of protected personal information, including names and addresses, which are regularly collected by the Commission in combination with phone numbers, email addresses and identification of public employers. The legislation indicates that the name and address of a person would be protected if it is submitted "in combination" with other information that would increase the likelihood of a person becoming a victim of identity theft." If this bill is passed, it will likely increase the information that must be redacted by the Commission before publicly disclosing the information, which could increase staff time to accommodate the redactions for nearly every document collected. However, the Commission could amend its forms to accommodate the legislation to ensure a minimal fiscal impact by reducing staff time that would otherwise be required to redact such information. Therefore, the agency has reviewed this legislation and determined that it will have negligible fiscal impact.
