There is no way to determine the impact of these forumula changes without including the new factors into the existing formula and applying them to each district. The only certainty is that changes of this magnitude will cause significant shifts in funds from school district to school district and may significantly and adversely affect several school districts while benefitting a few. Although the factors are somewhat different than the recent American Institutes for Reaseach (AIR) funding study, the implications and impacts may be similar (refer to attached). According to one scenario in this study, 15 of 17 counties realized a decrease in funding while 2 counties (Washoe and Clark) realized an increase. Approximately \$39.6 million would be shifted from rural counties to Washoe and Clark. In a hold harmless scenario, the State would not only increase the funding to school districts based on the new factors but would also have to hold school districts harmless. Further, the Executive Budget has already included categorical funding that would be duplicated within the formula. This sets the stage for inequitable funding levels. It would be best to design the formula and determine the impact before legislatively mandating the change. There is a risk and probability that adverse changes based on the existing funding levels will force Nevada's Funding Formula to litigation.
