Note 1: Personnel costs include a benefit load factor of 45% and a 5% increase in salary each fiscal year after FY2016. FY2016 salaries are 1/2 year due to January 1, 2016 effective date of legislation.

Note 2: If off-site data storage (Server/Data Storage) is chosen as the data storage solution, annual costs are \$142,272, resulting in a difference of +\$67,522 in FY 2016, and +\$142,272 in FY 2017, and +\$284,544 in Future Biennia.

Note 3: While ownership of equipment is preferred, an option to use leased equipment and off-site storage has an annual costs of \$288,192.
