This measure revises the provisions for early literacy screening assessments, including the results of the assessments in annual reporting. The measure also requires the Nevada Department of Education (NDE) to employ a full-time dyslexia specialist and publish a Dyslexia Resource Guide. Sections 2 and 17 allow the State Board of Education to adopt regulations necessary in order to carry out the provisions of this measure. The agency estimates the cost of regulation review to be \$1550. Section 3 requires the results of the early literacy screening assessment be included in the report of accountability prepared annually by the NDE; this is supported by an annual cost of \$2 per pupil for data collection and reporting. The NDE estimates 35,000 pupils per grade in each year for Kindergarten and grades 1 and 2. This combines to 105,000 pupils per year at \$2.00 per pupil, for a total of \$210,000 annually for this expense. Section 12 of this bill requires NDE to designate a full-time employee to serve as a dyslexia specialist; currently, the NDE does not have such a position. Because of the effective date for the measure, a new Educations Programs Professional position is requested with a start date of July 1, 2015. This position is request to start at a step 6 because of the requirements for the dyslexia specialist outlined in Section 12 subsection 2. Section 14 requires NDE to prepare and publish a Dyslexia Resource Guide to use to identify and provide dyslexia therapy for pupils with dyslexia. The agency estimates a cost of \$30,000 for the publication; this amount is based on the preparation and publication costs incurred for the Nevada Literacy Plan publication in FY 2015.
