It is likely that in order for the charter school to send notice as described, Douglas County School District would be required to provide the applicable addresses from our Student Information System (SIS). However, there is a distinct possibility that the district would a greater loss of enrolled students as a result of the charter school "advertising" letter requirement, which would have a direct financial impact as a result of lost per pupil state support. However, there is not sufficient information to determine or calculate the fiscal effects or to provide a meaningful or substantial submittal on behalf of the school district.
