This BDR Revises the duties of public agencies, primarily the Attorney General's (AG) Office concerning certain public roads (with an emphasis on those crossing public (e.g. BLM or USFS-administered) lands: This bill creates duties for the AG's office to litigate and to negotiate on behalf of rural counties to maintain and prevent closure of public roads as well as to assert ownership of such roads (and arguably to affect public access). It would revise provisions allowing petitions seeking certain actions from a board of county commissioners concerning public roads. Also it authorizes the AG to initiate actions to "vindicate" the rights of certain persons and revises provisions relating to the closure of temporary closure of State parks, monuments, historic landmarks or recreational areas. The Utah Attorney General's RS 2477 unit consists of 4 Assistant Attorney Generals plus various in-house agency counsel as well as a seasonal crew who drive the back roads of Utah assembling the public road inventory needed for Utah's program. Our contact in Utah said that conservatively the program costs Utah \$1,000,000 annually. The program contemplated by BDR 35-1089 resembles Utah's RS 2477 program and provides a template for the creation of a scaled-down version of a similar program in Nevada Even at a reduced level, there will be staffing requirements and associated costs for this office. At a minimum the AG office would request a Sr. DAG, a DAG, a Criminal Investigator II, a Legal Researcher and a Legal Secretary II. The decision unit that shows these expenditures is in BA 1030, title BDR 35-580 & BDR 35-1089.
