Comment: Approximately half of animals processed through the Henderson Animal Shelter are owner surrenders. Under current practice owner surrenders are only held for 24 hours before being evaluated for adoptions. This legislation would add requirements to hold owner surrender animals longer and increasing costs by \$385,000. The legislation would also increase the number of days that stray animals are held, increasing the costs for these animals by \$110,000.

Comment: The passage of this bill would have a significant fiscal impact to the City of Las Vegas. Currently, the City requires the Animal Foundation to hold impounded animals for 72 hours. This bill would require the Foundation to hold these animals an additional 48 hours, to include a Saturday. If the costs for the additional days were passed onto the City, it would cost approximately \$600,000 per year, based on the current cost per animal per day and the number of animals that are brought into the Foundation from our jurisdiction.

Comment: For the fiscal impact of this Bill of additional cost for 2 more sheltering days at current costs and a 3% COLA on the first of the Calendar year:

- FY15 \$324,400 is based upon an additional cost of three months remaining in FY15 calculated by (0.6667 *\$162158 current monthly cost * three months)
- FY16 \$1316600 based upon an additional cost of six months at the current rate, and six months with a 3% COLA increase on January 1, 2016 calculated by (0.6667 *\$162158 * 6 months) PLUS (0.6667*\$162158 * 6 months*1.03 COLA).
- FY17 \$1356000 based upon an additional cost of six months at the CY 2016 calculated rate, and six months with a 3% COLA increase on January 1, 2017 calculated by (0.6667 *\$167000 * 6 months) PLUS (0.6667*\$167000 * 6 months*1.03 COLA).

Comment: As written, the words "consecutive business days" within this bill would add 1 to 7 days to our Departments current 5 business day holding period of stray animals.

In current Washoe County code an animal is to be held five business days. When a dog is impounded on a Tuesday evening; the stray period begins the next day which would be the first business day; Monday is the last business day and the animal is then made available for transfer to the rescue groups on Tuesday morning.

As written the wording "consecutive business days" would imply in the above situation that Sunday would break the consecutive business day requirement and mandate the department to start the clock again causing the animal to be held through the required time frame as proposed.

The extended stray hold in the proposed amendment would force Regional Animal Services to double up animals in holding kennels which could cause injury and disease transmission. Additionally, the requirement to hold animals for "five consecutive business days" after the stray period for adoption" would place the same undue burden as in the example above on operations and the budget as we do not handle the adoptions of animals in Washoe County. Washoe County Regional Animal Services holds a Professional Services Agreement with the Nevada Humane Society who handles 85% of adoptions for adoptable animals with other authorized rescue groups transferring 8% of the remaining animals for adoption. This extended time period will have a significant impact to our shelter operations and budget.

We estimate the cost per day to hold a dog is approximately \$100 per day. Last year Washoe Animal Services had 11,000 stray animals come into the shelter if each of those animals stayed one extra day the impact could be significant. One extra day for 11,000 strays is \$1,100,000.
