City/County: <b>Churchill County</b> Approved by: Eleanor Lockwood, County Manager Comment: While Churchill County has concerns with making a civil infraction out of what is currently considered criminal, the overall fiscal impact may be positive to the County, as the jail would have to book fewer warrants. However, some of this savings may be offset by the County struggling to collect on fines that offenders can simply continue to receive citations for and fail to obey the courts by not paying their fines and never having to answer to a magistrate.

If 75% of those arrests had been cited instead, at an average length of stay of 2 days and an average daily bed rate of \$135, \$1,129,950 could have been saved.
