Comment: Concerns from the Washoe County Sheriff's Office:

• There would have to be a standardized ID format for all counties Lacking a standardized (recognizable) format, anything given would be indistinguishable from

an ID printed off the internet.
Creation of an official form that establishes a person's identity, without supporting documentation.

At minimum DMV requires the person to present one document for proof of identity

- § State-issued birth certificate (original or certified copy)
- § Valid, unexpired United States Passport or United States Passport Card
- § Nevada Department of Corrections identification card
- § Consular Report of Birth Abroad (FS-240)
- Driver's license, instruction permit, or identification card from another state

AND one document for proof of Social Security number

AND two documents to prove Nevada residential address.

None of that is needed to be arrested – all that required is reasonable cause to believe that the person in custody is the person that committed the offense.

The only person that have "confirmed" identity are those that have ID (and that isn't always accurate). The rest are booked as the name given at time of arrest (and agencies have booked, sentenced, and released "John/Jane Doe's")

• Is the state prepared for the impact?

Processing a WINs check is the only valid way to establish the identity, and even then:

- § It assumes they have an existing criminal record;
- § There was an accurate name when the history was initially created.

Comment: The unfunded mandate to provide photo identification to prisoners at the expiration of their term of imprisonment will result in adverse impact to the County in the form of higher expenses. The additional costs will include purchase of equipment to create IDs, tracking systems for IDs issued and salary/benefits for the additional staff time to provide the IDs and the "reasonable assistance" to acquire a driver's license. Future administrative regulations will provide the requirements to which the County must adhere which will be the largest driver of cost. For that reason an exact amount cannot be determined at this time, however, it will result in adverse impact to the County.
