#### INTRODUCTION, FIRST READING AND REFERENCE

Assembly Bill No. 120—AN ACT relating to education; clarifying the rights of pupils at public schools regarding the free exercise of religion; providing a grievance process for pupils claiming that their rights of free exercise of religion have been violated; and providing other matters properly relating thereto.

Assemblyman Wheeler moved that the bill be referred to the Committee on Education.

Assembly Bill No. 121—AN ACT relating to education; prohibiting a school from disciplining a pupil for simulating a firearm or dangerous weapon or wearing clothing or accessories that depict a firearm or dangerous weapon or express certain opinions except in certain circumstances; and providing other matters properly relating thereto.

Assemblyman Wheeler moved that the bill be referred to the Committee on Education.

Assembly Bill No. 122—AN ACT relating to days of observance; establishing "Nevada Modernist Architecture Day" as a day of observance; and providing other matters properly relating thereto.

Assembly Bill No. 124—AN ACT relating to juveniles; revising the minimum age at which a child may be adjudicated and punished as a delinquent child; and providing other matters properly relating thereto.

Assemblywoman Diaz moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By the Committee on Judiciary:

Assembly Bill No. 125—AN ACT relating to constructional defects; enacting provisions governing the indemnification of a controlling party by a subcontractor for certain constructional defects; enacting provisions governing wrap-up insurance policies or consolidated insurance programs covering certain claims for constructional defects; authorizing the parties to a claim for a constructional defect to agree to have a judgment entered before the filing of a civil action under certain circumstances; revising the definition of "constructional defect"; revising provisions governing the information required to be provided in a notice of constructional defect; removing provisions authorizing claimants to give notice of common constructional defects in residences or appurtenances; requiring a claimant to pursue a claim under a homeowner's warranty under certain circumstances; revising provisions governing the damages recovered by a claimant; revising the statutes of repose regarding actions for damages resulting from certain deficiencies in construction; revising provisions governing the tolling of statutes of limitation and repose regarding actions for constructional defects; prohibiting a homeowners' association from pursuing an action for a constructional defect unless the action pertains exclusively to the common elements of the association; and providing other matters properly relating thereto.

Assemblyman Nelson moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Assemblywoman Carlton:

Assembly Bill No. 126—AN ACT relating to massage therapy; exempting a nail technologist from the requirement to be licensed as a massage therapist when performing certain activities; revising certain testing requirements for applicants for a license to practice massage therapy; limiting the period during which an inactive or expired license may be restored or renewed; deleting certain grounds for refusal to issue a license or initiate disciplinary action against licensees; and providing other matters properly relating thereto.

Assemblywoman Carlton moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Assemblymen Hambrick and O'Neill; Senators Gustavson and Settelmeyer:

Assembly Bill No. 127—AN ACT relating to firearms; limiting the authority of certain political subdivisions of the State to enact or maintain laws, ordinances, rules or regulations relating to firearms and reserving such

authority to the Legislature; authorizing a person adversely affected by the enforcement of such a law, ordinance, rule or regulation to seek declarative and injunctive relief and damages; deleting certain provisions authorizing certain larger counties to enact ordinances relating to the registration of firearms capable of being concealed; revising the applicability of certain provisions pertaining to the regulation of firearms by certain political subdivisions; and providing other matters properly relating thereto.

Assemblyman Paul Anderson moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By the Committee on Judiciary:

Assembly Bill No. 128—AN ACT relating to powers of attorney; creating a power of attorney for health care decisions for adults with intellectual disabilities; and providing other matters properly relating thereto.

Assemblyman Nelson moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By the Committee on Judiciary:

Assembly Bill No. 129—AN ACT relating to judgments; increasing the percentage of a judgment debtor's disposable earnings which is exempt from execution under certain circumstances; authorizing a judgment debtor who is a resident of this State to bring a civil action in certain circumstances against a judgment creditor who obtains a writ of garnishment without domesticating a foreign judgment; extending the period for which a writ of garnishment served on an employer of a judgment debtor continues; and providing other matters properly relating thereto.

Assemblyman Nelson moved that the bill be referred to the Committee on Judiciary.

Motion carried.
