By Assemblymen Hambrick and Kirkpatrick; Senators Roberson and Ford: Assembly Concurrent Resolution No. 2—Providing for the voluntary transfer of a portion of Legislators' salaries to the State General Fund.

#### ASSEMBLYMAN PAUL ANDERSON:

In recognition of the 2.3 percent salary reduction taken by state employees this biennium as a result of the furlough requirements, A.C.R. 2 directs the accounting unit of the Legislative Counsel Bureau to withhold 2.3 percent of each Legislator's salary for this session. The total amount of this withholding will be credited to the state's General Fund, however, this is voluntary. The withholding will not be made from the salary of any member who did not vote in favor of passage of this resolution and who notifies the Director of the Legislative Counsel Bureau that the member does not wish to have the withholding made from his or her salary.

Resolution adopted and ordered transmitted to the Senate.

Assembly Bill No. 132—AN ACT relating to displaced homemakers; requiring a person who commences an action for the termination of a domestic partnership in a district court to pay a fee to the county clerk for use by the Director of the Department of Employment, Training and Rehabilitation to administer the provisions of law relating to the education and counseling of displaced homemakers; providing that the member of the Board for the Education and Counseling of Displaced Homemakers who is a displaced homemaker may be a current or former displaced homemaker; and providing other matters properly relating thereto.

Assemblyman Hansen moved that the bill be referred to the Committee on Judiciary.

Assembly Bill No. 133—AN ACT relating to contractors; prohibiting a licensee from knowingly employing an unauthorized alien; requiring the State

Contractors' Board to investigate and take certain action against a licensee who knowingly employs an unauthorized alien; and providing other matters properly relating thereto.

Assemblyman Hansen moved that the bill be referred to the Committee on Commerce and Labor.

Assembly Bill No. 134—AN ACT relating to the Nevada Commission for Women; revising the qualifications for appointment to the Commission; and providing other matters properly relating thereto.

Assembly Bill No. 135—AN ACT relating to public records; requiring the Division of State Library and Archives of the Department of Administration to develop and conduct a program of education and training concerning the retention and disposition of official state records for the employees of agencies, boards and commissions that are required to have a schedule approved by the Committee to Approve Schedules for the Retention and Disposition of Official State Records; requiring the head of such an agency, board or commission to require certain employees to complete the program; requiring the head of such an agency, board or commission to issue a letter of reprimand to an employee who disposes of an official state record in a manner contrary to an approved schedule for the retention and disposition of official state records; authorizing the head of an agency, board or commission to take additional appropriate disciplinary action against such an employee; and providing other matters properly relating thereto.
